# A GENERAL CLASS OF PHASE TRANSITION MODELS WITH WEIGHTED INTERFACE ENERGY 

E. ACERBI, G. BOUCHITTÉ


#### Abstract

We study a family of singular perturbation problems of the kind $$
\inf \left\{\frac{1}{\varepsilon} \int_{\Omega} f(u, \varepsilon \nabla u, \varepsilon \rho) d x: \int_{\Omega} u=m_{0}, \int_{\Omega} \rho=m_{1}\right\}
$$ where $u$ represents a fluid density and the nonnegative energy density $f$ vanishes only for $u=\alpha$ or $u=\beta$. The novelty of the model is the additional variable $\rho \geq 0$ which is also unknown and interplays with the gradient of $u$ in the formation of interfaces. Under mild assumptions on $f$, we characterize the limit energy as $\varepsilon \rightarrow 0$ and find for each $f$ a transition energy (well defined when $u \in B V(\Omega ;\{\alpha, \beta\})$ and $\rho$ is a measure) which depends on the $n-1$ dimensional density of the measure $\rho$ on the jump set of $u$. An explicit formula is also given.


## 1. Introduction and main results

Bubbles, foams and the role of surfactants have been the object of focused study in the last years; a surfactant is, roughly speaking, a substance which may be added to a mixture of two phases (gas/fluid, fluid/fluid, even metallic foams) to help with the formation of interfaces, by locally lowering surface tension.

Several Ginzburg-Landau-type models exist in the literature (see e.g. [3, 4, 5, [6, 8, ,9, 10, 12]), based on the study of the molecular interaction energies of the two phases and the surfactant. Due to the amphiphilic character of tensioactives, the energy should take into account the gradient of the orientation of surfactant molecules, but as this gives rise to highly complex numerical problems, in many instances (see [5, 8, 9, 10, 12]) only the average concentration of surfactant is considered, thus leading to a bulk energy of the form

\int f(u, \nabla u, \rho) d x
$$

where $u$ is the phase parameter (i.e. a scalar function which takes two different prescribed values, say $\alpha$ and $\beta$, in the two phases) and $\rho$ is the density of the surfactant.

As an example, a recent paper [5] by Fonseca, Morini and Slastikov uses a particular model by Perkins, Sekerka, Warren and Langer which is a modification of the standard van der Waals-Cahn-Hilliard model for fluid phase transition,
namely their energy is given by

\int_{\Omega} \frac{1}{\varepsilon} W(u)+\varepsilon|\nabla u|^{2}+\varepsilon(\rho-|\nabla u|)^{2} d x \tag{1.1}
\end{equation*}

where $W$ is a double-well potential and $\varepsilon$ is the scaling parameter that is commonly used to drive the system towards phase separation. Fonseca, Morini and Slastikov deduce from the model the limit energy at the interface between two phases.

In this paper we deal with a very general class of energy functionals, and under mild assumptions we derive the limit energy on the interface, depending on the bulk energy density $f$; to be more precise, let $\alpha<\beta$ be two real numbers and let $f: \mathbb{R} \times \mathbb{R}^{n} \times[0,+\infty[\rightarrow[0,+\infty[$ be a continuous function satisfying
(H1) $f(s, 0,0)=0 \Longleftrightarrow s \in\{\alpha, \beta\}$
(H2) for all $s \in \mathbb{R}, f(s, \cdot, \cdot)$ is convex

\text { for all } s \in \mathbb{R}, z \mapsto f(s, z, 0) \text { attains a strict minimum at } z=0 \\
\text { for all } s \in \mathbb{R}, \frac{\partial f}{\partial z}(s, 0,0)=0 \\
\text { if } s \in\{\alpha, \beta\}, \frac{\partial f}{\partial \gamma}(s, 0,0)=0
\end{array}\right.
$$

(H4) there exist $C, C^{\prime}>0$ such that $f(s, 0,0) \geq \frac{1}{C}|s|-C^{\prime}$.
If $\Omega$ is a bounded open set with Lipschitz boundary, the total energy we attach to the system reads

$$
F_{\varepsilon}(u, \rho)= \begin{cases}\frac{1}{\varepsilon} \int_{\Omega} f(u, \varepsilon \nabla u, \varepsilon \rho) d x & \text { if }(u, \rho) \in W^{1,1}(\Omega) \times L_{+}^{1}(\Omega)  \tag{1.2}\\ +\infty & \text { otherwise }\end{cases}
$$

Due to the scaling and to conditions (H1),(H2),(H3) we expect that if a sequence $\left(u_{\varepsilon}, \rho_{\varepsilon}\right)$ is uniformly bounded in energy (that is $\left.\sup _{\varepsilon} F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right)<+\infty\right)$, then up to a subsequence we will have $u_{\varepsilon} \rightharpoonup u$ and $\rho_{\varepsilon} \rightharpoonup \rho$ where $u(x) \in\{\alpha, \beta\}$ and $\rho \in \mathcal{M}_{+}(\bar{\Omega})$ is a non-negative Radon measure supported by $\bar{\Omega}$. We will show that in fact the convergence of $u_{\varepsilon}$ is strong in $L^{1}(\Omega)$ and the limit $u$ belongs to the space $B V(\Omega ;\{\alpha, \beta\})$ : thus $u$ is of the form $u=\alpha \mathbb{1}_{A}+\beta \mathbb{1}_{\Omega \backslash A}$ where $A$ is a set with finite perimeter. Then the total limit energy will be concentrated on the interface $\partial A$ (essential boundary of $A$ ). The physical interpretation of the above is that the two phases actually separate, and all the energy resides at the interface.

The interest now lies in describing this energy; for this task we introduce the conical envelope of $f$ defined by:

\end{equation*}

and then, for all $(z, \Theta) \in \mathbb{R}^{n} \times[0,+\infty[$, we set

$$
\begin{equation*}
\sigma(z, \Theta):=\inf \left\{\int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s: \gamma \in L^{1}\left(\alpha, \beta ; R_{+}\right), \int_{\alpha}^{\beta} \gamma(s) d s \leq \Theta\right\} \tag{1.4}
\end{equation*}
$$

The properties of $f_{c}$ and $\sigma$ are summarized in section 3, see Lemma 3.2 and Lemma 3.4. It turns out that the value $\sigma(z, \Theta)$ given in (1.4) is the reduced expression for the minimum of a one dimensional problem in which $u$ varies between $\alpha$ and $\beta$ and the density $\rho$ has a prescribed integral. The direction $z$ figures out the normal to the transition layer. As observed in many other scalar models (see the forefather [11] and many of the references in [5]) the transition profile will be unidimensional. If for a two-valued $B V$ function $\alpha \mathbb{1}_{A}+\beta \mathbb{1}_{\Omega \backslash A}$ we denote by $S_{u}$ the jump set of $u$, that is the reduced boundary of $A$ inside $\Omega$, and by $\nu_{u}$ the normal to $S_{u}$ pointing towards higher values of $u$, for any such function and for any non-negative Radon measure $\rho$ on $\bar{\Omega}$ we define

F(u, \rho):=\int_{S_{u}} \sigma\left(\nu_{u}(x), \rho^{0}(x)\right) d \mathcal{H}^{n-1} \tag{1.5}
\end{equation*}
$$

where

$$
\begin{equation*}
\rho^{0}(x)=\frac{d \rho}{d(J u)}(x), \quad J u:=\mathcal{H}^{n-1}\left\llcorner S_{u} .\right. \tag{1.6}
\end{equation*}
$$

We remark that according to the previous formulas the only portion of surfactant which plays a role in the total energy concentrates at the interface, that is it has a density with respect to the singular surface measure.

After some preliminary material in section 3, we will prove in section 4 the $\Gamma$-convergence of $F_{\varepsilon}$ to $F$ and as an immediate corollary we obtain the following result:

Theorem 1.1. Assume that $m_{1}>0$ and that $\alpha|\Omega|<m_{0}<\beta|\Omega|$. Let $\left(u_{\varepsilon}, \rho_{\varepsilon}\right)$ be an optimal pair (possibly up to a small error vanishing as $\varepsilon \rightarrow 0$ ) for the minimum problem

\inf \left\{\frac{1}{\varepsilon} \int_{\Omega} f(u, \varepsilon \nabla u, \varepsilon \rho) d x: \int_{\Omega} u=m_{0}, \int_{\Omega} \rho=m_{1}\right\}
$$

Then the sequence $\left(u_{\varepsilon}, \rho_{\varepsilon}\right)$ is relatively compact for the normed topology of $L^{1}(\Omega)$ times the weak convergence in $\mathcal{M}_{+}(\bar{\Omega})$, and any cluster point ( $\bar{u}, \bar{\rho}$ ) belongs to $B V(\Omega ;\{\alpha, \beta\}) \times \mathcal{M}_{+}(\bar{\Omega})$ and solves the problem
$\inf \left\{F(u, \rho):(u, \rho) \in B V(\Omega ;\{\alpha, \beta\}) \times \mathcal{M}_{+}(\bar{\Omega}), \int_{\Omega} u d x=m_{0}, \int_{\bar{\Omega}} \rho=m_{1}\right\}$.
To prove one of the inequalities involved in our main result (Theorem 4.1), we will introduce an integral representation formula for the relaxed functional of $\int_{\Omega} f_{c}(u, \nabla u, \rho) d x$ on $B V \times \mathcal{M}_{+}$. Instead, the other inequality requires lengthy technical approximation arguments to find and implement an optimal transition profile.

We remark that the definition (1.4) of $\sigma$ may seem too difficult to handle to be of any practical use, but in section 2 we provide an explicit formula which helps with computing the function $\sigma$ without solving the variational problem in 1.4, and we apply it to the study of some particular cases and a dicussion on the underlying physical models including the one proposed in [5]. Due to the interest
of these considerations for the applications, we placed this section right after the introduction, even though we will have to refer to some material covered later on.

To conclude this introduction, we emphasize that in this paper we give a mathematical foundation to a large class of surfactant-driven energies and that the approximation procedure we propose may be usefully applied for the numerical treatment of interface problems in the presence of a surfactant.

## 2. A representation formula, examples and comments

In this section we will analyse in deeper detail the properties of the integrand $\sigma(z, \Theta)$ which describes the interface energy arising from our model. As will be proved in Lemma 3.4, the function $\sigma(z, \Theta)$ given by (1.4) is convex, lower semicontinuous and 1-homogeneous on $\mathbb{R}^{n} \times \mathbb{R}^{+}$. Moreover $\sigma(z, \cdot)$ is monotone nonincreasing. In the following we extend the definition of $\sigma$ to all of $\mathbb{R}^{n+1}$ by setting

$$
\sigma(z, \Theta)=+\infty \quad \text { if } \Theta<0
$$

which obviously preserves the previous properties of $\sigma$.
Explicit computations are not an easy task. However we found a quite simple formula for the partial Legendre-Fenchel conjugate of $\sigma$ with respect to the variable $\Theta$, that is the function $\sigma^{*}\left(z, \Theta^{*}\right)$ given by

\sigma^{*}\left(z, \Theta^{*}\right)=\sup _{\Theta \in \mathbb{R}}\left[\Theta^{*} \Theta-\sigma(z, \Theta)\right]
$$

This formula will be helpful in order to study the differentiability of $\sigma(z, \cdot)$. Notice that, as a convex and l.s.c. function on the real line, $\sigma(z, \cdot)$ can be recovered from $\sigma^{*}(z, \cdot)$ through the biconjugate formula $\sigma(z, \Theta)=\sup \left\{\Theta \Theta^{*}-\sigma^{*}\left(z, \Theta^{*}\right): \Theta^{*} \in\right.$ $\mathbb{R}\}$. Analogously, we denote by $f_{c}^{*}(s, z, \cdot)$ the (partial) Legendre-Fenchel conjugate of $f_{c}(s, z, \cdot)$. We also denote by $\partial \sigma(z, \Theta)$ the partial subdifferential defined by

\partial \sigma(z, \Theta)=\left\{\Theta^{*}: \sigma(z, \Theta)+\sigma^{*}\left(z, \Theta^{*}\right)=\Theta \Theta^{*}\right\}
$$

Since $\sigma=+\infty$ for $\Theta<0$, we have that $\partial \sigma(z, 0)=]-\infty, \tau]$ where $\tau=\sigma^{\prime}\left(z, 0^{+}\right)$ is the slope at 0 of $\sigma(z, \cdot)$.

Lemma 2.1. For any $z \in \mathbb{R}^{n}$

\sigma^{*}\left(z, \Theta^{*}\right)= \begin{cases}\int_{\alpha}^{\beta} f_{c}^{*}\left(s, z, \Theta^{*}\right) d s & \text { if } \Theta^{*} \leq 0  \tag{2.1}\\ +\infty & \text { if } \Theta^{*}>0\end{cases}
$$

Proof. As $\sigma$ is bounded, see (3.14), we immediately infer that $\sigma^{*}\left(z, \Theta^{*}\right)=+\infty$ whenever $\Theta^{*}>0$. Thus from now on we concentrate on the case $\Theta^{*} \leq 0$. We get
from defintion (1.4)

$$
\begin{aligned}
\sigma^{*}\left(z, \Theta^{*}\right) & =\sup _{\Theta \geq 0}\left[\Theta^{*} \Theta-\sigma(z, \Theta)\right] \\
& =\sup _{\Theta \geq 0}\left[\Theta^{*} \Theta-\inf \left\{\int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s: \gamma \in L_{+}^{1}, \int_{\alpha}^{\beta} \gamma(s) d s \leq \Theta\right\}\right] \\
& =\sup _{\Theta \geq 0}\left[\sup _{\gamma \in L^{1}\left([\alpha, \beta] ; R_{+}\right), \int_{\alpha}^{\beta} \gamma(s) d s \leq \Theta}\left(\Theta^{*} \Theta-\int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s\right)\right] \\
& =\sup _{\gamma \in L^{1}\left([\alpha, \beta] ; R_{+}\right)}\left[\sup _{\Theta \geq \int_{\alpha}^{\beta} \gamma(s) d s}\left(\Theta^{*} \Theta-\int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s\right)\right] .
\end{aligned}
$$

Since $\Theta^{*} \leq 0$, it is never convenient to take $\Theta>\int_{\alpha}^{\beta} \gamma(s) d s$. Thus we obtain

\begin{aligned}
\sigma^{*}\left(z, \Theta^{*}\right) & =\sup _{\gamma \in L^{1}\left([\alpha, \beta] ; R_{+}\right)}\left[\Theta^{*} \int_{\alpha}^{\beta} \gamma(s) d s-\int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s\right] \\
& =\sup _{\gamma \in L^{1}\left([\alpha, \beta] ; R_{+}\right)} \int_{\alpha}^{\beta}\left[\Theta^{*} \gamma(s)-f_{c}(s, z, \gamma(s))\right] d s \\
& =\int_{\alpha}^{\beta} \sup _{\gamma(s) \geq 0}\left[\Theta^{*} \gamma(s)-f_{c}(s, z, \gamma(s))\right] d s \\
& =\int_{\alpha}^{\beta} f_{c}^{*}\left(s, z, \Theta^{*}\right) d s
\end{aligned}
$$

where in the third line we interchange "sup" and "integral" (see [2], Thm VII.7).

We remark that, despite the function $f_{c}^{*}$ may very well be finite also for some positive values of $\Theta^{*}$ (see Example 2.5), the domain of $\sigma(z, \cdot)$, and thus of $\partial \sigma(z, \cdot)$, lies in ] $-\infty, 0$ ]. As a consequence of Lemma 2.1 we have:

Lemma 2.2. Let $z \in \mathbb{R}^{n}, \Theta \geq 0$ and $\Theta^{*}<0$. Then $\Theta^{*} \in \partial \sigma(z, \Theta)$ if and only if there exists $\gamma \in L^{1}\left([\alpha, \beta] ; \mathbb{R}^{+}\right)$such that

$$
\begin{equation*}
\int_{\alpha}^{\beta} \gamma(s) d s \leq \Theta, \quad \Theta^{*} \in \partial f_{c}(s, z, \gamma(s)) \quad \text { for a.e. } s \in[\alpha, \beta] . \tag{2.2}
\end{equation*}
$$

In particular

$$
\left.\left.\partial \sigma(z, 0)=\bigcap_{s \in[\alpha, \beta]} \operatorname{argmin} f_{c}^{*}(s, z, \cdot)=\right]-\infty, \tau(z)\right],
$$

where $\tau(z)=\inf _{s \in[\alpha, \beta]} f_{c}^{\prime}\left(s, z, 0^{+}\right)$and $f_{c}^{\prime}\left(s, z, 0^{+}\right)$is the slope at 0 of $f_{c}(s, z, \cdot)$.
Notice that this lemma ensures the existence of an optimal $\gamma$ associated with $\Theta$ provided $\partial \sigma(z, \Theta)$ contains a negative element $\Theta^{*}$. The special case $\Theta^{*}=0$ is discussed later in Remark 2.4.

Proof. If $\gamma$ satisfies (2.2), then

$$
\begin{aligned}
\sigma(z, \Theta) \leq \int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s & =\int_{\alpha}^{\beta}\left[\Theta^{*} \gamma(s)-f_{c}^{*}\left(s, z, \Theta^{*}\right)\right] d s \\
& \leq \Theta \Theta^{*}-\sigma^{*}\left(z, \Theta^{*}\right)
\end{aligned}
$$

showing that $\Theta^{*} \in \partial \sigma(z, \Theta)$. Remark that this implication holds also if $\Theta^{*}=0$.
Conversely, assume that $\Theta^{*} \in \partial \sigma(z, \Theta)$ with $\Theta^{*}<0$; we begin with the case $\Theta>0$. As we will see in Lemma 3.5, for every $\varepsilon>0$ there exists $\gamma_{\varepsilon}(s)$ such that

$$
\int_{\alpha}^{\beta} f_{c}\left(s, z, \gamma_{\varepsilon}(s)\right) d s \leq \sigma(z, \Theta)+\varepsilon, \quad \int_{\alpha}^{\beta} \gamma_{\varepsilon}(s) d s=\Theta
$$

Set $h_{\varepsilon}(s):=f_{c}\left(s, z, \gamma_{\varepsilon}(s)\right)+f_{c}^{*}\left(s, z, \Theta^{*}\right)-\Theta^{*} \gamma_{\varepsilon}(s)$. Then by Lemma 2.1 the function $f_{c}^{*}\left(\cdot, z, \Theta^{*}\right)$ is integrable and

$$
\int_{\alpha}^{\beta} h_{\varepsilon}(s) d s \leq \varepsilon+\sigma(z, \Theta)+\sigma^{*}\left(z, \Theta^{*}\right)-\Theta \Theta^{*}=\varepsilon
$$

As in addition $h_{\varepsilon}$ and $f_{c}$ are nonnegative, we infer that $h_{\varepsilon} \rightarrow 0$ in $L^{1}([\alpha, \beta])$. Recalling that $\Theta^{*}<0$, we are led to

$$
0 \leq \gamma_{\varepsilon} \leq \frac{1}{-\Theta^{*}}\left[h_{\varepsilon}-f_{c}^{*}\left(\cdot, z, \Theta^{*}\right)\right]
$$

Thus the sequence $\gamma_{\varepsilon}$ is equi-integrable and therefore weakly relatively compact in $L^{1}([\alpha, \beta)]$. Let $\gamma$ be a weak cluster point. Then $\lim _{\varepsilon \rightarrow 0} \int_{\alpha}^{\beta} \gamma_{\varepsilon}(s) d s=\int_{\alpha}^{\beta} \gamma(s) d s$ and, since $f_{c}(s, z, \cdot)$ is convex continuous, we have by the classical weak lower semicontinuity property of convex integral functionals

$$
\liminf _{\varepsilon \rightarrow 0} \int_{\alpha}^{\beta} f_{c}\left(s, z, \gamma_{\varepsilon}(s)\right) d s \geq \int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s
$$

Therefore

$$
0=\lim _{\varepsilon \rightarrow 0} \int_{\alpha}^{\beta} h_{\varepsilon}(s) d s \geq \int_{\alpha}^{\beta}\left[f_{c}(s, z, \gamma(s))+f_{c}^{*}\left(s, z, \Theta^{*}\right)-\Theta^{*} \gamma(s)\right] d s \geq 0
$$

and we conclude that $\gamma(s)$ satisfies (2.2).
Now let $\Theta=0$ : in this case we obviously have $\gamma \equiv 0$ and condition (2.2) reduces to $\Theta^{*} \in \partial f_{c}(s, z, 0)$ for a.e. $s \in[\alpha, \beta]$. By Lemma 2.3, we have $\partial f_{c}(s, z, 0)=$ $\left.\left.\operatorname{argmin} f_{c}^{*}(s, z, \cdot)=\right]-\infty, \tau(s)\right]$ where

$$
\tau(s):=f_{c}^{\prime}\left(s, z, 0^{+}\right)=\inf _{t>0} \frac{f_{c}(s, z, t)}{t}
$$

The continuity of $f_{c}$, proved in Lemma 3.2, implies that $\tau(s)$ is upper semicontinuous. Thus the condition on $\Theta^{*}$ satisfied a.e. reduces to $\Theta^{*} \leq \tau$ where $\tau=\inf \{\tau(s): s \in[\alpha, \beta]\}$.

Lemma 2.3. Let $g$ be a convex lower semicontinuous function on $\mathbb{R}$ such that $g(x)=+\infty$ for $x<0$; the following three conditions are then equivalent:
(i) : $g(x) \geq g(0)+\tau x \forall x \geq 0$, (ii) $: g^{*}(\tau)=-g(0)$, (iii) $: g^{*}\left(x^{*}\right)=g^{*}(\tau) \forall x^{*} \leq \tau$.

Therefore $\left.\left.\partial g(0)=\operatorname{argmin} g^{*}=\right]-\infty, g^{\prime}\left(0^{+}\right)\right]$.
Proof. Since (i) may be rewritten $\tau x-g(x) \leq-g(0)$ it is clearly equivalent to (ii). Now we observe that $g^{*}\left(x^{*}\right)=\sup _{x>0}\left[x^{*} x-g(x)\right]$ is monotone non decreasing as a function of $x^{*}$. Therefore condition (iii) is equivalent to $g^{*}(\tau)=\min g^{*}$. Since $g$ is convex l.s.c. we have $\inf g^{*}=-g^{* *}(0)=-g(0)$ and the last condition reduces to (ii).

Remark 2.4. In view of Lemma 2.3, one has $0 \in \partial \sigma(z, \bar{\Theta})$ if and only if $\sigma(z, \cdot)$ reaches its minimum at $\bar{\Theta}$ and remains constant on $[\bar{\Theta},+\infty[$. This means that $\bar{\Theta}$ is a saturation constant beyond which any further addition of surfactant has no effect on the surface tension. If there exists an integrable selection $\gamma(s)$ of the minimum set of $f_{c}(s, z, \cdot)$, then this selection satisfies (2.2) with $\Theta^{*}=0$, and as already mentioned in the proof of Lemma 2.2 this implies that $0 \in \partial \sigma(z, \Theta)$ where $\Theta=\int_{\alpha}^{\beta} \gamma(s) d s$. Therefore we obtain:

$$
\bar{\Theta}=\inf \left\{\int_{\alpha}^{\beta} \gamma(s) d s: f_{c}(s, z, \gamma(s))=\min f_{c}(s, z, \cdot)=-f_{c}^{*}(s, z, 0) \text { a.e. }\right\}
$$

Notice also that such a finite $\bar{\Theta}$ exists if and only if the slope at 0 of $\sigma^{*}(z, \cdot)$ is finite, which, in view of 2.1 , is equivalent to the condition $\int_{\alpha}^{\beta}\left(f_{c}^{*}\right)^{\prime}\left(s, z, 0^{+}\right) d s<+\infty$.

In the ensuing examples we will endeavour to describe the behaviour of the surface energy $\sigma$, by pushing its computation as far as possible. In addition to Lemma $\sqrt[2.3]{ }$ we will use the fact that, for any function $f$ and constants $C, K \neq 0$, there holds

$$
\begin{equation*}
g(x)=C f(x / K) \quad \Rightarrow \quad g^{*}\left(x^{*}\right)=C f^{*}\left(K x^{*} / C\right) . \tag{2.3}
\end{equation*}
$$

For a wide class of energies, including those considered in examples 2.5 and 2.6 below, the specific form of the energy density $f$ allows for easy computation of $f_{c}$. Indeed assume

$$
f(s, z, \gamma)=W(s)+g^{2}(s, z, \gamma)
$$

with $W \geq 0$ and with $g \geq 0$ positively homogeneous of degree 1 with respect to the pair $(z, \gamma)$, so that $g^{2}$ is positively homogeneous of degree 2 : then one directly obtains

$$
f_{c}(s, z, \gamma)=2 \sqrt{W(s)} g(s, z, \gamma)
$$

In view of 2.1), we need to compute $f_{c}^{*}$ : this is simpler when, in addition, $f$ depends on $z$ only through $|z|$. Then writing

$$
g(s, z, \gamma)=\underset{7}{|z|} \underset{7}{ }(s, \gamma /|z|)
$$

(with $\psi(s, t)=+\infty$ for $t<0$ ), and leaving to the reader the easy changes for the cases $z=0$ or $W(s)=0$, one has by (2.3)

$$
\begin{aligned}
f_{c}^{*}\left(s, z, \Theta^{*}\right) & =\sup _{\gamma>0}\left[\Theta^{*} \gamma-2 \sqrt{W(s)}|z| \psi(s, \gamma /|z|)\right] \\
& =|z| \sup _{t>0}\left[\Theta^{*} t-2 \sqrt{W(s)} \psi(s, t)\right] \\
& =2 \sqrt{W(s)}|z| \psi^{*}\left(s, \frac{\Theta^{*}}{2 \sqrt{W(s)}}\right)
\end{aligned}
$$

Eventually one has only to compute the conjugate of the function (of one real variable) $\psi(s, \cdot)$.
Example 2.5. The functional (1.1) may now be dealt with quite easily: indeed we apply to the function $f(s, z, \gamma)=W(s)+|z|^{2}+(|z|-\gamma)^{2}$ the considerations above to get

$$
f_{c}(s, z, \gamma)=2 \sqrt{W(s)}|z| \psi(\gamma /|z|)
$$

with $\psi(t)=\sqrt{1+(1-t)^{2}}$ for $t>0$. Since in 1.5 we only use $|z|=1$, with a little abuse of notation we have

$$
f_{c}(s, 1, \gamma)=2 \sqrt{W(s)} \sqrt{1+(1-\gamma)^{2}}
$$

it is straightforward to get

$$
\psi^{*}\left(t^{*}\right)= \begin{cases}+\infty & \text { if } t^{*}>1 \\ t^{*}-\sqrt{1-\left(t^{*}\right)^{2}} & \text { if }-\frac{1}{\sqrt{2}} \leq t^{*} \leq 1 \\ -\sqrt{2} & \text { if } t^{*} \leq-\frac{1}{\sqrt{2}}\end{cases}
$$

(we remark that this function is finite also for some positive values of its argument), so that by (2.3)

$$
f_{c}^{*}\left(s, 1, \Theta^{*}\right)= \begin{cases}\Theta^{*}-\sqrt{4 W(s)-\left(\Theta^{*}\right)^{2}} & \text { if }-\sqrt{2} \sqrt{W(s)} \leq \Theta^{*} \leq 0 \\ -2 \sqrt{2} \sqrt{W(s)} & \text { if } \Theta^{*} \leq-\sqrt{2} \sqrt{W(s)}\end{cases}
$$

Although going further would require to know $W$ in explicit form, we can draw some physically interesting features of the limit interface $\sigma(z, \Theta)(=|z| \sigma(1, \Theta))$.
(1) By 2.1 the function $\sigma^{*}(1, \cdot)$ is constant exactly on $\left.]-\infty,-\sqrt{2 \max W}\right]$; by Lemma 2.2 or Lemma 2.3 this implies that the slope at $\Theta=0$ of $\sigma(1, \Theta)$ is $-\sqrt{2} \max W$ : the value of this constant accounts the influence of small additions of surfactant to a surfactant-free mixture. In particular, we have for small $\Theta$

$$
\sigma(1, \Theta) \approx \sigma(1,0)-\sqrt{2 \max W} \Theta
$$

where

$$
\sigma(1,0)=\int_{\alpha}^{\beta} f_{c}(s, 1,0) d s=2 \int_{\alpha}^{\beta} \sqrt{W(s)} d s
$$

(2) Employing the prime to denote differentiation with respect to $\Theta^{*}$, since $\left(f_{c}^{*}\right)^{\prime}\left(s, 1,0^{-}\right) \equiv 1$, by 2.1) we have $\left(\sigma^{*}\right)^{\prime}\left(1,0^{-}\right)=\beta-\alpha$, which by Lemma 2.3 implies that $\sigma(1, \Theta)$ is constant for $\Theta \geq \beta-\alpha$ : this shows that this model exhibits saturation, that is, if the amount of surfactant is larger than $\beta-\alpha$ the exceeding part has no influence on the interface energy. One may easily see that in this case if $\Theta=\beta-\alpha$ the minimizing density given by Lemma 2.2 is the constant 1 , whereas if $\Theta>\beta-\alpha$ the minimizing sequence concentrates the exceeding mass around points where $W(s)=0$, that is at $s=\alpha$ or $s=\beta$. Physically this means that the extra surfactant concentrates inside the pure phases.

Example 2.6. We may modify the example 2.5 above to obtain an uneven distribution of surfactant across the interface, or to obtain cases where saturation is neither achieved: fix a positive function $\bar{\gamma}(s)$ and define

$$
\psi(s, t)=\sqrt{1+(1-t / \bar{\gamma}(s))^{2}}
$$

so that the minimum point of $\psi$ is now at $t=\bar{\gamma}(s)$ instead of $t \equiv 1$. Leaving out the computations, one may check that there is saturation if and only if $\bar{\gamma} \in L^{1}$, because

$$
\left(\sigma^{*}\right)^{\prime}\left(1,0^{-}\right)=\int_{\alpha}^{\beta} \bar{\gamma}(s) d s=: \Theta_{0}
$$

the value at which (if finite) the surfactant reaches saturation by Lemma 2.3 .
Example 2.7. Another interesting energy is given by

$$
f(s, z, \gamma)=W(s)+\frac{|z|^{p}}{(\delta+\gamma)^{p-1}}
$$

where $\delta>0$ and $p>1$. Setting

$$
\mu_{\delta}(s)=\left(\frac{(p-1) \delta}{W(s)}\right)^{1 / p}
$$

one has

$$
f_{c}(s, z, \gamma)= \begin{cases}\frac{p|z|}{\mu_{\delta}^{p-1}}-\frac{p-1}{\mu_{\delta}^{p}} \gamma & \text { if } 0 \leq \gamma \leq \mu_{\delta}(s)|z| \\ \frac{|z|^{p}}{\gamma^{p-1}} & \text { if } \gamma \geq \mu_{\delta}(s)|z|\end{cases}
$$

The left part of the graph of $f_{c}$ with respect to $\gamma$ is the tangent line drawn from $\left(0, f_{c}(s, z, 0)\right)$ to the graph of $|z|^{p} / \gamma^{p-1}$; here again some comments may be made.
(1) There is no saturation: this seems clear since $f_{c}$ is decreasing. It can be proved by computing $f_{c}^{*}$; indeed for all $s \neq \alpha, \beta$ one has for a suitable $t(s)>0$ and for all $\left.\Theta^{*} \in\right]-t(s), 0[$ :

$$
f_{c}^{*}\left(s, 1, \Theta^{*}\right)=-p(p-1)^{(1-p) / p}\left(-\Theta^{*}\right)^{(p-1) / p}
$$

In particular $\left(f_{c}^{*}\right)^{\prime}(s, 1,0) \equiv+\infty$, which implies $\left(\sigma^{*}\right)^{\prime}(1,0)=+\infty$.
(2) For $\Theta^{*} \leq \Theta_{0}^{*}:=-\frac{\max W(s)}{\delta}$, one has

$$
f_{c}^{*}\left(s, 1, \Theta^{*}\right)=-\frac{p}{\left(\mu_{\delta}(s)\right)^{p-1}}
$$

so that $\sigma^{*}(1, \cdot)$ is constant on $\left.]-\infty, \Theta_{0}^{*}\right]$. From Lemma 2.3 we deduce the approximate behaviour of the surface energy for small amounts of surfactant:

$$
\sigma(1, \Theta) \approx \sigma(1,0)+\Theta_{0}^{*} \Theta
$$

where

$$
\sigma(1,0)=\frac{p}{((p-1) \delta)^{(p-1) / p}} \int_{\alpha}^{\beta} W^{(p-1) / p}(s) d s
$$

(3) Pushing $\delta$ to zero leads to the following explicit expression for the limit surface tension coefficient

$$
\sigma(1, \Theta)=\frac{(\beta-\alpha)^{p}}{\Theta^{p-1}}
$$

This can be easily checked by plugging $f_{c}(s, z, \gamma)=|z|^{p} / \gamma^{p-1}$ in (1.4) and by choosing a constant profile $\gamma(s)$. In the underlying physical model, the phase transition may thus only occur at those interfaces on which the surfactant has a positive density.

## 3. Preliminary results

The first part of this section is devoted to a precise study of the properties of the conical envelope $f_{c}$ introduced in (1.3) and of the interface energy density $\sigma$ introduced in (1.4) in relation with a one dimensional variational problem. In the second part of the section, we recall some useful features of convex functionals on measures. Then in the last part, we establish some approximation properties for the limit functional introduced in (1.5).

### 3.1. Interfacial integrands.

Lemma 3.1. Under assumptions (H1),(H2),(H3)

$$
\begin{gather*}
f_{c}(s, z, 0)=0 \text { for some } z \neq 0 \Longleftrightarrow s \in\{\alpha, \beta\}  \tag{3.1}\\
f_{c}(\alpha, z, 0)=f_{c}(\beta, z, 0)=0  \tag{3.2}\\
f_{c}(\alpha, 0, \gamma)=f_{c}(\beta, 0, \gamma)=0 \tag{3.3}
\end{gather*}
$$

Proof. Assume that $f_{c}(s, z, 0)=0$ for some $z \neq 0$ and $s \notin\{\alpha, \beta\}$ : this means that for a suitable sequence $\lambda_{n}$ of positive numbers

$$
\begin{equation*}
\frac{1}{\lambda_{n}} f\left(s, \lambda_{n} z, 0\right) \rightarrow 0 \tag{3.4}
\end{equation*}
$$

by the minimum property $(\mathrm{H} 3)_{2}$ we have

$$
\frac{1}{\lambda_{n}} f\left(s, \lambda_{n} z, 0\right) \geq \frac{f(s, 0,0)}{\lambda_{n}}
$$

and if $\lambda_{n} \nrightarrow+\infty$ we deduce as $n \rightarrow+\infty$

$$
f(s, 0,0)=0
$$

which implies by (H1) that $s \in\{\alpha, \beta\}$. If otherwise $\lambda_{n} \rightarrow+\infty$, by the convexity of $f$ we have as soon as $\lambda_{n} \geq 1$

$$
f\left(s, \lambda_{n} z, 0\right) \geq f(s, 0,0)+\lambda_{n}(f(s, z, 0)-f(s, 0,0))
$$

thus in particular

$$
\frac{1}{\lambda_{n}} f\left(s, \lambda_{n} z, 0\right) \geq f(s, z, 0)-f(s, 0,0)
$$

which by (3.4) would give $f(s, z, 0) \leq f(s, 0,0)$, thus contradicting the strict minimality in $(\mathrm{H} 3)_{2}$ because $f$ is convex and $z \neq 0$, which proves (3.1).

Confining ourselves to $s=\alpha$, by (H1) we may write

$$
\frac{f(\alpha, \lambda z, 0)}{\lambda}=\frac{f(\alpha, \lambda z, 0)-f(\alpha, 0,0)}{\lambda} \rightarrow z \frac{\partial f}{\partial z}(\alpha, 0,0)=0
$$

by $(\mathrm{H} 3)_{3}$, thus $f_{c}(\alpha, 0,0) \leq 0$ by (1.3), and also (3.2) is proved.
The proof of (3.3) is the same (switch $z$ and $\gamma$ ), just remark that we did not use the strict minimality given by $(\mathrm{H} 3)_{3}$ but simply minimality - which in the case of $(s, 0, \cdot)$ is provided by $(\mathrm{H} 3)_{1}$ - and we need to compute the partial derivative only at $s=\alpha$, which is allowed by $(\mathrm{H} 3)_{4}$.

In addition to the function $f_{c}$ defined in 1.3 we will use the function defined for all $M \geq 1$ as

$$
\begin{equation*}
f_{c}^{M}(s, z, \gamma)=\inf _{M^{-1} \leq \lambda \leq M} \frac{1}{\lambda} f(s, \lambda z, \lambda \gamma) \tag{3.5}
\end{equation*}
$$

Moreover it is useful to introduce an auxiliary lower-bound function: we set

$$
\begin{equation*}
k(s)=\inf \left\{\gamma+f_{c}(s, z, \gamma): \gamma \geq 0,|z|^{2}+\gamma^{2}=1\right\} \tag{3.6}
\end{equation*}
$$

We then have:
Lemma 3.2. Under the assumptions (H1),(H2),(H3) the function $f_{c}(s, z, \gamma)$ is continuous; for every s it is convex, 1-homogeneous and subadditive with respect to $(z, \gamma)$ and

$$
\begin{equation*}
f_{c}(\alpha, \cdot, \cdot)=f_{c}(\beta, \cdot, \cdot)=0 \tag{3.7}
\end{equation*}
$$

In particular there exists

$$
K=\max \left\{f_{c}(s, z, \gamma): s \in[\alpha, \beta], \gamma \geq 0,|z|+\gamma=1\right\}
$$

and

$$
\begin{equation*}
f_{c}(s, z, \gamma) \leq K(|z|+\gamma) \quad \forall s \in[\alpha, \beta], \gamma \geq 0, z \in \mathbb{R}^{n} \tag{3.8}
\end{equation*}
$$

The function $f_{c}^{M}$ is also continuous, and

$$
\begin{equation*}
f_{c}^{M} \searrow f_{c} \quad \text { as } M \rightarrow+\infty ; \tag{3.9}
\end{equation*}
$$

in particular it satisfies the inequalities

$$
\begin{equation*}
f_{c}(s, z, \gamma) \leq f_{c}^{M}(s, z, \gamma) \leq f_{c}^{1}(s, z, \gamma)=f(s, z, \gamma) \tag{3.10}
\end{equation*}
$$

Finally the function $k(s)$ is continuous and

$$
\begin{equation*}
k(s)>0 \quad \text { if } s \notin\{\alpha, \beta\} . \tag{3.11}
\end{equation*}
$$

Proof. Some of the properties of $f_{c}$ might be deduced from [1], proof of Lemma 3.1 in the appendix, but since our assumptions on $(z, \gamma)$ are a little less restrictive we prefer to carry on the adapted proofs here.

To prove that $f_{c}$ is convex, fix $s$, take two couples $\left(z_{1}, \gamma_{1}\right)$ and $\left(z_{2}, \gamma_{2}\right)$ and choose a number $\vartheta \in] 0,1\left[\right.$; now take any two positive numbers $\lambda_{1}, \lambda_{2}$, and for the sake of convenience set

$$
\frac{1}{K}=\frac{\vartheta}{\lambda_{1}}+\frac{1-\vartheta}{\lambda_{2}} .
$$

We have

$$
\begin{aligned}
& \frac{\vartheta}{\lambda_{1}} f\left(s, \lambda_{1} z_{1}, \lambda_{1} \gamma_{1}\right)+\frac{1-\vartheta}{\lambda_{2}} f\left(s, \lambda_{2} z_{2}, \lambda_{2} \gamma_{2}\right) \\
& \quad=\frac{1}{K}\left[\frac{\frac{\vartheta}{\lambda_{1}}}{\frac{\vartheta}{\lambda_{1}}+\frac{1-\vartheta}{\lambda_{2}}} f\left(s, \lambda_{1} z_{1}, \lambda_{1} \gamma_{1}\right)+\frac{\frac{1-\vartheta}{\lambda_{2}}}{\frac{\vartheta}{\lambda_{1}}+\frac{1-\vartheta}{\lambda_{2}}} f\left(s, \lambda_{2} z_{2}, \lambda_{2} \gamma_{2}\right)\right] \\
& \quad \geq \frac{1}{K} f\left(s, K\left(\vartheta z_{1}+(1-\vartheta) z_{2}\right), K\left(\vartheta \gamma_{1}+(1-\vartheta) \gamma_{2}\right)\right) \\
& \quad \geq f_{c}\left(s, \vartheta z_{1}+(1-\vartheta) z_{2}, \vartheta \gamma_{1}+(1-\vartheta) \gamma_{2}\right)
\end{aligned}
$$

where we used the convexity of $f$ in the second-last inequality. Taking the infimum with respect to $\lambda_{1}, \lambda_{2}$ gives the convexity inequality.

The fact that $f_{c}$ is 1 -homogeneous is obvious from the definition; since $f_{c}$ is convex and 1-homogeneous it is also subadditive. Convexity and (3.2), (3.3) together with the fact that $f \geq 0$ imply (3.7).

To prove continuity we remark that as $f_{c}$ is the infimum of a family of continuous functions, it is upper semicontinuous, and we have only to prove that it is also lower semicontinuous. Assume

$$
s_{n} \rightarrow s, \quad z_{n} \rightarrow z, \quad \gamma_{n} \rightarrow \gamma
$$

and set

$$
\ell=\liminf _{n \rightarrow+\infty} f_{c}\left(s_{n}, z_{n}, \gamma_{n}\right)
$$

Upon passing to a subsequence it is not restrictive to assume that indeed

$$
\ell=\lim _{n \rightarrow+\infty} f_{c}\left(s_{n}, z_{n}, \gamma_{n}\right)
$$

and we have to prove that $f_{c}(s, z, \gamma) \leq \ell$, which of course we must do only if $\ell<+\infty$. For every $n$, by (1.3) we may select $\lambda_{n}$ such that

$$
\left|f_{c}\left(s_{n}, z_{n}, \gamma_{n}\right)-\frac{1}{\lambda_{n}} f\left(s_{n}, \lambda_{n} z_{n}, \lambda_{n} \gamma_{n}\right)\right|<\frac{1}{n}
$$

thus

$$
\frac{1}{\lambda_{n}} f\left(s_{n}, \lambda_{n} z_{n}, \lambda_{n} \gamma_{n}\right) \rightarrow \ell
$$

It is not restrictive to assume also $\lambda_{n} \rightarrow \lambda \in[0,+\infty]$; now we have three cases depending on the limit $\lambda$.
Case $\lambda=0$. We remark that by (H3) ${ }_{1}$

$$
\frac{1}{\lambda_{n}} f\left(s_{n}, 0,0\right) \leq \frac{1}{\lambda_{n}} f\left(s_{n}, \lambda_{n} z_{n}, \lambda_{n} \gamma_{n}\right) \rightarrow \ell<+\infty
$$

thus $f\left(s_{n}, 0,0\right) \rightarrow 0$, but the continuity of $f$ implies $f(s, 0,0)=0$, which in turn by (H1) implies that $s \in\{\alpha, \beta\}$. But then (3.7) clearly implies $0=f_{c}(s, z, \gamma) \leq \ell$. Case $0<\lambda<+\infty$. This is the easiest, because by the continuity of $f$ and (1.3) we get

$$
f_{c}(s, z, \gamma) \leq \frac{1}{\lambda} f(s, \lambda z, \lambda \gamma)=\lim _{n \rightarrow+\infty} \frac{1}{\lambda_{n}} f\left(s_{n}, \lambda_{n} z_{n}, \lambda_{n} \gamma_{n}\right)=\ell .
$$

Case $\lambda=+\infty$. Fix $\mu>0$ : by the convexity of $f$ we have as soon as $\lambda_{n} \geq \mu$

$$
\frac{1}{\mu}\left(f\left(s_{n}, \mu z_{n}, \mu \gamma_{n}\right)-f\left(s_{n}, 0,0\right)\right) \leq \frac{1}{\lambda_{n}}\left(f\left(s_{n}, \lambda_{n} z_{n}, \lambda_{n} \gamma_{n}\right)-f\left(s_{n}, 0,0\right)\right)
$$

letting $n \rightarrow+\infty$ by the continuity of $f$ we get

$$
\frac{1}{\mu} f(s, \mu z, \mu \gamma) \leq \frac{1}{\mu} f(s, 0,0)+\ell
$$

and the result follows by 1.3 . The remaining statements about $f_{c}$ follow immediately from continuity and homogeneity.

The proof of the continuity of $f_{c}^{M}$ is the same, and there is no need of the last case; as for (3.9), (3.10) we remark that definitions (1.3) and (3.5) immediately imply that the family of functions $M \mapsto f_{c}^{M}$ decreases pointwise to $f_{c}$ as $M \rightarrow \infty$.

We now turn to $k$ : as $f_{c}$ is continuous, the function $(s, z, \gamma) \mapsto \gamma+f_{c}(s, z, \gamma)$ is uniformly continuous on every set

$$
\left[s_{1}, s_{2}\right] \times(z, \gamma): \gamma \geq 0,|z|^{2}+\gamma^{2}=1
$$

which implies continuity with respect to $s$ of its minimum value with respect to the other two variables, which is $k$ by (3.6).

To prove that $k(s)$ is positive if $s \notin\{\alpha, \beta\}$, assume that for some $s$ we have $k(s)=0$ : by the continuity of $f_{c}$ there exist $(z, \gamma)$ such that

$$
\begin{equation*}
\gamma \geq 0, \quad|z|^{2}+\gamma^{2}=1, \quad \gamma+f_{c}(s, z, \gamma)=0 \tag{3.12}
\end{equation*}
$$

Since $f_{c} \geq 0$, we have immediately $\gamma=0$, thus (3.12) reads $f_{c}(s, z, 0)=0$ for some $z \neq 0$, and (3.1) ends the proof.

For the sake of completeness we recall a selection lemma, see [2] Theorem 3.6 or [7] Theorem 3.1, stated here in the special case we will need:

Lemma 3.3. Let $\Lambda$ be a measurable multifunction defined on $[0, R]$ and whose values are nonempty closed subsets of $\mathbb{R}$; if for every $c \geq 0$ the set $\{t: \Lambda(t) \cap$ $[c,+\infty[\neq \emptyset\}$ is measurable, there exists a measurable function $\lambda:[0, R] \rightarrow \mathbb{R}$ such that $\lambda(t) \in \Lambda(t)$.

We now come to a relevant variational interpretation of the function $\sigma$ introduced in (1.4): define for all $R>0$

$$
\begin{align*}
& \sigma_{R}(z, \Theta)=\inf \{ \int_{0}^{R} f\left(w(t), z w^{\prime}(t), \rho(t)\right) d t: w(0)=\alpha, w(R)=\beta  \tag{3.13}\\
&\left.w \in \operatorname{Lip}(0, R), w^{\prime}(t)>0 \text { when } w(t)<\beta, \int_{0}^{R} \rho(t) d t \leq \Theta\right\}
\end{align*}
$$

(here and elsewhere, measurability is understood whenever an integral appears); then:

Lemma 3.4. For every $(z, \Theta)$ we have $\sigma_{R}(z, \Theta) \searrow \sigma(z, \Theta)$ when $R \rightarrow+\infty$. Moreover the function $\sigma$ is convex, continuous, 1-homogeneous, subadditive, and it is nonincreasing with respect to $\Theta$. Accordingly, there is a constant $C>0$ such that

$$
\begin{equation*}
\sigma(z, \Theta) \leq \sigma(z, 0) \leq C \quad \text { on }\{|z|=1\} \tag{3.14}
\end{equation*}
$$

Proof. The fact that $R \mapsto \sigma_{R}$ is decreasing is obvious. To prove that $\sigma_{R} \geq \sigma$, take any couple ( $w, \rho$ ) as in (3.13); we first clean away the part where $w=\beta$. Assume

$$
\{w<\beta\}=\left[0, R_{0}[\right.
$$

then $w:\left[0, R_{0}\right] \rightarrow[\alpha, \beta]$ is invertible and since $f \geq 0$ we have

$$
\begin{align*}
\int_{0}^{R} f\left(w(t), z w^{\prime}(t), \rho(t)\right) d t & \geq \int_{0}^{R_{0}} f\left(w(t), z w^{\prime}(t), \rho(t)\right) d t \\
& =\int_{0}^{R_{0}} \frac{1}{w^{\prime}(t)} f\left(w(t), z w^{\prime}(t), \frac{\rho(t)}{w^{\prime}(t)} w^{\prime}(t)\right) w^{\prime}(t) d t \\
& \geq \int_{0}^{R_{0}} f_{c}\left(w(t), z, \frac{\rho(t)}{w^{\prime}(t)}\right) w^{\prime}(t) d t \tag{3.15}
\end{align*}
$$

where we used (1.3). We change to the variable $s=w(t) \in[\alpha, \beta]$, so $t=w^{-1}(s)$, and we define an important new function (the density $\rho$ reparametrized by the value of $w$ ) by

$$
\gamma(s)=\frac{\rho\left(w^{-1}(s)\right)}{w^{\prime}\left(w^{-1}(s)\right)}
$$

remark that

$$
\begin{equation*}
\int_{0}^{R_{0}} f_{c}\left(w(t), z, \frac{\rho(t)}{w^{\prime}(t)}\right) w^{\prime}(t) d t=\int_{\alpha}^{\beta} f_{c}(s, z, \gamma(s)) d s \tag{3.16}
\end{equation*}
$$

and that

\Theta \geq \int_{0}^{R} \rho(t) d t \geq \int_{0}^{R_{0}} \rho(t) d t=\int_{\alpha}^{\beta} \gamma(s) d s
$$

so (1.4), (3.15), (3.16) give

Proving that $\sigma=\inf \sigma_{R}$ requires more care. Set

\end{equation*}
$$

fix any $R, w, \rho$ such that

$$
\begin{equation*}
\left.w(0)=\alpha, \quad w(R)=\beta, \quad w \in \operatorname{Lip}, \quad w^{\prime}>0 \text { on }\right] 0, R\left[, \quad \int_{0}^{R} \rho(t) d t \leq \Theta\right. \tag{3.19}
\end{equation*}
$$

and, for the time being, also

$$
\begin{equation*}
\rho \text { bounded, } \tag{3.20}
\end{equation*}
$$

and take any $R_{0}>0$ and any 1-1 Lipschitz function $\varphi:\left[0, R_{0}\right] \rightarrow[0, R]$ with Lipschitz inverse and $\varphi^{\prime}>0$. We define on $\left[0, R_{0}\right]$ two functions $w_{0}, \rho_{0}$ by

\int_{0}^{R_{0}} \rho_{0}(s) d s=\int_{0}^{R_{0}} \rho(\varphi(s)) \varphi^{\prime}(s) d s=\int_{0}^{R} \rho(t) d t \leq \Theta
$$

therefore by 3.13

$$
\begin{aligned}
\mathcal{I}(z, \Theta) & \leq \sigma_{R_{0}}(z, \Theta) \leq \int_{0}^{R_{0}} f\left(w_{0}(s), z w_{0}^{\prime}(s), \rho_{0}(s)\right) d s \\
& =\int_{0}^{R} \frac{1}{\varphi^{\prime}\left(\varphi^{-1}(t)\right)} f\left(w(t), z w^{\prime}(t) \varphi^{\prime}\left(\varphi^{-1}(t)\right), \rho(t) \varphi^{\prime}\left(\varphi^{-1}(t)\right)\right) d t
\end{aligned}
$$

If we set

$$
\lambda(t)=\varphi^{\prime}\left(\varphi^{-1}(t)\right)=1 /\left(\varphi^{-1}\right)^{\prime}(t)
$$

the choices made up to this point impose on $\lambda$ only the following restrictions:

(the bounds are due to Lipschitz continuity of $\varphi$ and $\varphi^{-1}$, and there is no restriction concerning the integral of $\lambda$ because $R_{0}$ may still be any positive number). We have proved that

\mathcal{I}(z, \Theta) \leq \int_{0}^{R} \frac{1}{\lambda(t)} f\left(w(t), z w^{\prime}(t) \lambda(t), \rho(t) \lambda(t)\right) d t \tag{3.22}
\end{equation*}

for any $(R, w, \rho)$ satisfying (3.19), 3.20) and any $\lambda$ satisfying (3.21).
Fix $M>1$ and choose $\varepsilon>0$ : we check that lemma 3.3 may be applied to
$\Lambda(t)=\left\{\lambda \in\left[M^{-1}, M\right]: \frac{1}{\lambda} f\left(w(t), z w^{\prime}(t) \lambda, \rho(t) \lambda\right) \leq f_{c}^{M}\left(w(t), z w^{\prime}(t), \rho(t)\right)+\frac{\varepsilon}{R}\right\}$.
Indeed closedness is easy, nonemptyness follows from the definition of $f_{c}^{M}$, and we must check that

is measurable if $c>0$. Assume for a while that $w \in \mathcal{C}^{1}$ and $\rho \in \mathcal{C}^{0}$ : by lemma 3.2 the function

By Lemma 3.3 there exists a measurable function $\lambda_{M}$ defined on $[0, R]$ such that

Now, the argument of $f_{c}^{M}$ lies in a compact subset of $[\alpha, \beta] \times \mathbb{R}^{n+1}$ by 3.19), 3.20, so by the continuity of $f$ and (3.9), (3.10) we may apply the dominated convergence theorem in (3.23) and get as $M \rightarrow+\infty$

Since $w$ and $\rho$ need only satisfy the mild conditions (3.19), the function $\gamma$ need only satisfy

As for the remaining statements, monotonicity, convexity and 1-homogeneity are directly verified from the definition, and subadditivity follows from the latter two. Since convexity implies continuity at all interior points of the domain, and upper semicontinuity at the boundary, we only need to prove lower semicontinuity at $(z, 0)$ : take $\left(z_{n}, \Theta_{n}\right) \rightarrow(z, 0)$ and, assuming without loss of generality that $\sigma\left(z_{n}, \Theta_{n}\right)$ has a limit, by (1.4) let $\gamma_{n} \in L^{1}([\alpha, \beta])$ be such that

Since $\Theta_{n} \rightarrow 0$ the sequence $\gamma_{n}$ converges to zero in $L^{1}$, but $f_{c}$ is continuous by Lemma 3.2 and it is positive, so Fatou's lemma implies

The bound (3.14) follows immediately from continuity.
Two remarks are in order: first, the lemma we just finished shows that to approach the value $\sigma(z, \Theta)$ one must carefully tune the distribution $\rho(s)$ of the amount $\Theta$ of surfactant with the transition profile $w(s)$, so the two are coupled. Second, it appears that the the amount of surfactant needed to reach the transition cost $\sigma(z, \Theta)$ can be lower than the given maximum $\Theta$. In fact it is not worth to take care of the unused portion as is shown in the following lemma, where the inequality constraint $\int_{0}^{R} \rho(t) d t \leq \Theta$ is substituted with an equality.

Lemma 3.5. Let $\tilde{\sigma}_{R}$ be defined by

\left.w \in \operatorname{Lip}(0, R), w^{\prime}(t)>0 \text { when } w(t)<\beta, \int_{0}^{R} w(t) d t=\Theta\right\}
\end{array}
$$

then $\sigma(z, \Theta)=\liminf _{R \rightarrow \infty} \tilde{\sigma}_{R}(z, \Theta)$.

Proof. Since $\tilde{\sigma}_{R} \geq \sigma_{R}$, by Lemma 3.4 we already have $\sigma \leq \liminf _{R \rightarrow \infty} \tilde{\sigma}_{R}$. Fix $z, \Theta$ and $R>0$ and take $\varepsilon>0$ : we will find a number $R^{\prime} \geq R$ such that $\tilde{\sigma}_{R^{\prime}}(z, \Theta) \leq \sigma_{R}(z, \Theta)+\varepsilon$, which will conclude the proof. Let $w$ and $\rho$ be as in (3.13) and such that

\end{aligned}

3.2. Convex functionals on measures. Let $X$ a locally compact metric space and let $\varphi(x, p)$ be a Borel function on $X \times \mathbb{R}^{d}$ to $\mathbb{R}_{+}$which is positively 1 homogeneous in $p$. Then we consider the functional on the space $\mathcal{M}\left(X ; \mathbb{R}^{d}\right)$ of $R^{d}$-valued vector measures on $X$ defined by

$$
\Phi: \lambda \in \mathcal{M}\left(X ; \mathbb{R}^{d}\right) \rightarrow \int_{X} \varphi\left(x, \frac{d \lambda}{d \theta}\right) d \theta
$$

where $\theta$ is a positive Radon measure on $X$ such that $\lambda \ll \theta$. By the homogenity of $\varphi$, is easy to check that the integral above does not depend on the choice of $\theta$ and therefore we may rewrite functional $\Phi$ in a more intrinsic way as

$$
\begin{equation*}
\int_{X} \varphi(x, \lambda)=\int_{X} \varphi\left(x, \frac{d \lambda}{d \theta}\right) d \theta \quad \text { for every } \theta \text { such that } \lambda \ll \theta \tag{3.28}

Furthermore, the following additivity property holds

(where $\lambda_{1} \perp \lambda_{2}$ means that $\lambda_{1}$ and $\lambda_{2}$ are mutually singular)
Now we turn to the continuity (resp. lowersemicontinuity) properties of functional $\Phi$. We will say that a sequence $\left\{\lambda_{n}\right\}$ converges weakly to $\lambda$ (denoted $\left.\lambda_{n} \stackrel{*}{\rightharpoonup} \lambda\right)$ in $\mathcal{M}\left(X ; \mathbb{R}^{d}\right)$ if we have $\int_{X} u d \lambda_{n} \rightarrow \int_{X} u d \lambda_{n}$ for every continuous test function compactly supported in $X$. A straightforward variant of an important result due to Reshetnyak is the following

Theorem 3.6. i) (Lower semicontinuity) Assume that $\varphi(x, \cdot)$ is convex, nonnegative and that $\varphi$ is lsc on $X \times \mathbb{R}^{d}$. Then

$$
\lambda_{n} \stackrel{*}{*} \lambda \quad \Longrightarrow \quad \liminf _{n} \int_{X} \varphi\left(x, \lambda_{n}\right) \geq \int_{X} \varphi(x, \lambda)
$$

ii) (Continuity) Assume that $X$ is compact and that $\varphi$ is continuous on $X \times \mathbb{R}^{d}$. Let $\left\{\lambda_{n}\right\}$ a sequence in $\mathcal{M}\left(X ; \mathbb{R}^{d}\right)$ such that

$$
\lambda_{n} \stackrel{*}{\rightharpoonup} \lambda \quad, \quad \int_{X} \varphi_{0}\left(\lambda_{n}\right) \rightarrow \int_{X} \varphi_{0}(\lambda)
$$

where $\varphi_{0}: \mathbb{R}^{d} \rightarrow \mathbb{R}_{+}$is a suitable stricly convex positively 1 -homogeneous function (i.e. $\varphi_{0}\left(z_{1}+z_{2}\right)<\varphi_{0}\left(z_{1}\right)+\varphi_{0}\left(z_{2}\right)$ whenever $\left|z_{1}\right|=\left|z_{2}\right|=1$ and $z_{1} \neq\left|z_{2}\right|$ ). Then we have

$$
\lim _{n} \int_{X} \varphi\left(x, \lambda_{n}\right)=\int_{X} \varphi(x, \lambda)
$$

Assertion i) of this theorem will be used in section 4 with $X=\Omega \times] \alpha, \beta$ [ and $d=n+1$, whereas assertion ii) will be used with $X=\bar{\Omega}$ and $d=n$.
3.3. Approximation properties for the limit energy. In order to simplify the construction of recovery sequences for the limit energy $F(u, \rho)$, it will be very useful to reduce to the case where $(u, \rho)$ is suitably regular: this will be possible using Proposition 3.10 below. Before that, we need some lemmas (two Lipschitz approximation results for measures and an approximation result for sets of finite perimeter) and we introduce a distance on the set of Radon measures.

Lemma 3.7. Let $\Omega$ be a bounded open set and let $\mu \in \mathcal{M}_{+}(\bar{\Omega})$ be a non-negative Radon measure such that $\mu(\partial \Omega)=0$. If $\theta \in L_{\mu}^{1}$, there exists a sequence $\theta_{h}$ of Lipschitz functions defined on $\mathbb{R}^{n}$ and with compact support in $\Omega$ such that $\int\left|\theta-\theta_{h}\right| d \mu \rightarrow 0$. Moreover one may take $\int \theta_{h} d \mu=\int \theta d \mu$.

Proof. By Hahn-Banach Theorem, proving that the subspace $V$ of Lipschitz functions compactly supported in $\Omega$ is dense in $L_{\mu}^{1}$ is equivalent to showing that an element $w \in L_{\mu}^{\infty}$ (dual space) vanishes whenever it satisfies $\int w \theta d \mu=0$ for all $\varphi \in V$. Let $w$ be such a function and let $B \subset \subset \Omega$ be a closed ball. Then there exists a sequence of smooth functions $\varphi_{h} \in V$ ranging in $[0,1]$ such that $\varphi_{h} \rightarrow \mathbb{1}_{B}$ and whose support lies in a slightly bigger ball $B^{\prime} \subset \subset \Omega$. By using dominated convergence, we obtain

$$
\int_{B} w d \mu=\lim _{h} \int \varphi_{h} w d \mu=0
$$

yielding that $w=0$ at every Lebesgue's point of $w$ in $\Omega$, that is $\mu$-a.e. over $\mathbb{R}^{n}$ since $\mu(\partial \Omega)=0$. So we have proved that there exists a sequence $\tilde{\theta}_{h}$ in $V$ such that $\tilde{\theta}_{h} \rightarrow \theta$ in $L_{\mu}^{1}$. In particular $r_{h}:=\int \tilde{\theta}_{h} d \mu$ converges to $r:=\int \theta d \mu$. Pick an element $\varphi_{0} \in V$ such that $\int \varphi_{0} d \mu=1$. Then $\theta_{h}:=\tilde{\theta}_{h}+\left(r-r_{h}\right) \varphi_{0}$ satisfies all requirements.
Lemma 3.8. Let $\Omega$ be a bounded open set and let $\omega \in \mathcal{M}_{+}(\bar{\Omega})$ be a non-negative Radon measure. There exists a sequence $\omega_{h}$ of non-negative Lipschitz functions defined on $\mathbb{R}^{n}$ and with compact support in $\Omega$ such that $\omega_{h} d \mathcal{L}^{n} \rightharpoonup \omega$ weakly in the sense of measures. Moreover one may take $\int_{\Omega} \omega_{h} d x=\omega(\bar{\Omega})$.

Proof. We prove that the weak closure of the set of Radon measures of the form $f d \mathcal{L}^{n}$ with $f$ Lipschitz, non-negative and compactly supported in $\Omega$ is the space of all non-negative Radon measures in $\bar{\Omega}$ : this density result clearly follows from the fact that if $\phi \in C^{0}(\bar{\Omega})$ satisfies $\int \phi f d x=0$ for all such $f$ then $\phi=0$. The last condition is dealt with as in Lemma 3.7.

The following is a variant of an approximation result for sets with finite perimeter to be found in [11] (see also [1).
Lemma 3.9. Let $A$ be a set of finite perimeter in $\Omega$. Denote by $\partial A$ the essential boundary of $A$ and by $\nu_{A}$ its generalized outward normal. Then there exists a sequence $\left\{A_{h}\right\}$ of bounded subsets of $\mathbb{R}^{n}$ with $C^{2}$ boundary satisfying

\left|A_{h} \cap \Omega\right|=|A|, \quad\left|\left(A_{h} \cap \Omega\right) \triangle A\right| \rightarrow 0, \quad \mathcal{H}^{n-1}\left(\partial A_{h} \cap \partial \Omega\right)=0

and such that for every non-negative convex continuous function $\sigma$ on $\mathbb{R}^{n} \times[0,+\infty[$ and every non-negative Lipschitz function $\rho$ on $\mathbb{R}^{n}$

$$
\lim _{h} \int_{\Omega \cap \partial A_{h}} \sigma\left(\nu_{A_{h}}, \rho(x)\right) d \mathcal{H}^{n-1}=\int_{\partial A} \sigma\left(\nu_{A}, \rho(x)\right) d \mathcal{H}^{n-1}
$$

Proof. For the construction of $A_{h}$ we refer to Lemma 4.3 in [1] where it is noticed that the vector measure $\lambda_{h}:=D \mathbb{1}_{A_{h}}$ converges tightly to $\lambda:=D \mathbb{1}_{A}$, that is

\mathcal{H}^{n-1}\left(\partial A_{h} \cap \Omega\right)=\int_{\bar{\Omega}}\left|\lambda_{h}\right| \rightarrow \int_{\bar{\Omega}}|\lambda|=\mathcal{H}^{n-1}(\partial A \cap \Omega) \tag{3.29}
\end{equation*}
$$

The last assertion follows by using property ii) in Theorem 3.6 with $\varphi_{0}(z)=|z|$ and $\varphi(x, z)=\sigma(z, \rho(x))$.

We introduce a distance on the set of positive Radon measures $\mathcal{M}_{+}(\bar{\Omega})$ by

where $\left\{\phi_{n}\right\}_{n}$ is a dense subset of $C^{0}(\bar{\Omega} ;[0,1])$. It is clear that this distance satisfies

\begin{gather*}
\mathrm{d}^{*}\left(t \mu_{1}, t \mu_{2}\right)=t \mathrm{~d}^{*}\left(\mu_{1}, \mu_{2}\right) \quad \forall t \geq 0  \tag{3.31}\\
\mathrm{~d}^{*}\left(\mu_{1}+\mu_{2}, \mu_{3}+\mu_{4}\right) \leq \mathrm{d}^{*}\left(\mu_{1}, \mu_{3}\right)+\mathrm{d}^{*}\left(\mu_{2}, \mu_{4}\right) \tag{3.32}
\end{gather*}
$$

Also, the topology induced by this distance on the space of positive Radon measures with total mass not exceeding a given value is equivalent to weak convergence, so in particular on the set $\left\{\mu \in \mathcal{M}_{+}(\bar{\Omega}): \mu(\bar{\Omega}) \leq m_{1}\right\}$ we have

$$
\mu_{h} \rightharpoonup \mu \quad \Longleftrightarrow \quad \mathrm{~d}^{*}\left(\mu_{h}, \mu\right) \rightarrow 0
$$

We may state and prove the main result of this subsection.
Proposition 3.10. Let $u \in B V(\Omega ;\{\alpha, \beta\})$, with $u=\alpha \mathbb{1}_{A}+\beta \mathbb{1}_{\Omega \backslash A}$ for some $A \subset \Omega$, and let $\rho \in \mathcal{M}_{+}(\bar{\Omega})$ be a non-negative Radon measure. There exist a sequence $\left\{A_{h}\right\}$ of bounded subsets of $\mathbb{R}^{n}$ and two sequences $\theta_{h}, \omega_{h}$ of non-negative Lipschitz functions compactly supported in $\Omega$, such that, setting

$$
u_{h}:=\alpha \mathbb{1}_{A_{h} \cap \Omega}+\beta \mathbb{1}_{\Omega \backslash A_{h}}, \quad \rho_{h}:=\theta_{h} \mathcal{H}^{n-1}\left\llcorner\partial A_{h}+\omega_{h} \mathcal{L}^{n}\llcorner\Omega\right.
$$

the following properties hold:
i) $\partial A_{h} \in C^{2}, \mathcal{H}^{n-1}\left(\partial A_{h} \cap \partial \Omega\right)=0, \int_{\Omega}\left|u_{h}-u\right| d x \rightarrow 0, \int_{\Omega} u_{h} d x=\int_{\Omega} u d x$
ii) $\rho_{h} \rightharpoonup \rho$ and $\rho_{h}(\bar{\Omega})=\rho(\bar{\Omega})$ for every $h$
iii) $\lim _{h \rightarrow+\infty} F\left(u_{h}, \rho_{h}\right)=F(u, \rho)$.

Proof. We first remark that if $\theta, \omega$ are Lipschitz and $v \in B V(\Omega ;\{\alpha, \beta\})$ then setting $\bar{\rho}=\theta \mathcal{H}^{n-1}\left\llcorner S_{v}+\omega \mathcal{L}^{n}\llcorner\Omega\right.$ we have by (1.5), (1.6)

$$
F(v, \bar{\rho})=\int_{S_{v}} \sigma\left(\nu_{v}, \theta(x)\right) d \mathcal{H}^{n-1}
$$

Setting as in (1.6)

$$
\rho^{0}=\frac{d \rho}{d J u}
$$

what we have to show, in order to prove all three properties, is that

$$
\begin{align*}
& \forall h \in \mathbb{N}, \exists A_{h}, \tilde{\theta}_{h}, \omega_{h}: \quad\left\|u_{h}-u\right\|_{1}+\mathrm{d}^{*}\left(\rho_{h}, \rho\right)<\frac{C}{h}  \tag{3.33}\\
& \int_{S_{u_{h}}} \sigma\left(\nu_{u_{h}}, \tilde{\theta}_{h}(x)\right) d \mathcal{H}^{n-1}<\int_{S_{u}} \sigma\left(\nu_{u}, \rho^{0}(x)\right) d \mathcal{H}^{n-1}+\frac{C}{h} \tag{3.34}
\end{align*}
$$

for some constant $C$, with $A_{h}, \tilde{\theta}_{h}, \omega_{h}$ as prescribed and the condition on $\int u_{h}$ and $\rho_{h}(\bar{\Omega})$ satisfied.

Fix $h$. We begin by applying Lemma 3.7 to

$$
\mu:=J u=\mathcal{H}^{n-1}\left\llcorner S_{u}, \quad \theta:=\rho^{0}=\frac{d \rho}{d \mu}\right.
$$

(recall that $S_{u} \subset \Omega$ ) and Lemma 3.8 to

$$
\omega=\rho-\theta \mathcal{H}^{n-1}\left\llcorner S_{u}\right.
$$

to obtain two sequences $\theta_{j}, \omega_{j}$. By the continuity of $\sigma$ and the convergence of $\theta_{j}$ to $\rho^{0}$ we have, using also (3.14),

$$
\int_{S_{u}}\left|\sigma\left(\nu_{u}, \theta_{j}\right)-\sigma\left(\nu_{u}, \rho^{0}\right)\right| d \mathcal{H}^{n-1} \rightarrow 0
$$

as $j \rightarrow+\infty$. By the convergence results in the two lemmas, we may select an index (which we label $h$ ) such that

$$
\begin{equation*}
\int_{S_{u}}\left|\sigma\left(\nu_{u}, \theta_{h}\right)-\sigma\left(\nu_{u}, \rho^{0}\right)\right| d \mathcal{H}^{n-1}<\frac{1}{h}, \quad \mathrm{~d}^{*}\left(\omega_{h}+\theta_{h} J u, \rho\right)<\frac{1}{h} \tag{3.35}
\end{equation*}
$$

Now we apply Lemma 3.9 to get a sequence $A_{j}$ and define $u_{j}$ accordingly. We remark that by the convergence of $D \mathbb{1}_{A_{j}}$ to $D \mathbb{1}_{A}$ we have from Theorem 3.6 that for every continuous function $\phi$

$$
\int_{S_{u_{j}}} \phi \theta_{h} d \mathcal{H}^{n-1} \rightarrow \int_{S_{u}} \phi \theta_{h} d \mathcal{H}^{n-1}
$$

and in particular

$$
p_{j}:=\int_{S_{u_{j}}} \theta_{h} d \mathcal{H}^{n-1} \rightarrow p:=\int_{S_{u}} \theta_{h} d \mathcal{H}^{n-1}=\int_{S_{u}} \rho^{0} d \mathcal{H}^{n-1}
$$

These properties together say that

$$
\frac{p}{p_{j}} \theta_{h} \mathcal{H}^{n-1}\left\llcornerS _ { u _ { j } } \rightharpoonup \theta _ { h } \mathcal { H } ^ { n - 1 } \left\llcorner S_{u}, \quad \int_{S_{u_{j}}} \frac{p}{p_{j}} \theta_{h} d \mathcal{H}^{n-1}=\int_{S_{u}} \rho^{0} d \mathcal{H}^{n-1}\right.\right.
$$

Since $\theta_{h}$ is bounded, by the continuity of $\sigma$ we deduce

$$
\sup _{|z|=1, x \in \mathbb{R}^{n}}\left|\sigma\left(z, \frac{p}{p_{j}} \theta_{h}(x)\right)-\sigma\left(z, \theta_{h}(x)\right)\right| \rightarrow 0
$$

as $j \rightarrow+\infty$, so that by (3.29)

$$
\int_{S_{u_{j}}}\left|\sigma\left(\nu_{u_{j}}, \frac{p}{p_{j}} \theta_{h}\right)-\sigma\left(\nu_{u_{j}}, \theta_{h}\right)\right| d \mathcal{H}^{n-1} \rightarrow 0 .
$$

Finally, Lemma 3.9 implies that

$$
\int_{S_{u_{j}}} \sigma\left(\nu_{u_{j}}, \theta_{h}\right) d \mathcal{H}^{n-1} \rightarrow \int_{S_{u}} \sigma\left(\nu_{u}, \theta_{h}\right) d \mathcal{H}^{n-1}
$$

so that by the previous formula

$$
\int_{S_{u_{j}}} \sigma\left(\nu_{u_{j}}, \frac{p}{p_{j}} \theta_{h}\right) d \mathcal{H}^{n-1} \rightarrow \int_{S_{u}} \sigma\left(\nu_{u}, \theta_{h}\right) d \mathcal{H}^{n-1}
$$

as $j \rightarrow+\infty$. We may therefore select an index $j$ (which we relabel $h$ ) such that defining

$$
\tilde{\theta}_{h}=\frac{p}{p_{h}} \theta_{h}, \quad \rho_{h}=\tilde{\theta}_{h} \mathcal{H}^{n-1}\left\llcorner S_{u_{h}}+\omega_{h} \mathcal{L}^{n}\llcorner\Omega\right.
$$

and using also (3.35) all conditions in (3.33), (3.34) are satisfied.

## 4. Main Result

We will use two sets of mass contraints:

$$
\begin{equation*}
\int_{\Omega} u_{\varepsilon} d x=m_{0}, \quad \int_{\Omega} \rho_{\varepsilon} d x=m_{1} \tag{4.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\int_{\Omega} u d x=m_{0}, \quad \rho(\bar{\Omega})=m_{1} \tag{4.2}
\end{equation*}
$$

Theorem 4.1. Let $\Omega$ be a bounded open subset of $\mathbb{R}^{n}$ with Lipschitz boundary, and let $f$ satisfy (H1),..,(H4). If $F_{\varepsilon}, F$ are defined as in (1.2), 1.5) respectively, then:
i) (compactness) if $\left\{\left(u_{\varepsilon}, \rho_{\varepsilon}\right)\right\}_{\varepsilon} \subset W^{1,1}(\Omega) \times L_{+}^{1}(\Omega)$ satisfies 4.1) and

$$
\sup F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right)<+\infty
$$

then there exists $(u, \rho) \in B V(\Omega ;\{\alpha, \beta\}) \times \mathcal{M}_{+}(\bar{\Omega})$ satisfying 4.2 such that at least for a subsequence

$$
\begin{array}{ll}
u_{\varepsilon} \rightarrow u & \text { strongly in } L^{1} \\
\rho_{\varepsilon} \rightharpoonup \rho & \text { weakly in the sense of Radon measures. }
\end{array}
$$

ii) (lower bound) if $\left\{\left(u_{\varepsilon}, \rho_{\varepsilon}\right)\right\}_{\varepsilon} \subset W^{1,1}(\Omega) \times L_{+}^{1}(\Omega)$ satisfies 4.1) and

$$
u_{\varepsilon} \rightarrow u, \quad \rho_{\varepsilon} \rightharpoonup \rho
$$

for some $(u, \rho) \in B V(\Omega ;\{\alpha, \beta\}) \times \mathcal{M}_{+}(\bar{\Omega})$ then $(u, \rho)$ satisfies 4.2) and $F(u, \rho) \leq \liminf _{\varepsilon \rightarrow 0} F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right)$.
iii) (upper bound) if $(u, \rho) \in B V(\Omega ;\{\alpha, \beta\}) \times \mathcal{M}_{+}(\bar{\Omega})$ satisfies (4.2) there exists $\left\{\left(u_{\varepsilon}, \rho_{\varepsilon}\right)\right\}_{\varepsilon} \subset W^{1,1}(\Omega) \times L_{+}^{1}(\Omega)$ satisfying 4.1) such that

$$
\begin{equation*}
u_{\varepsilon} \rightarrow u, \quad \rho_{\varepsilon} \rightharpoonup \rho, \quad \limsup _{\varepsilon \rightarrow 0} F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right) \leq F(u, \rho) \tag{4.3}
\end{equation*}
$$

Conditions ii) and iii) express the fact that the sequence $F_{\varepsilon}$ is $\Gamma$-converging to $F$ in the space $B V \times \mathcal{M}_{+}$endowed with the strong $L^{1}$ topology times the weak topology of measures. The remainder of this section is devoted to the proof of the three parts of the theorem.
4.1. Compactness. We truncate the function $k$ defined in (3.6) by setting

$$
\tilde{k}(s)=\min \{1, k(s)\}
$$

so that

$$
\begin{equation*}
0 \leq \tilde{k}(s) \leq 1, \quad \tilde{k}(s)=0 \Leftrightarrow s \in\{\alpha, \beta\} \tag{4.4}
\end{equation*}
$$

by (3.11); we also define

$$
K(s)=\int_{0}^{s} \tilde{k}(t) d t
$$

thus $K$ is a $\mathcal{C}^{1}$ function, strictly increasing and satisfying

$$
\begin{equation*}
|K(s)| \leq|s| \tag{4.5}
\end{equation*}
$$

Assume

$$
\begin{equation*}
F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right) \leq C ; \tag{4.6}
\end{equation*}
$$

since $\int \rho_{\varepsilon} d x=m_{1}$, we have (writing $C$ in place of $C+m_{1}$ : throughout the proof we will denote by the same letter $C$ any harmless constant)

$$
\begin{aligned}
C & \geq \int_{\Omega} \rho_{\varepsilon}+\frac{1}{\varepsilon} f\left(u_{\varepsilon}, \varepsilon \nabla u_{\varepsilon}, \varepsilon \rho_{\varepsilon}\right) d x \geq \int_{\Omega} \rho_{\varepsilon}+f_{c}\left(u_{\varepsilon}, \nabla u_{\varepsilon}, \rho_{\varepsilon}\right) d x \\
& \geq \int_{\Omega} \sqrt{\left|\nabla u_{\varepsilon}\right|^{2}+\rho_{\varepsilon}^{2}} k\left(u_{\varepsilon}\right) d x \geq \int_{\Omega} k\left(u_{\varepsilon}\right)\left|\nabla u_{\varepsilon}\right| d x \\
& \geq \int_{\Omega} \tilde{k}\left(u_{\varepsilon}\right)\left|\nabla u_{\varepsilon}\right| d x=\int_{\Omega}\left|\nabla\left(K\left(u_{\varepsilon}\right)\right)\right| d x
\end{aligned}
$$

thus

$$
\begin{equation*}
\int_{\Omega} k\left(u_{\varepsilon}\right)\left|\nabla u_{\varepsilon}\right| d x \leq C \quad, \quad\left\|\nabla\left(K\left(u_{\varepsilon}\right)\right)\right\|_{L^{1}} \leq C \tag{4.7}
\end{equation*}
$$

By (4.5), (4.6) and by using the definitions of $f_{c}$ and $F_{\varepsilon}$ we deduce

$$
\begin{aligned}
\int_{\Omega}\left|K\left(u_{\varepsilon}\right)\right| d x & \leq \int_{\Omega}\left|u_{\varepsilon}\right| d x \leq C C^{\prime}+C \int_{\Omega} f\left(u_{\varepsilon}, \varepsilon \nabla u_{\varepsilon}, \varepsilon \rho_{\varepsilon}\right) d x \\
& \leq C C^{\prime}+C \varepsilon F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right) \leq C
\end{aligned}
$$

whence

$$
\begin{equation*}
\left\|K\left(u_{\varepsilon}\right)\right\|_{24} \leq C \tag{4.8}
\end{equation*}
$$

We may also write by (4.6

$$
\int_{\Omega} \frac{1}{\varepsilon} f\left(u_{\varepsilon}, 0,0\right) d x \leq F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right) \leq C
$$

so that

$$
\begin{equation*}
\int_{\Omega} f\left(u_{\varepsilon}, 0,0\right) d x \rightarrow 0 \tag{4.9}
\end{equation*}
$$

We begin to switch back and forth between $u_{\varepsilon}$ and $K\left(u_{\varepsilon}\right)$ : by (4.7), (4.8) we deduce that the sequence $K\left(u_{\varepsilon}\right)$ is bounded in $W^{1,1}(\Omega)$, thus strongly compact in $B V$; in particular, up to a subsequence, there exists a function $\psi$ such that

$$
\psi \in B V(\Omega), \quad K\left(u_{\varepsilon}\right) \rightarrow \psi \quad \text { weakly in } B V \text { and strongly in } L^{1} .
$$

We deduce also from this that

$$
K\left(u_{\varepsilon}\right) \rightarrow \psi \quad \text { a.e. in } \Omega
$$

Since $K$ is $1-1$ by (4.4) we have that

$$
\begin{equation*}
u_{\varepsilon}=K^{-1}\left(K\left(u_{\varepsilon}\right)\right) \rightarrow u:=K^{-1}(\psi) \quad \text { a.e. in } \Omega \tag{4.10}
\end{equation*}
$$

By (H4) we have

$$
\left|u_{\varepsilon}\right| \leq C C^{\prime}+C f\left(u_{\varepsilon}, 0,0\right) d x
$$

but (4.9) implies that the non-negative sequence $f\left(u_{\varepsilon}, 0,0\right)$ converges in $L^{1}$, thus the previous two formulas imply that

$$
u_{\varepsilon} \rightarrow u \quad \text { strongly in } L^{1}(\Omega)
$$

Now the continuity of $f$ implies that

$$
f\left(u_{\varepsilon}, 0,0\right) \rightarrow f(u, 0,0) \quad \text { a.e. }
$$

but since $f\left(u_{\varepsilon}, 0,0\right) \rightarrow 0$ we obtain

$$
f(u(x), 0,0)=0 \quad \text { a.e., }
$$

which by (H1) gives $u(x) \in\{\alpha, \beta\}$ a.e.; call $A$ the set where $u(x)=\alpha$ : then $\psi(x)=K(\alpha)$ on $A$ and $\psi(x)=K(\beta)$ otherwise, so

$$
\psi=K(\alpha) \mathbb{1}_{A}+K(\beta) \mathbb{1}_{\Omega \backslash A}
$$

but as $\psi \in B V$ the set $A$ is (equivalent to one) of finite perimeter in $\Omega$ and thus

$$
u=\alpha \mathbb{1}_{A}+\beta \mathbb{1}_{\Omega \backslash A} \in B V(\Omega)
$$

As for the convergence of $\rho_{\varepsilon}$ we have that (4.1) implies that for a subsequence $\rho_{\varepsilon} \rightharpoonup \rho$, but $\rho(\bar{\Omega}) \geq m_{1}$ because $\bar{\Omega}$ is compact, and $\rho(\bar{\Omega}) \leq \rho\left(\mathbb{R}^{n}\right) \leq m_{1}$ because $\mathbb{R}^{n}$ is open.
4.2. Lower bound inequality. Assume $u=\alpha \mathbb{1}_{A}+\beta \mathbb{1}_{\Omega \backslash A}$ is a $B V$ function and let $\left\{\left(u_{\varepsilon}, \rho_{\varepsilon}\right)\right\}_{\varepsilon}$ be as in the statement ; we may assume

$$
\liminf _{\varepsilon \rightarrow 0} F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right)=\lim _{\varepsilon \rightarrow 0} F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right)<+\infty
$$

We first get rid of the areas where $u_{\varepsilon} \notin[\alpha, \beta]$ : indeed, if we consider the truncation operator $T(t)=(t \vee \alpha) \wedge \beta$ we have

$$
T\left(u_{\varepsilon}\right) \rightharpoonup T(u)=u \quad \text { weakly in } B V
$$

and

$$
\begin{aligned}
F_{\varepsilon}\left(u_{\varepsilon}, \rho_{\varepsilon}\right) & =\int_{\Omega} \frac{1}{\varepsilon} f\left(u_{\varepsilon}, \varepsilon \nabla u_{\varepsilon}, \varepsilon \rho_{\varepsilon}\right) d x \stackrel{\sqrt{1.31}}{\geq} \int_{\Omega} f_{c}\left(u_{\varepsilon}, \nabla u_{\varepsilon}, \rho_{\varepsilon}\right) d x \\
& \geq \int_{\Omega} f_{c}\left(T\left(u_{\varepsilon}\right), \nabla T\left(u_{\varepsilon}\right), \rho_{\varepsilon}\right) d x
\end{aligned}
$$

because $f_{c}\left(u_{\varepsilon}, \cdot, \cdot\right) \geq 0$ whereas $f_{c}\left(T\left(u_{\varepsilon}\right), \nabla T\left(u_{\varepsilon}\right), \cdot\right)=0$ where $u_{\varepsilon} \neq T\left(u_{\varepsilon}\right)$ due to (3.7). To avoid the weight of the notation, we may thus with no loss of generality assume that

$$
\alpha \leq u_{\varepsilon} \leq \beta
$$

and prove that

$$
\begin{equation*}
\liminf _{\varepsilon \rightarrow 0} \int_{\Omega} f_{c}\left(u_{\varepsilon}, \nabla u_{\varepsilon}, \rho_{\varepsilon}\right) d x \geq F(u, \rho) \tag{4.11}
\end{equation*}
$$

We want to rewrite the integral at the left-hand side in a way that will let us apply Reshetnyak's theorem 3.6, so we transform it into an integral (in one more dimension) on the graph of $u_{\varepsilon}$. We begin by remarking that there is no contribution to the integral from the parts where $u_{\varepsilon}=\alpha$ or $u_{\varepsilon}=\beta$, because $\nabla u_{\varepsilon}=0$ a.e. on these sets and due to (3.7). Now we associate with each $\left(u_{\varepsilon}, \rho_{\varepsilon}\right)$ three bounded Radon measures which we define on $\Omega \times] \alpha, \beta[$ as

$$
\begin{align*}
\left\langle\zeta_{\varepsilon}, \varphi\right\rangle & =\int_{\Omega} \varphi\left(x, u_{\varepsilon}\right) \nabla u_{\varepsilon} d x=\int_{\Omega \times] \alpha, \beta[ } \varphi(x, t) \frac{\nabla u_{\varepsilon}}{\sqrt{1+\left|\nabla u_{\varepsilon}\right|^{2}}} d \mathcal{H}^{n}\left\llcorner G_{u_{\varepsilon}}\right. \\
\left\langle m_{\varepsilon}, \varphi\right\rangle & =\int_{\Omega} \varphi\left(x, u_{\varepsilon}\right) \rho_{\varepsilon} d x=\int_{\Omega \times] \alpha, \beta[ } \varphi(x, t) \frac{\rho_{\varepsilon}}{\sqrt{1+\left|\nabla u_{\varepsilon}\right|^{2}}} d \mathcal{H}^{n}\left\llcorner G_{u_{\varepsilon}}(4\right.  \tag{4.12}\\
\left\langle\mu_{\varepsilon}, \varphi\right\rangle & =\int_{\Omega} \varphi\left(x, u_{\varepsilon}\right) d x=\int_{\Omega \times] \alpha, \beta[ } \frac{\varphi(x, t)}{\sqrt{1+\left|\nabla u_{\varepsilon}\right|^{2}}} d \mathcal{H}^{n}\left\llcorner G_{u_{\varepsilon}} ;\right.
\end{align*}
$$

the first one is vector-valued, all three are supported by the graph $G_{u_{\varepsilon}}$ of $u_{\varepsilon}$ and clearly

$$
\zeta_{\varepsilon} \ll \mu_{\varepsilon}, \quad \frac{d \zeta_{\varepsilon}}{d \mu_{\varepsilon}}=\nabla u_{\varepsilon}, \quad m_{\varepsilon} \ll \mu_{\varepsilon}, \quad \frac{d m_{\varepsilon}}{d \mu_{\varepsilon}}=\rho_{\varepsilon} .
$$

Recalling (3.7), by the area formula we may write

$$
\begin{align*}
\int_{\Omega} f_{c}\left(u_{\varepsilon}, \nabla u_{\varepsilon}, \rho_{\varepsilon}\right) d x & =\int_{\Omega \times] \alpha, \beta[ } f_{c}\left(t, \nabla u_{\varepsilon}(x), \rho_{\varepsilon}(x)\right) \frac{1}{\sqrt{1+\left|\nabla u_{\varepsilon}\right|^{2}}} d \mathcal{H}^{n}\left\llcorner G_{u_{\varepsilon}}\right. \\
& =\int_{\Omega \times] \alpha, \beta[ } f_{c}\left(t, \nabla u_{\varepsilon}(x), \rho_{\varepsilon}(x)\right) d \mu_{\varepsilon} \\
& =\int_{\Omega \times] \alpha, \beta[ } f_{c}\left(t, \frac{d \zeta_{\varepsilon}}{d \mu_{\varepsilon}}, \frac{d m_{\varepsilon}}{d \mu_{\varepsilon}}\right) d \mu_{\varepsilon} \\
& =\int_{\Omega \times] \alpha, \beta[ } f_{c}\left(t, \zeta_{\varepsilon}, m_{\varepsilon}\right) \tag{4.13}
\end{align*}
$$

by (3.28). We will prove that up to subsequences we have

$$
\begin{equation*}
\zeta_{\varepsilon} \rightharpoonup \zeta, \quad m_{\varepsilon} \rightharpoonup m \tag{4.14}
\end{equation*}
$$

weakly in the sense of measures, therefore by Reshetnyak's theorem 3.6

\liminf _{\varepsilon \rightarrow 0} \int_{\Omega \times] \alpha, \beta[ } f_{c}\left(t, \zeta_{\varepsilon}, m_{\varepsilon}\right) \geq \int_{\Omega \times] \alpha, \beta[ } f_{c}(t, \zeta, m) \tag{4.15}
\end{equation*}
$$

The measures $m_{\varepsilon}$ are uniformly bounded, and on the other hand (4.7), by (3.11) and the continuity of $k$, implies

$$
\int_{\left\{x \in \Omega: \alpha+\delta<u_{\varepsilon}(x)<\beta-\delta\right\}}\left|\nabla u_{\varepsilon}(x)\right| d x \leq c_{\delta}
$$

hence also $\zeta_{\varepsilon}$ is compact and (4.14) is proved: we will now identify the limits of the measures $\zeta_{\varepsilon}$ as $\varepsilon \rightarrow 0$; to this aim it is enough to take as test functions those which are products of a function of $x$ times a function of $t$, that is we take

The support of $a(t)$ is contained in an interval $] \alpha^{\prime}, \beta^{\prime}$, and (4.10) implies that the bounded functions $u_{\varepsilon}$ converge pointwise a.e. to $u$, thus $A\left(u_{\varepsilon}\right)$ converges in $L^{1}$ and we deduce that the last integral converges as $\varepsilon \rightarrow 0$ to

by the form of $u$ and the fact that $A(\alpha)=0$. Since $u$ is in $B V$, recalling the definitions of $S_{u}, J u$ and $\nu_{u}$ given in section 1 we may write

What we proved for product functions extends by density, and we may thus write

It is not easy to characterize the limit of $m_{\varepsilon}$; to better understand the outcome it is useful, in addition to (4.12), to write also

Thus $m_{\varepsilon}$ is a product measure which (as $G_{u_{\varepsilon}}$ has no vertical part) on the vertical side is concentrated on a single real value for each $x$. The projection of $m_{\varepsilon}$ on $\Omega$ is just $\rho_{\varepsilon} d \mathcal{L}^{n}$, and what we know of the measure $m$ in (4.14) is that, due to the assumption $\rho_{\varepsilon} \rightharpoonup \rho$, the projection of $m$ on $\Omega$ is $\rho$. Define

we may split $m$ into its absolutely continuous and singular parts with respect to $\mu$, as $m=m_{a} d \mu+m_{s}$, and due to our considerations for $\mathcal{H}^{n-1}$-a.e. $x \in S_{u}$ there exists a probability measure $p^{x}$ on $] \alpha, \beta$ [ such that, denoting by $p_{a}^{x}(t) d t$ its absolutely continuous part with respect to $\mathcal{L}^{1}\llcorner ] \alpha, \beta[$,

We remark that as $p^{x}$ was a probability, now

& \geq \int_{\Omega \times] \alpha, \beta[ } f_{c}\left(t, \frac{d \zeta}{d \mu}, \frac{d m}{d \mu}\right) d \mu \\
& =\int_{S_{u}}\left(\int_{\alpha}^{\beta} f_{c}\left(t, \nu_{u}, \frac{d \rho}{d J u}(x) p_{a}^{x}(t)\right) d t\right) d J u \\
& \geq \int_{S_{u}} \sigma\left(\nu_{u}, \frac{d \rho}{d J u}(x)\right) d J u \tag{4.21}
\end{align*}
$$

by (4.20) and $(\sqrt{1.4})$. The proof of (4.11) follows by collecting (4.13), (4.15), (4.21) and the definition (1.2) of $F(u, \rho)$.

Going back to (4.19), we see that now that the graph of $u$ has vertical parts, the measure $m$, besides eventually possessing a singular part with respect to $J u \otimes \mathcal{L}^{1}$, spreads its pointwise projection $\frac{d \rho}{d J u}(x)$ on the vertical line from $\alpha$ to $\beta$ in the fashion that turns out to be most favorable in terms of $f_{c}\left(t, \nu_{u}, \cdot\right)$-energy. A word about the singular part of $m$, which plays no role in the final energy: it is easy to remark that if by chance the approximating functions $u_{\varepsilon}$ take the value $\alpha$ (or $\beta$ ) on a set $S$ of positive measure, and if we take $\rho_{\varepsilon}$ to be any (even huge) constant on $S$, then by (H1),(H2),(H3)

and the energy contribution of this part of the limit $m$ is indeed zero.
4.3. Upper bound inequality. We use the distance introduced in (3.30); using a simplified notation (we omit some spaces and conditions) it is readily seen that (4.3) is equivalent to

\end{gather*}

for some fixed constant $C$. Indeed it is trivial that (4.3) implies (4.22); for the converse, one may first make sure that $\varepsilon_{j} \searrow 0$ by setting

as $\tilde{\varepsilon}_{j} \searrow 0$, also $j(\varepsilon) \rightarrow \infty$ when $\varepsilon \rightarrow 0$, and

\left\|u_{\varepsilon}^{j(\varepsilon)}-u\right\|_{1}+\mathrm{d}^{*}\left(\rho_{\varepsilon}^{j(\varepsilon)}, \rho\right) \rightarrow 0, \quad \limsup _{\varepsilon \rightarrow 0} F_{\varepsilon}\left(u_{\varepsilon}^{j(\varepsilon)}, \rho_{\varepsilon}^{j(\varepsilon)}\right) \leq F(u, \rho)

We will therefore concentrate on (4.22). We have several tasks ahead, and we accordingly subdivide the proof into several steps: at the beginning we deal with
the case when everything is smooth, then we will use the approximation result of Lemma 3.10 .

Step 1: smooth interface, preliminaries and first approximation of $\rho$ on $S_{u}$. Let $u \in B V(\Omega ;\{\alpha, \beta\})$ be a function with a nice interface: precisely we assume that there exists a bounded open set $U \subset \mathbb{R}^{n}$ with smooth boundary such that

We remark that inside $\Omega$ the vector $\nu_{u}(x)$ coincides with the outward normal vector $n_{U}(x)$ to $U$; to avoid doubling the notation, we define $\nu_{u}(x)$ on all of $\partial U$ as $n_{U}(x)$.

Since $U$ is smooth, denoting by dist ${ }^{ \pm}$the signed distance to $\partial U$, i.e.

if we define for all $r>0$

there exists a number $T>0$ such that the projection $\Pi(x)$ of $x$ onto $\partial U$ is well defined on the strip $U^{T}$, and the mapping

is a smooth diffeomorphism whose jacobian satisfies

Let $\rho$ be a nice function: precisely we assume that there exist two non-negative Lipschitz functions $\rho^{0}$, $\rho^{1}$ compactly supported in $\Omega$ such that

\end{equation*}

if $m_{1}^{\prime}=0$ much of the trouble we are going to be into would be spared, because $\sigma(z, 0)=\max \sigma(z, \cdot)$, thus we assume that, alas, this is not the case. Eventually reducing the value of the number $T$ above, we also assume that

\operatorname{spt} \rho^{0} \cup \operatorname{spt} \rho^{1} \subset \subset \Omega_{T}
$$

The lives of the two measures split for a while: steps $1 \ldots 4$ are devoted to the approximation of $\rho^{0}$ and step 5 to $\rho^{1}$; the two proofs are entirely independent, and may be read in any order. We warn that to improve readability (and since confusion is unlikely) we will frequently employ the same symbol to denote a measure and its density with respect to a base measure which is clear from the context: thus for example we will denote by $\rho^{0}$ both the measure $\rho^{0}(x) \mathcal{H}^{n-1}\left\llcorner S_{u}\right.$ and its density $\rho^{0}(x)$. Also, when dealing with subsets of $\partial U$ we will use terms as open and boundary referring to the relative topology, without further mentioning it.

To help the reader not to get lost, we include a map of what lies forth: for simplicity imagine $x$ is the coordinate on the jump set, and $t$ orthogonal to it; for every $x$ we want to approximate $\sigma\left(\nu_{u}(x), \rho^{0}(x)\right)$ with a smooth transition from $\alpha$ to $\beta$. To do this we must rely on Lemma 3.4 and 3.13 which $\operatorname{link} \sigma\left(\nu_{u}(x), \rho^{0}(x)\right)$ with something containing the original integrand $f$; unfortunately this gives rise to a family of "near best" transitions, one for each $x$, given in the notation of (3.13) by the couples $\left(w_{x}(t), \rho_{x}(t)\right)$, where we stress the dependence on the point $x$.

This family has no regularity properties at all with respect to $x$, thus we are forced to replace it by a piecewise constant (with respect to $x$ ) choice, later to be smoothed out by a partition of unity method. We will therefore select small intervals, and pick points $x$ where $\int f\left(w_{x}, \nu_{u}(x) w_{x}^{\prime}, \rho_{x}\right) d t$ nearly matches $\sigma\left(\nu_{u}(x), \rho^{0}(x)\right)$. This process may ruin the condition of constant total mass on $\rho$, and we remark that as this mass might be entirely concentrated on the jump set, we cannot risk to exceed $m_{1}^{\prime}$ : we therefore must voluntarily reduce $\rho^{0}$ so that its mass is less than $m_{1}^{\prime}$, which will leave us with some room for the piecewise constant approximation without mass problems; we will later put the extra mass remaining in a dustbin far from the jump set. One last problem will come from the volume constraint on $u$ : to deal with this we will move the transition strip a little around the jump set, and as we do not want this translation to ruin all we did to preserve the mass of $\rho$ by letting some of it fall outside $\Omega$, all future movements will have amplitude not exceeding $T$.

The first brick is the dustbin: take, say, a ball $P \subset \Omega$ far from $S_{u}$ and $\partial \Omega$ : we may assume its distance from both is at least $T$. Fix $j \in \mathbb{N}$; as this will remain the same throughout the proof, dependence on $j$ is harmless, and will be stressed only very sparingly. We measure how much mass we may afford to put in the dustbin: let $\Delta m>0$ be such that

(this $\Delta m$ is one of the $j$-dependent quantities). By (3.31) this implies that

We reserve half the dustbin's capacity for each of $\rho^{0}$ and $\rho^{1}$ : choose $m_{1}^{\prime \prime}$ such that

$$

In step 3 we will have to venture on $\partial U$ a bit beyond $\Omega$ : thus we define the function $\rho^{0}$ on all of $\partial U$ by extending it as zero outside $\Omega$. We thus remark that the function $\sigma\left(\nu_{u}(x), \rho^{0}(x)\right)$ is well defined on $\partial U$. For simplicity of notation, it is also convenient to restrict the function $\rho^{0}$ to $\partial U$, so that $\operatorname{spt} \rho^{0} \subset \subset \Omega \cap \partial U$. Now remark that by 4.23

so we may take $0<r_{j}<T / 3$, and a constant $\vartheta_{j}<1$ so close to 1 that if we define a smaller function

\end{equation*}

the introduction of the number $\vartheta_{j}<1$ was needed only to get that the very last inequality is strict, so from now on we will be able to slightly change the function without worrying whether this increases or decreases the norm.

We also impose on $r_{j}$ the following restriction:

Step 2: near best slope and piecewise constant approximation. We are not finished with $\rho^{0}$ yet; pick a small number $\vartheta>0$ such that both functions

We may also suppose the number $\vartheta$ to be so small that for any non-negative continuous function $\bar{\rho} \in L^{1}(\partial U)$

by (4.34). We apply Lemma 3.5 to obtain for each point $x \in \partial U$ a number $r_{x}$ and functions $w_{x}, \rho_{x}$ as in (3.26) such that

(due to the first condition we have $\rho_{x} \equiv 0$ outside spt $\rho^{0}$ ). In particular for $Y=x$ we have
$\rho_{s m}(Y)-\vartheta<\int_{0}^{r_{x}} \rho_{x}(t) d t<\rho_{s m}^{+}(Y), \int_{0}^{r_{x}} f\left(w_{x}(t), \nu_{u}(Y) w_{x}^{\prime}(t), \rho_{x}(t)\right) d t<\xi(Y)$.
Since $\rho_{s m}, f, \nu_{u}, \xi$ are continuous functions, these inequalities hold also for all $Y$ in a neighbourhood $I_{x}$ of $x$ in $\partial U$, and in particular since $\rho_{x} \geq 0$ we have for all $Y \in I_{x}$
$\rho_{s m}^{-}(Y) \leq \int_{0}^{r_{x}} \rho_{x}(t) d t<\rho_{s m}^{+}(Y), \quad \int_{0}^{r_{x}} f\left(w_{x}(t), \nu_{u}(Y) w_{x}^{\prime}(t), \rho_{x}(t)\right) d t<\xi(Y)$
(we had to use the possibly negative function $\rho_{s m}-\vartheta$ only to have a clean strict inequality at boundary points of the support of $\rho_{s m}$ ). We impose another restriction: if $x \in \Omega_{2 r_{j}}$ then $I_{x} \subset \Omega_{2 r_{j}}$, and for all $x \in \partial U \backslash \operatorname{spt} \rho^{0}$ we assume that $I_{x}$ does not intersect $\operatorname{spt} \rho^{0}$ : these points will thus never contribute in terms of $\rho$, since $\rho_{s m}=0$ on all of $I_{x}$; instead, the sets $I_{x}$ for all points in $\operatorname{spt} \rho^{0}$ will never go beyond $\Omega_{2 r_{j}}$. Finally we assume these sets are nice, precisely that $I_{x}$ is the intersection of $\partial U$ with an open ball $B_{x}$ centered at $x$ and with radius less than the number $T$ defined in (4.25), and we define $W_{x}$ to be the intersection of $\Sigma_{u}$ with the ball of half the radius of $B_{x}$, thus $W_{x}$ is relatively open in $\Sigma_{u}$.

We cover $\Sigma_{u}$ with a finite number of these sets, $W_{1}, \ldots, W_{k}$ with $W_{m} \equiv W_{x_{m}}$, and let $I_{m}, r_{m}, w_{m}, \rho_{m}$ be the sets, numbers and functions $I_{x_{m}}, r_{x_{m}}, w_{x_{m}}, \rho_{x_{m}}$ respectively. To make the sets disjoint, we replace each $W_{m}$ by

W_{m} \backslash \bigcup_{\substack{i=1 \\ 33}}^{m-1} \overline{W_{i}},
$$

which we relabel $W_{m}$ not to add to the already exhuberant notation, and we remark that $I_{m}$ is still an open neighbourhood of $W_{m}$. We get rid of the numbers $r_{m}$ by calling $r=\max \left\{r_{m}\right\}$ and by extending the functions $w_{m}$ and $\rho_{m}$ as $\beta$ and 0 respectively on $\left.] r_{m}, r\right]$ : this does not change the situation, as $f(\beta, 0,0)=0$. For our future convenience we may go one step further, extending $w_{m}, \rho_{m}$ on all of $\mathbb{R}$ as $\alpha, 0$ for $t<0$ and $\beta, 0$ for $t>r$ : still nothing changes.

We summarize the situation: we have

with $\mathcal{H}^{n-1}(N)=0$ and all sets disjoint; we also have functions $w_{m}, \rho_{m}$ such that for all points $x \in I_{m}$

Step 3: glueing together the pieces in a neighbourhood of $\Sigma_{u}$. In this step we use ideas from the proof of [1]; basically we will use $w_{m}$ and $\rho_{m}$ in $W_{m}$ to define a function in a small "cylinder" sticking out from $W_{m}$ into $\Omega$, but although this might be fine for $\rho$, the resulting function $w$ is irregular, so we will interpolate between neighbouring patches.

Take a number $\delta>0$, whose value we will be able to fix later, smaller than half the smallest radius of the balls $B_{m}$ and smaller than $r_{j}$, and let
$W_{m}^{\delta}=\left\{x \in W_{m}: \operatorname{dist}\left(x, \partial U \backslash W_{m}\right) \geq \delta\right\}, \quad \widetilde{W}{ }_{m}^{\delta}=\left\{x \in \partial U: \operatorname{dist}\left(x, W_{m}\right)<\delta\right\}:$ since $\widetilde{W}_{1}^{\delta} \cup \cdots \cup \widetilde{W}_{k}^{\delta}$ is a neighbourhood of $\Sigma_{u}$ and each $W_{m}^{\delta}$ is compact in $\widetilde{W}_{m}^{\delta}$, we may take a partition of unity $\psi_{1}, \ldots, \psi_{k}$ on $\Sigma_{u}$ such that

for some $C$ independent of $\delta$.
Recalling (4.26), we remark that for $\vartheta>r / T$ the function

is regular and it is well defined for all $x \in \mathbb{R}^{n}$ such that

which contains an $n$-dimensional neighbourhood of $\partial U$; moreover where

its value on one face of the neighbourhood is $\alpha$, its value on the other is $\beta$. This may seem a good candidate for the transition, just extending the resulting function as $\alpha$ or $\beta$ elsewhere, but there are two (minor) problems: for one thing, there may be points in $\Omega$ satisfying (4.38) but not (4.39), and the proposed extension would then be discontinuous; also, recalling (4.24), the proposed extension would
have value $\alpha$ in all of $A$, but $\beta$ only in a portion of $B$, thus missing the integral constraint. Thanks to the introduction of $\Sigma_{u}$ we will show that it is easy to deal with the first problem, while to tackle the second we will slightly shift the centre of the neighbourhood in the normal direction to $\partial U$.

Recall that $T>3 r_{j}$ and that $\operatorname{dist}\left(\partial U \backslash \Sigma_{u}, \Omega\right) \geq 2 r_{j}$, so that

where $c$ was defined in (4.27); we are about to set a first $j$-dependent restriction on $\varepsilon$, which will be used to determine the number $\varepsilon_{j}$ of (4.22): recalling (4.24), (4.25), we define in $\Omega$ for all $\varepsilon<R_{j} / r$

u_{\varepsilon}^{\delta}(x)=\sum_{m=1}^{k} \psi_{m}(\Pi(x)) w_{m}\left(\frac{\operatorname{dist}^{ \pm}(x)}{\varepsilon}+\tau_{\varepsilon}\right) & \text { if } x \in \Omega \cap U^{R_{j}}  \tag{4.42}\\
u_{\varepsilon}^{\delta}(x)=\alpha & \text { if } x \in A \backslash U^{R_{j}}, \quad u_{\varepsilon}^{\delta}(x)=\beta \quad \text { if } x \in B \backslash U^{R_{j}},
\end{array}
$$

where $\tau_{\varepsilon} \in[0, r]$ will be chosen in a few lines. By 4.40), if $x \in \Omega$ is such that $\operatorname{dist}^{ \pm}(x)=R_{j}$ then $\left|\operatorname{dist}^{ \pm}(x)\right|<r_{j}$ and

no matter what $\tau_{\varepsilon} \geq 0$ is, so $w_{m}(\cdots)=\beta$ for all $m$ and therefore $u_{\varepsilon}^{\delta}(x)=\beta$; analogous considerations hold on the other side of $U^{R_{j}}$, where $\operatorname{dist}^{ \pm}(x)=-R_{j}$ and the value turns out to be $\alpha$ for any $\tau_{\varepsilon} \leq r$. Thus the resulting function $u_{\varepsilon}^{\delta}$ is in $W^{1,1}(\Omega)$; moreover it is always between $\alpha$ and $\beta$ because so do the functions $w_{m}$ of which it is a convex combination, and it agrees with the target function $u$ except on a set whose measure by (4.41) does not exceed $1 / j$, so that

Therefore there exists a value of $\tau_{\varepsilon}$ for which the volume constraint

\bar{\rho}_{m}=0 \text { if } I_{m} \cap \operatorname{spt} \rho^{0}=\emptyset, \quad \bar{\rho}_{m} \neq 0 \Rightarrow \widetilde{W}_{m}^{\delta} \subset I_{m} \subset \Omega_{2 r_{j}}
\end{gathered}
$$

and in particular

\operatorname{spt} \rho_{p}^{\delta} \subset S_{u} \cap \Omega_{2 r_{j}} \tag{4.44}
\end{equation*}
$$

and also, since at each point the value $\rho_{p}^{\delta}(x)$ is a convex combination of only those $\bar{\rho}_{m}$ for which $x \in I_{m}$, by the first part of (4.36) we have

In particular we deduce by (4.34), the monotonicity of $\sigma$ and the choice of $\rho_{s m}^{-}, \rho_{s m}^{+}$ made at the beginning of step 2

\rho_{\varepsilon}^{\delta}(x)=\frac{1}{\varepsilon} \sum_{m=1}^{k} \psi_{m}(\Pi(x)) \rho_{m}\left(\frac{\text { dist }^{ \pm}(x)}{\varepsilon}+\tau_{\varepsilon}\right) \quad \text { if } x \in \Omega \cap U^{R_{j}}
$$

and zero elsewhere. It is clear that as $\varepsilon \rightarrow 0$ this family converges weakly to the measure $\rho_{p}^{\delta}$, and also that $\int_{\Omega} \rho_{\varepsilon}^{\delta} d x \rightarrow \int_{S_{u}} \rho_{p}^{\delta} d \mathcal{H}^{n-1}$, so we deduce by (4.32) and the choice of $\rho_{s m}^{-}, \rho_{s m}^{+}$that for $\varepsilon$ small (this is the second condition to build $\varepsilon_{j}$ )

\end{equation*}

since the support of each $\rho_{m}$ is in $[0, r]$, the support of $\rho_{\varepsilon}^{\delta}$ is contained in

\left\{y \in \Omega: y=x+t \nu_{u}(x), x \in \operatorname{spt} \rho_{p}^{\delta},|t| \leq \varepsilon r\right\}
$$

but as we chose

\varepsilon r \leq R_{j} \leq r_{j}
$$

we finally deduce by (4.44)

The remark extends to $u_{\varepsilon}^{\delta}$, for which we may say

We summarize: concentrating on $\rho^{0}$ and the jump, we found a candidate family of transitions $u_{\varepsilon}^{\delta}$ which converges in $L^{1}$ to $u$ and satisfies the integral constraint, and a candidate family of $L^{1}$ functions $\rho_{\varepsilon}^{\delta}$ whose support is a narrow strip close to $S_{u}$ and far from $\partial \Omega$, whose integral is not too far from $\int_{S_{u}} \rho^{0}$ and which are sufficiently close to $\rho^{0}$ in the $\mathrm{d}^{*}$ metric.

Step 4: energy estimate and conclusion for $\rho^{0}$. We restrict ourselves to the strip $\Omega \cap U^{\varepsilon r}$, outside which $f\left(u_{\varepsilon}^{\delta}, \varepsilon \nabla u_{\varepsilon}^{\delta}, \varepsilon \rho_{\varepsilon}^{\delta}\right) \equiv 0$. We add another restriction about $\varepsilon_{j}$ : we will assume that

$$
\varepsilon \leq \delta
$$

( $\delta$ has still to be chosen, but we will do so depending only on $j$ ). Since the functions $w_{m}(t)$ we got from Lemma 3.5 were Lipschitz, from (4.37), (4.42) and the regularity of $\partial U$ we deduce

Now take a patch $W_{m}^{\delta}$ and remark that on $\left\{x \in \Omega \cap U^{\varepsilon r}: \Pi(x) \in W_{m}^{\delta}\right\}$ we have

& \quad=\int_{W_{m}^{\delta}} d \mathcal{H}^{n-1}(x) \int_{0}^{r} f\left(w_{m}(t), \nu_{u}(x) w_{m}^{\prime}(t), \rho_{m}(t)\right) J \Phi^{-1}(y) d t
\end{aligned}
$$

where $y \in \Omega \cap U^{\varepsilon r}$ is the only place where $\varepsilon$ hides. Recalling (4.28) and later using (4.36) we have

& =\int_{W_{m}^{\delta}} d \mathcal{H}^{n-1}(x) \int_{0}^{r} f\left(w_{m}(t), \nu_{u}(x) w_{m}^{\prime}(t), \rho_{m}(t)\right) d t \\
& \quad<\int_{W_{m}^{\delta}} \xi(x) d \mathcal{H}^{n-1},
\end{aligned}
$$

so that for $\varepsilon$ sufficiently small (this is the last restriction on $\varepsilon_{j}$ as far as $\rho^{0}$ is concerned)

where we used again (H1). Summing with respect to $m$ and collecting (4.35), (4.46) and 4.47) we get at last

for all $\varepsilon$ sufficiently small.
Step 5: reduction to a simpler problem and approximation of $\rho^{1}$. Recalling the subadditivity property (3.32) of $\mathrm{d}^{*}$ and comparing (4.43), (4.45), (4.48) with our goal (4.22), we see that we still have to define $\rho_{\varepsilon}^{j}$ also outside the strip $U^{r_{j}}$ in such a way that using the hybrid notation $[\alpha ; \beta]$ to denote $\alpha$ in $A$ and $\beta$ in $B$,

where $\rho^{1}$ was defined in 4.29). Indeed the last condition and 4.48), given 1.2 and (1.5), immediately imply the last inequality in (4.22). Recall the definition (4.30) of $m_{2}^{\prime}$; if we are in the lucky case $m_{2}^{\prime}=0$ then $\rho_{j}=0$ outside $U^{r_{j}}$ and
that's the end. Else, the task ahead is not too hard: we remark that the function $\rho^{j}=\rho^{1}\left\llcorner\left(\Omega \backslash U^{r_{j}}\right)\right.$ satisfies

and remembering (4.31) define on $\Omega \backslash U^{r_{j}}$

(recall that $\rho_{\varepsilon}^{j}$ is already defined on $\Omega \cap U^{r_{j}}$ ). This family satisfies the integral constraint $\int \rho_{\varepsilon}^{j}=m_{1}$, also $\mathrm{d}^{*}\left(\rho_{\varepsilon}^{j}, \rho\right)<C / j$ and by the $L^{\infty}$ bound, since $c_{\varepsilon} \leq m_{1}$, we deduce by (3.27)

\rho_{\varepsilon}^{j} \leq M \quad \text { on } \Omega \backslash U^{r_{j}} \quad \Rightarrow \quad f\left([\alpha ; \beta], 0, \varepsilon \rho_{\varepsilon}^{j}\right) \leq \varepsilon M \eta(\varepsilon M) \quad \text { on } \Omega \backslash U^{r_{j}}
$$

so that

$$
\frac{1}{\varepsilon} \int_{\Omega \backslash U_{j}^{r}} f\left([\alpha ; \beta], 0, \varepsilon \rho_{\varepsilon}^{j}\right) d x \leq M \eta(\varepsilon M) \rightarrow 0
$$

as $\varepsilon \rightarrow 0$, and we may suppose that

$$
\frac{1}{\varepsilon} \int_{\Omega \backslash U_{j}^{r}} f\left([\alpha ; \beta], 0, \varepsilon \rho_{\varepsilon}^{j}\right) d x \leq \frac{1}{j}
$$

for $\varepsilon \leq \varepsilon_{j}$ suitably small (last restriction on $\varepsilon_{j}$ ).
Step 6: general case. By the metric nature of both $L^{1}$ convergence and weak convergence of Radon measures with equibounded mass, 4.22) in the general case now follows easily from Proposition 3.10. let $u_{h}, \rho_{h}$ be the sequence given by this proposition and fix $j$; there exists $\bar{h}$ such that

$$
\left\|u_{\bar{h}}-u\right\|_{1}+\mathrm{d}^{*}\left(\rho_{h}, \rho\right)<\frac{1}{j}, \quad F\left(u_{\bar{h}}, \rho_{h}\right)<F(u, \rho)+\frac{1}{j} .
$$

In steps $1 \ldots 5$ we proved that (4.22) holds if $u, \rho$ are nice, so in particular if $\left(u_{\varepsilon}^{j}, \rho_{\varepsilon}^{j}\right)$ is the sequence given by (4.22) with $u_{\bar{h}}, \rho_{\bar{h}}$ in place of $u, \rho$ we have for all $\varepsilon<\varepsilon_{j}$

$$
\left\|u_{\varepsilon}^{j}-u\right\|_{1}+\mathrm{d}^{*}\left(\rho_{\varepsilon}^{j}, \rho\right)<\frac{C+1}{j}, \quad F_{\varepsilon}\left(u_{\varepsilon}^{j}, \rho_{\varepsilon}^{j}\right)<F(u, \rho)+\frac{C+1}{j} .
$$
