## Regularity of optimal transport maps on multiple products of spheres \*

#### Abstract

This article addresses regularity of optimal transport maps for cost="squared distance" on Riemannian manifolds that are products of arbitrarily many round spheres with arbitrary sizes and dimensions. Such manifolds are known to be non-negatively cross-curved [KM2]. Under boundedness and non-vanishing assumptions on the transferred source and target densities we show that optimal maps stay away from the cut-locus (where the cost exhibits singularity), and obtain injectivity and continuity of optimal maps. This allows to be used to with the results of Liu, Trudinger and Wang [LTW] to conclude higher regularity  $(C^{1,\alpha}/C^{\infty})$  of optimal maps for smoother  $(C^{\alpha}/C^{\infty})$  densities. These are the first global regularity results which we are aware of concerning optimal maps on Riemannian manifolds which possess some vanishing sectional curvatures, beside the totally flat case of  $\mathbb{R}^n$  [Ca3] and its quotients [Co]. Moreover, such product manifolds have potential relevance in statistics (see [S]) and in statistical mechanics (where the state of a system consisting of many spins is classically modeled by a point in the phase space obtained by taking many products of spheres). For the proof we apply and extend the method developed in [FKM1], where we showed injectivity and continuity of optimal maps on domains in  $\mathbb{R}^n$  for smooth non-negatively cross-curved cost. The major obstacle in the present paper is to deal with the product structure of the cut-locus and the presence of flat directions.

Transport Equation: Analysis and Control

#### 1 Introduction

ERC-Summer School on "Calculus of Variations, Continuum Mechanics and Geometric Inequalities" Let M and M be n-dimensional complete Riemannian manifolds, and let  $\mu = \rho \operatorname{vol}_M$  and  $\nu = \bar{\rho} \operatorname{vol}_{\bar{M}}$  be two probability measures whose densities  $\rho$  and  $\bar{\rho}$  are bounded away from zero and infinity. Given a cost function  $c: M \times \overline{M} \to \mathbb{R}$ , the optimal transport problem with cost c(x,y) consist in finding a transport map  $T:M\to \bar{M}$  which sends  $\mu$  onto  $\nu$  and minimizes the transportation cost

$$\int_M c(x,T(x))\,d\mu(x).$$

As shown by McCann [M] extending the result of Brenier [Br] on  $\mathbb{R}^n$ , if  $M = \overline{M}$  and c =dist<sup>2</sup>/2 then the optimal transport map (or simply optimal map) exists and is unique. More generally, the same result holds if the cost is semiconcave and satisfies the twist condition in Assumption 2.1, see for instance [V, Chapter 10].

The optimal map T is uniquely characterized by the relation  $T(x) \in \partial^c \phi(x)$ , where  $\phi$  is a c-convex function (called potential) and  $\partial^c \phi$  denotes its c-subdifferential (see Section 2 for the definitions). Furthermore, the fact that  $\rho$  and  $\bar{\rho}$  are bounded away from zero and infinity ensures the existence of a constant  $\lambda > 0$  such that the following Monge-Ampère type equation holds:

$$\lambda |\Omega| \le |\partial^c \phi(\Omega)| \le \frac{1}{\lambda} |\Omega| \quad \forall \Omega \subset M \text{ Borel},$$

where  $\partial^c \phi(\Omega) = \bigcup_{x \in \Omega} \partial^c \phi(x)$ . (See for instance [FKM1, Lemma 3.1].)

The aim of this paper is to investigate the regularity issue of optimal maps when  $M = \overline{M}$  are multiple product of spheres, i.e.,  $M = \bar{M} = \mathbb{S}_{r_1}^{n_1} \times \ldots \times \mathbb{S}_{r_k}^{n_k}$ , and  $c(x,y) = f(\operatorname{dist}(x,y))$  for some function f, including the case  $f(t) = t^2/2$  of distance squared cost. For k = 1 and  $f(t) = t^2/2$ , smoothness of optimal maps has been proved by Loeper [L2]. However, if k > 1 the structure of the cut-locus (the singular set of the cost function) becomes more complicated, and due to the product structure, the manifold has both flat and positively curved directions, thus making the regularity issue much more delicate. Especially, the powerful Hölder regularity estimate of Loeper [L1] (see also [Li]) as well as the a priori estimates of Ma, Trudinger and Wang [MTW], which are successfully applied to positively curved manifolds as in [L2, KM2, LV, FR, DG, FRV], are not available any more in our setting. Our main results (Theorem 5.1 and Corollary 5.3) give the first global regularity results which we are aware of concerning optimal maps on non-flat Riemannian manifolds which allow vanishing sectional curvature. For completely flat manifolds (with  $c = dist^2/2$ ) the regularity of optimal maps is known as it reduces to the regularity theory of the classical Monge-Ampére equation [D1, Ca1, Ca2, Ca3, U, Ca4, Co, D2, G].

To describe our result more precisely, first recall that in [MTW] Ma, Trudinger and Wang discovered condition (A3) on the cost function, whose weaker variant (A3w) [TW] turned out to be both necessary [L1] and sufficient [TW] for regularity when the solution  $\phi$  is known to be strictly c-convex and the cost function is smooth. When  $M = \overline{M} = \mathbb{S}_r^n$ , the particular structure of the cut-locus (for every point x, its cut-locus Cut(x) consists of its antipodal point) allowed Delanoë and Loeper [DL] to deduce that optimal maps stay away from the cut-locus, namely,  $\partial^c \phi(x) \cap \text{Cut}(x) = \emptyset$  for all  $x \in M$ ; see [L2, DG, KM1, KM1a] for alternate approaches. Loeper [L2] combined this observation with the fact that  $c = \text{dist}^2/2$  satisfies (A3) to show regularity of optimal maps; for a simpler approach to continuity, see [KM1, KM1a]. His result has been extended to variety of positively curved manifolds including the complex projective space [KM2] and perturbation of the real projective space [LV] and of the sphere [FR, DG, FRV], all of where (A3) holds thus the strong Hölder regularity estimate of [L1] as well as the a priori estimate of [MTW] applies. Note that (A3) (resp. (A3w)) forces the sectional curvature to be positive (resp. nonnegative) [L1], though the converse does not hold [K].

On multiple products of spheres, taking  $c = \text{dist}^2/2$  leads to two main issues: first, only a degenerate strengthening of the weak Ma-Trudinger-Wang condition holds (the so-called non-negative cross-curvature condition in [KM1, KM2]), which although stronger than (A3w) is not as useful as (A3) for proving regularity due to lack of powerful estimates; (neither non-negative cross-curvature nor (A3) implies the other, though either one separately implies (A3w)). Moreover, the cut-locus now has a non-trivial structure, which makes it much more difficult to understand whether the stay-away property holds. In [FKM1] we showed strict c-convexity and  $C^1$  regularity of  $\phi$ , or equivalently, injectivity and continuity of T, when the cost is smooth and non-negative cross-curvature holds. Hence the only question left is whether  $\partial^c \phi$  avoids the cut-locus or not.

In this paper we answer this question positively: by taking advantage of the fact that the cut-locus is given by the union of certain sub-products of spheres we prove in Theorem 5.1 the stay-away property that  $\partial^c \phi(x) \cap \operatorname{Cut}(x) = \emptyset$  for all  $x \in M$ . By compactness, these two sets are separated by a uniform distance that is dependent on  $\lambda$ , but independent of the particular choice of  $\phi$  and x; see Corollary 5.2. Once stay-away property is shown, one can localize the argument of [FKM1] to obtain injectivity and continuity of the optimal map; then higher regularity  $(C^{2,\alpha}/C^{\infty})$  of  $\phi$ , thus  $C^{1,\alpha}/C^{\infty}$ -regularity of T, follows from [LTW] when the densities are smooth  $(C^{\alpha}/C^{\infty})$ ; see Corollary 5.3.

The multiple products of spheres is a model case for more general manifolds on which the cost c satisfies the necessary conditions [L1, FRV] for regularity of optimal transport maps. The method we develop in this paper demonstrates one approach to handling complex singularities

of the cost, especially the stay-away property of optimal maps. Moreover, a general Alexandrov type estimate (Lemma 4.1) is obtained which has applications beyond the products of spheres.

Our regularity result has potential relevance to statistics and statistical mechanics. For instance, recently T. Sei applied optimal transport theory for  $c = dist^2$  to directional statistics on the sphere. In his main result [S, Theorem 1], he needed the optimal map not to touch the cut-locus. Now, our stay-away property on multiple products of spheres M (Theorem 5.1) states that all optimal maps, obtained by transporting densities bounded away from zero and infinity onto each other, satisfy this assumption. Hence, this provides a large family of c-convex potentials that could be used to create log-concave likelihood functions as in [S, Subsection 3.2], extending his theory to multiple products of spheres. Namely, as a direct consequence of [KM2, FKM2, S], on multiple products of spheres a convex combination  $\phi = \sum_{i=1}^k s_i \phi_i$ ,  $s_i \geq 0, \sum s_i = 1$ , of c-convex functions  $\phi_i$  is again c-convex, thus a crucial requirement in Sei's theory is satisfied. If each  $\phi_i$  is the c-potential of an optimal map between densities bounded away from zero and infinity, by Theorem 5.1 one sees  $\partial^c \phi_i$  stay away from the cut-locus. One then can show that  $\partial^c \phi$  also avoids the cut-locus, thus applying [S, Theorem 1] one obtains the log-concave Jacobian inequality for this convex combination. To see this, for example, observe that in the product of spheres the "domain of exponential map" is convex<sup>1</sup>, and  $\partial^c \phi$  satisfies  $\partial^c \phi(x) = \exp_x \partial \phi(x) = \exp_x \left[ \sum_i s_i \partial \phi_i(x) \right]$  for  $x \in M$  (see Lemma 2.7). Since each  $\partial^c \phi_i$  stays away from the cut-locus,  $\partial \phi_i(x)$  belongs to the domain of exponential map, so does  $\partial \phi(x)$ , showing  $\partial^c \phi(x) \cap \operatorname{Cut}(x) = \emptyset$ .

Concerning statistical mechanics, let us recall that the state of a spin system is classically modeled as a point in the phase space M obtained by taking many products of spheres. In such contexts, optimal transport may provide a useful change of variables. More precisely, if  $\mu$  and  $\nu$  are two smooth densities and T denotes the optimal transport map from  $\mu$  to  $\nu$ , then

$$\int G(y) d\nu(y) = \int G(T(x)) d\mu(x),$$

for all bounded measurable functions  $G:M\to\mathbb{R}$ . Then, if  $\mu$  is a "nice" measure for which many statistical quantities are easily computable, one may hope to exploit some qualitative/quantitative properties of T in order to estimate the integral  $\int G(y) \, d\nu(y)$  by studying  $\int G(T(x)) \, d\mu(x)$ . We expect that regularity of optimal maps may play a crucial role in this direction. For instance, in Euclidean spaces this is already the case, as Caffarelli [Ca5] used regularity of optimal maps to show that suitable monotonicity and log-concavity properties of the densities imply monotonicity and contraction properties for the optimal map, from which correlation and momentum inequalities may be deduced.

Organization of the paper: Section 2 sets up the notation and assumptions used throughout the paper. In Section 3, a few useful preliminary results regarding convex sets and c-convex functions are listed. Section 4 is devoted to an Alexandrov type inequality which is one of the main tools in the proof of our main theorem. Until Section 4, we present the theory under rather general assumptions. However, from Section 5 we restrict to the multiple products of spheres. In Section 5 we state our main result about the stay-away property of optimal maps, and give a sketch of the proof. Moreover we explain how one can deduce regularity of optimal maps combining this theorem with the results in [FKM1] and [LTW]. Finally, the details of the

proof of the stay-away property are given in Section 6.

### 2 Notation and assumptions

In this section and the next we recall notation and results which will be useful in the sequel. Many of these results originated in or were inspired by the work of Ma, Trudinger, Wang [MTW] and Loeper [L1]. Though the present paper mainly concerns the Riemannian distance squared cost  $c = \operatorname{dist}^2/2$  on the product of round spheres, we will present our work in a rather general framework. It requires only a small additional effort and may prove useful for further development and applications of the theory.

Let  $M, \overline{M}$  be n-dimensional complete Riemannian manifolds, and let  $c(x, \overline{x})$  denote a cost function  $c: M \times \overline{M} \to \mathbb{R}$ . We will assume through the whole paper that c is semiconcave in both variables, i.e., in coordinate charts it can be written as the sum of a concave and a smooth function. Let us remark that since  $\operatorname{dist}^2(x,y)$  is semiconcave on  $M \times M$  (see for example [FF, Appendix B]), the above assumption is satisfied for instance by any cost function of the form  $f(\operatorname{dist}(x,y))$  on  $M \times M$ , with  $f: \mathbb{R} \to \mathbb{R}$  smooth, even, and strongly convex (meaning f(d) = f(-d) and f''(d) > 0 for all  $d \geq 0$ ). Here and in the sequel we use smooth as a synonymous of  $C^{\infty}$  (though  $C^4$  would be enough for all our purposes).

As for  $\bar{x}$  and  $\bar{M}$ , we use the "bar" notation to specify the second variable of the cost function. Also as a notation we use  $\bar{c}(\bar{x},x) := c(x,\bar{x})$ . We denote by  $D_x$  and  $D_{\bar{x}}$  the differentials with respect to the x and  $\bar{x}$  variable respectively. (For instance,  $D_x D_{\bar{x}} c(x_0, \bar{x}_0)$  denotes the mixed partial derivative of c at  $(x_0, \bar{x}_0)$ .) Let c-Cut $(\bar{x})$  denote the c-cut-locus of  $\bar{x} \in \bar{M}$ , that is

$$c\text{-Cut}(\bar{x}) := \{x \in M \mid c \text{ is not smooth in a neighborhood of } (x, \bar{x})\},\$$

and let  $M(\bar{x})$  denote the *c-injectivity locus*  $M \setminus c\text{-Cut}(\bar{x})$ . Define  $\bar{c}\text{-Cut}(x)$ ,  $\bar{M}(x)$  similarly. These sets are open.

**Assumption 2.1** (twist). For each  $(x, \bar{x}) \in M \times \bar{M}$ , the maps  $-D_x c(x, \cdot) : \bar{M}(x) \to T_x^* M$  and  $-D_{\bar{x}} c(\cdot, \bar{x}) : M(\bar{x}) \to T_{\bar{x}}^* \bar{M}$  are smooth embeddings (thus injective).

We remark that the above hypothesis from Levin [L] is equivalent to condition (A1) in [MTW, L1, KM1], which together with the semiconcavity of the cost ensures existence and uniqueness of optimal maps when the source measure is absolutely continuous with respect to the volume measure (see for instance [L, FF, F] or [V, Chapter 10]).

The domain of the c-exponential  $\bar{M}^*(\bar{x})$  in  $T_{\bar{x}}^*\bar{M}$  is defined as the image of  $M(\bar{x})$  under the map  $-D_{\bar{x}}c(x,\cdot)$ , i.e.,

$$\bar{M}^*(\bar{x}) := -D_{\bar{x}}c(M(\bar{x}), \bar{x}) \subset T_{\bar{x}}^*\bar{M}.$$

Define  $M^*(x)$  similarly.

As in [MTW, L1], we define the *c-exponential maps*  $c\text{-Exp}_x: M^*(x) \subset T_x^*M \to \bar{M}$  and  $\bar{c}\text{-Exp}_{\bar{x}}: \bar{M}^*(\bar{x}) \subset T_{\bar{x}}^*\bar{M} \to M$  as the inverse maps of  $-D_x c(x,\cdot)$  and  $-D_{\bar{x}} c(\cdot,\bar{x})$  respectively, i.e.

$$p = -D_x c(x, c\text{-Exp}_x p) \text{ for } p \in M^*(x), \qquad \bar{p} = -D_{\bar{x}} c(\bar{c}\text{-Exp}_{\bar{x}} \bar{p}, \bar{x}) \text{ for } \bar{p} \in \bar{M}^*(\bar{x}).$$

Given a set X, we denote by cl(X) its closure. Define the subdifferential of a semiconvex function  $\alpha: M \to \mathbb{R}$  at  $x \in M$  by

$$\partial \alpha(x) := \{ p \in T_x^*M \mid \alpha(\exp_x v) - \alpha(x) \ge \langle p, v \rangle + o(|v|_x) \text{ as } v \to 0 \text{ in } T_x M \}$$

(This is non-empty at every point.) Here  $\langle \cdot, \cdot \rangle$  denotes the paring of covectors and vectors.

**Assumption 2.2.** For each  $(x, \bar{x}) \in M \times \bar{M}$  the map  $c\text{-Exp}_x$  (resp.  $\bar{c}\text{-Exp}_{\bar{x}}$ ) extends to a smooth map from  $\operatorname{cl}(M^*(x))$  (resp.  $\operatorname{cl}(\bar{M}^*(\bar{x}))$ ) onto  $\bar{M}$  (resp. M). If we abuse notation to use  $c\text{-Exp}_x$ ,  $\bar{c}\text{-Exp}_{\bar{x}}$  to denote these extensions, then they satisfy

$$c-\operatorname{Exp}_{x}p = c-\operatorname{Exp}_{x}\Big(\partial_{x}\big(-c(x,c-\operatorname{Exp}_{x}p)\big)\Big), \forall p \in \operatorname{cl}(M^{*}(x));$$
$$\bar{c}-\operatorname{Exp}_{\bar{x}}\bar{p} = \bar{c}-\operatorname{Exp}_{\bar{x}}\Big(\partial_{\bar{x}}\big(-c(c-\operatorname{Exp}_{\bar{x}}\bar{p},\bar{x})\big)\Big), \forall \bar{p} \in \operatorname{cl}(\bar{M}^{*}(\bar{x})).$$

Here,  $\partial_x$ ,  $\partial_{\bar{x}}$  denote the subdifferentials with respect to the variables x,  $\bar{x}$ , respectively.

Note that the above assumptions hold for instance when  $M = \overline{M}$  and  $c = \operatorname{dist}^2/2$  (so that  $c\text{-Exp}_x$  coincides with the Riemannian exponential map  $\exp_x$ ). However, the following three assumptions are much more restrictive, and not true for  $c = \operatorname{dist}^2/2$  in general [MTW, L1, KM1, LV]. They are all crucial in this paper.

Assumption 2.3 (convexity of domains of c-exponentials). For each  $(x, \bar{x}) \in M \times \bar{M}$  the domains  $M^*(x)$ ,  $\bar{M}^*(\bar{x})$  are convex.

As shown in [FRV], the above assumption is necessary for continuity of optimal transport maps when the cost function is given by the squared distance.

A c-segment  $\{\bar{x}(t)\}_{0 \leq t \leq 1}$  with respect to x is the c-exponential image of a line segment in  $cl(M^*(x))$ , i.e.,

$$\bar{x}(t) := c \cdot \text{Exp}_{r}((1-t)p_0 + tp_1), \quad \text{for some } p_0, p_1 \in T_r^*M.$$

Define similarly a  $\bar{c}$ -segment  $\{x(t)\}_{0 \leq t \leq 1}$  with respect to  $\bar{x}$ . The notions of c- and  $\bar{c}$ -segments, due to Ma, Trudinger and Wang, induce a natural extension of the notion of convexity on sets in M,  $\bar{M}$  called c-convexity in [MTW]. Let  $U \subset M$ ,  $\bar{x} \in \bar{M}$ . The set U is said to be  $\bar{c}$ -convex with respect to  $\bar{x}$  if any two points in U are connected by a  $\bar{c}$ -segment with respect to  $\bar{x}$  entirely contained inside U. Similarly we define c-convex sets in  $\bar{M}$ . It is helpful to notice that c,  $\bar{c}$ -convex sets (with respect to x,  $\bar{x}$ , respectively) are images of convex sets under c-Exp $_x$ ,  $\bar{c}$ -Exp $_{\bar{x}}$ , respectively.

Regarding c,  $\bar{c}$ -segments, here comes a key assumption in this paper:

**Assumption 2.4 (convex DASM).** For every  $(x, \bar{x}) \in M \times \bar{M}$ , let  $\{\bar{x}(t)\}_{0 \leq t \leq 1}$ ,  $\{x(t)\}_{0 \leq t \leq 1}$  be c,  $\bar{c}$ -segments with respect to x,  $\bar{x}$ , respectively. Define the functions

$$m_t(\cdot) := -c(\cdot, \bar{x}(t)) + c(x, \bar{x}(t)), \qquad \bar{m}_t(\cdot) := -c(x(t), \cdot) + c(x(t), \cdot), \qquad 0 \le t \le 1.$$

Then

$$m_t \le (1-t)m_0 + t m_1, \qquad \bar{m}_t \le (1-t)\bar{m}_0 + t \bar{m}_1 \qquad 0 \le t \le 1.$$
 (2.1)

When, instead of (2.1), only  $m_t \leq \max[m_0, m_1]$  and  $\bar{m}_t \leq \max[\bar{m}_0, \bar{m}_1]$  are required, this property played a key role in the work of Loeper [L1]. In [KM1] we called it *Loeper's maximum principle* (**DASM**), the acronym (**DASM**) standing for "Double Mountain Above Sliding Mountain", a mnemonic which describes how the graphs of the functions  $m_t$ ,  $\bar{m}_t$  behave as t is varied. For convenience we use this acronym in various places in the present paper. The stronger property (**convex DASM**) was proved in [KM2] to be a consequence of the so-called nonnegative cross-curvature condition on the cost c.

We will also need a strict version of Loeper's maximum principle (**DASM**):

**Assumption 2.5** (DASM<sup>+</sup>). With the same notation as in Assumption 2.4,

$$m_t(y) \le \max[m_0(y), m_1(y)] \quad \forall y \in M, \qquad \bar{m}_t(\bar{y}) \le \max[\bar{m}_0(\bar{y}), \bar{m}_1(\bar{y})] \quad \forall \bar{y} \in \bar{M}.$$

Moreover, when the  $\bar{c}$ -(resp. c-)segument in the definition of  $m_t$  (resp.  $\bar{m}_t$ ) is nonconstant, the equality holds if and only if y = x (resp.  $\bar{y} = \bar{x}$ ).

Assumptions 2.4 and 2.5 correspond to a "global" version of the non-negative cross curvature assumption and of the (A3) condition of the cost function c, respectively: see [KM1] and [MTW] for the definition of nonnegative cross curvature and (A3), respectively. Although the equivalence between (convex DASM) and non-negative cross curvature (resp. (DASM<sup>+</sup>) and (A3)) is not known in general, it holds true for the squared distance cost function on a Riemannian manifold, as shown in [FV, FRV]. Moreover, Loeper's maximum principle (DASM) is a necessary condition for regularity: this is originally shown [L1] on domains in  $\mathbb{R}^n$  and later extended to the manifold case [FRV].

Given two functions  $\phi: M \to \mathbb{R}$  and  $\bar{\phi}: \bar{M} \to \mathbb{R}$ , we say that they are *c-convex* and dual with respect to each other if

$$\phi(x) = \sup_{\bar{x} \in \bar{M}} \{-c(x, \bar{x}) - \bar{\phi}(\bar{x})\},$$

$$\bar{\phi}(\bar{x}) = \sup_{x \in M} \{-c(x, \bar{x}) - \phi(x)\} = \sup_{x \in M} \{-\bar{c}(\bar{x}, x) - \phi(x)\}.$$
(2.2)

Since by assumption c is semiconcave, both functions above are semiconvex (see for instance [FF, Appendix A]). This implies in particular that their subdifferentials,  $\partial \phi(x)$ ,  $\partial \bar{\phi}(\bar{x})$  are non-empty at every point.

We define the c-subdifferential  $\partial^c \phi$  at a point x as follows:

$$\partial^{c} \phi(x) := \{ \bar{x} \in \bar{M} \mid \phi(y) - \phi(x) \ge -c(y, \bar{x}) + c(x, \bar{x}), \ \forall y \in M \}.$$
 (2.3)

Analogously, we define  $\partial^{\bar{c}}\bar{\phi}$  at every point  $\bar{x}$ . (Recall that  $\bar{c}$  denotes the function defined as  $\bar{c}(\bar{x},x):=c(x,\bar{x})$ .) The following well-known reciprocity holds:

**Lemma 2.6** (Reciprocity). For c-convex functions  $\phi$ ,  $\bar{\phi}$  dual to each other as in (2.2),

$$\bar{x} \in \partial^c \phi(x) \iff \phi(x) + \bar{\phi}(\bar{x}) = -c(x, \bar{x}) \iff x \in \partial^{\bar{c}} \bar{\phi}(\bar{x}).$$
 (2.4)

*Proof.* Suppose  $\bar{x} \in \partial^c \phi(x)$ . Then, by rearranging the inequality in (2.3) we get

$$-\phi(x) \ge c(x, \bar{x}) + \sup_{y \in M} \{-c(y, \bar{x}) - \phi(y)\},$$

and the supremum on the right hand side is exactly  $\bar{\phi}(\bar{x})$ . On the other hand, from the definition of  $\phi$  and  $\bar{\phi}$  we have

$$\bar{\phi}(\bar{y}) + c(x, \bar{y}) \ge -\phi(x) \qquad \forall \, \bar{y} \in \bar{M},$$

so that combining these two inequalities leads to  $\phi(x) + \bar{\phi}(\bar{x}) = -c(x,\bar{x})$ , and  $x \in \partial^{\bar{c}}\bar{\phi}(\bar{x})$ . The opposite implication follows by symmetry.

Loeper [L1] deduced the following fundamental relation to be a consequence of his maximum principle (**DASM**).

Lemma 2.7 (Loeper's maximum principle (DASM)). Let Assumptions 2.1, 2.2 and 2.3 hold. Suppose Loeper's maximum principle (DASM) holds. Let  $\phi$ ,  $\bar{\phi}$  be c-convex functions dual to each other as in (2.2). Then for all  $x \in M, \bar{x} \in \bar{M}$ ,

$$c\text{-Exp}_x(\partial\phi(x)) = \partial^c\phi(x), \qquad \bar{c}\text{-Exp}_{\bar{x}}(\partial\bar{\phi}(\bar{x})) = \partial^{\bar{c}}\bar{\phi}(\bar{x}).$$

*Proof.* The inclusions c- $\operatorname{Exp}_x(\partial \phi(x)) \subset \partial^c \phi(x)$ ,  $\bar{c}$ - $\operatorname{Exp}_{\bar{x}}(\partial \bar{\phi}(\bar{x})) \subset \partial^{\bar{c}} \bar{\phi}(\bar{x})$  follow from the convexity of  $\partial \phi(x)$  and the definition of *Loeper's maximum principle* (**DASM**). The other inclusions hold in general without Loeper's maximum principle. Details can be found in [L1].

In the following, we refer the conclusion of this lemma also as Loeper's maximum principle (**DASM**).

For a set  $\Omega \subset M$ , the image  $\partial^c \phi(\Omega)$  is defined as

$$\partial^c \phi(\Omega) := \bigcup_{x \in \Omega} \partial^c \phi(x).$$

For a c-convex function  $\phi$  and an open set  $U \in M$  with  $x_0 \in U$ , we define the set  $[\partial^c \phi(U)]_{x_0} \subset \bar{M}$  as

$$[\partial^c \phi(U)]_{x_0} := \{ \bar{x} \in \bar{M} \mid \phi(x) - \phi(x_0) \ge -c(x, \bar{x}) + c(x_0, \bar{x}) \text{ for all } x \in \partial U \}.$$

Trivially,  $\partial^c \phi(x_0) \subset [\partial^c \phi(U)]_{x_0}$ . This definition is justified by the following lemma, which is also very useful in later discussions.

**Lemma 2.8.** Let Assumptions 2.1, 2.2 and 2.3 hold. Suppose Loeper's maximum principle (**DASM**) holds. Let  $\phi$  be a c-convex function on M. Let  $U \subset M$  be an open set, and let  $x_0 \in U$ . Then

- (1)  $[\partial^c \phi(U)]_{x_0}$  is c-convex with respect to  $x_0$ ;
- (2)  $[\partial^c \phi(U)]_{x_0} \subset \partial^c \phi(U);$
- (3) If  $U \to \{x_0\}$ , then both  $\partial^c \phi(U)$ ,  $[\partial^c \phi(U)]_{x_0} \to \partial^c \phi(x_0)$ .

*Proof.* Assertion (1) follows directly from the definitions of Loeper's maximum principle (**DASM**) and of the set  $[\partial^c \phi(U)]_{x_0}$ .

To prove Assertion (2), fix  $\bar{x} \in [\partial^c \phi(U)]_{x_0}$ , and move first the graph of the function  $-c(\cdot, \bar{x})$  down so that it lies below  $\phi$  inside U, and then lift it up until it touches the graph of  $\phi$  inside cl(U). Thanks to the assumption  $\bar{x} \in [\partial^c \phi(U)]_{x_0}$  there exists at least one touching point x' which belongs to U (indeed, if there is a touching point on  $\partial U$ , then  $x_0$  is another touching point), and Lemma 2.7 ensures that  $\bar{x} \in \partial^c \phi(x')$ .

For (3), the convergence  $\partial^c \phi(U) \to \partial^c \phi(x_0)$  follows by continuity, and  $[\partial^c \phi(U)]_{x_0} \to \partial^c \phi(x_0)$  comes then from (2).

For  $\bar{x} \in \bar{M}$ , let  $S(\bar{x})$  be the contact set

$$S(\bar{x}) := \{ x \in M \mid \bar{x} \in \partial^c \phi(x) \} = \partial^{\bar{c}} \bar{\phi}(\bar{x}).$$

(The last identity follows from reciprocity, see Lemma 2.6.) For any  $x_0 \in S(\bar{x})$  one can write

$$S(\bar{x}) = \{ x \in M \mid \phi(x) - \phi(x_0) = -c(x, \bar{x}) + c(x_0, \bar{x}) \}.$$

A set Z in M is called a c-section of  $\phi$  with respect to  $\bar{x}$  if there is  $\lambda_{\bar{x}} \in \mathbb{R}$  such that

$$Z := \{ z \in M \mid \phi(z) \le -c(z, \bar{x}) + \lambda_{\bar{x}} \}.$$

The following simple observation is very useful for studying regularity of c-convex functions. It was originally made (implicitly) in [FKM1] and independently by Liu [Li].

**Lemma 2.9** (c-convex c-sections). Let Assumptions 2.1, 2.2 and 2.3 hold. Suppose Loeper's maximum principle (**DASM**) holds. Let  $\phi$  be a c-convex function on M, and fix  $\bar{x} \in \bar{M}$ . Every c-section Z of  $\phi$  with respect to  $\bar{x}$  is  $\bar{c}$ -convex with respect to  $\bar{x}$ .

*Proof.* This follows from the definition of c-convex functions and Loeper's maximum principle (**DASM**).

Given Borel sets  $V \subset M$  and  $\bar{V} \subset \bar{M}$ , we denote by |V| and  $|\bar{V}|$  their volume (computed with respect to the given Riemannian metric on M and  $\bar{M}$ , respectively). The following is our last assumption. As we already remarked in the introduction, it is satisfied whenever  $\phi$  is the potential associated to an optimal transport map and the densities are both bounded away from zero and infinity.

Assumption 2.10 (bounds on c-Monge-Ampère measure of  $\phi$ ). There exists  $\lambda > 0$  such that

$$\lambda |\Omega| \leq |\partial^c \phi(\Omega)| \leq \frac{1}{\lambda} |\Omega| \text{ for all Borel set } \Omega \subset M.$$

We sometimes abbreviate this condition on  $\phi$  simply by writing  $|\partial^c \phi| \in [\lambda, \frac{1}{\lambda}]$ .

### 3 Preliminary results

In this section, we list some preliminary results we require later. The first subsection deals with general convex sets and the second subsection considers the properties of the cost function under suitable assumptions.

#### 3.1 Convex sets

We first list two properties of convex sets that will be useful later.

**Lemma 3.1** (John's lemma). For a compact convex set  $S \subset \mathbb{R}^n$ , there exists an affine transformation  $L : \mathbb{R}^n \to \mathbb{R}^n$  such that  $B_1 \subset L^{-1}(S) \subset B_n$ . Here,  $B_1$  and  $B_n$  denote the ball of radius 1 and n, respectively, centered at 0.

Proof. See 
$$[J]$$
.

**Lemma 3.2.** Let S be a convex set in  $\mathbb{R}^n = \mathbb{R}^{n'} \times \mathbb{R}^{n''}$ , and denote by  $\pi', \pi''$  the canonical projections onto  $\mathbb{R}^{n'}$  and  $\mathbb{R}^{n''}$ , respectively. Let S' be a slice orthogonal to the second component, that is

$$S' = (\pi'')^{-1}(\bar{x}'') \cap S$$
 for some  $\bar{x}'' \in \pi''(S)$ .

Then there exists a constant C(n), depending only on n = n' + n'', such that

$$C(n)|S| \ge \mathscr{H}^{n'}(S')\mathscr{H}^{n''}(\pi''(S)),$$

where  $\mathscr{H}^d$  denotes the d-dimensional Hausdorff measure.

Proof. See [FKM1, Lemma 6.11].

The following lemma is important in the last step (Section 6.6) of the proof of the main

**Lemma 3.3.** Let  $X = X^1 \times ... \times X^k$ , with  $X^i = \mathbb{R}^{n_i}$ , i = 1,...,k, and write a point  $x \in X$  as  $x = (x^1,...,x^k)$ ,  $x^i \in X^i$ . For each i = 1,...,k, let  $U^i$  be a subset of  $X^i$ , and let  $s_i = (s_i^1,...,s_i^k) \in X$  with  $s_i^i \in U^i$ . Define  $S_i \subset X$  as

$$S_i := \{s_i^1\} \times \ldots \times \{s_i^{i-1}\} \times U_i \times \{s_i^{i+1}\} \times \ldots \times \{s_i^k\},$$

and consider the convex hull  $co(S_1, ..., S_k)$  of the sets  $S_1, ..., S_k$ . Then there exists a constant C(n, k), depending only on  $n := n_1 + ... + n_k$  and k, such that

$$C(n,k) | co(S_1,...,S_k)| \ge \prod_{i=1}^k \mathcal{H}^{n_i}(S^i).$$

*Proof.* First consider the barycenter b of the set  $\{s_1, \ldots, s_k\}$ , that is

$$b := \frac{1}{k}(s_1 + \ldots + s_k).$$

We will construct sets  $S_i^b$  each of which contains b and has Hausdorff measure comparable with  $S_i$ . In addition, these sets are mutually orthogonal. We will finish the proof by considering the volume of the convex hull of these sets  $S_1^b, \ldots, S_k^b$ .

For each i, let  $b_i$  be the barycenter of the set  $\{s_1, \ldots, s_k\} \setminus \{s_i\}$ , i.e.,

$$b_i := \frac{1}{k-1}(s_1 + \ldots + s_{i-1} + s_{i+1} + \ldots + s_k).$$

Consider the cone  $co(b_i, S_i) \subset co(S_1, \ldots, S_k)$  and let  $S_i^b$  be the intersection

$$S_i^b := co(b_i, S_i) \cap \{x \in X \mid x^j = b^j \text{ for } j \neq i\}.$$

Note that  $b \in S_i^b$  and these sets  $S_1^b, \ldots, S_k^b$  are mutually orthogonal, in the sense that, for each  $x \in S_i^b$  and  $y \in S_j^b$  with  $i \neq j$ , it holds  $(x - b) \cdot (y - b) = 0$ . Now, consider the convex hull  $co(S_1^b, \ldots, S_k^b) \subset co(S^1, \ldots, S_k^b)$ . The previous orthogonality implies

$$C(n) |\operatorname{co}(S_1^b, \dots, S_k^b)| \ge \prod_{i=1}^k \mathscr{H}^{n_i}(S_i^b).$$

for some constant C(n) depending only on  $n_1 + \ldots + n_k$ . (This inequality is obtained for instance by iteratively applying Lemma 3.2.) To conclude the proof simply observe that  $b = \frac{1}{k}s_i + \frac{k-1}{k}b_i$ , and so

$$\mathscr{H}^{n_i}(S_i^b) \ge \frac{1}{k^{n_i}} \mathscr{H}^{n_i}(S_i).$$

#### 3.2 Coordinate change

In this subsection we briefly recall the coordinate change introduced in [FKM1, Section 4] that transforms c-convex functions into convex functions under the condition (**convex DASM**), referring to [FKM1, Section 4] for more details. Throughout this subsection we let Assumptions 2.1, 2.2 and 2.3 hold.

Let  $\bar{y}_0$  be an arbitrary point in  $\bar{M}$ . Then the map  $x \in M(\bar{y}_0) \mapsto q \in T^*_{\bar{y}_0}\bar{M}$  given by  $q(x) = -D_{\bar{x}}c(x,\bar{y}_0)$  is an embedding thanks to Assumption 2.1. Recall that  $\bar{M}^*(\bar{y}_0) \subset T^*_{\bar{y}_0}\bar{M}$  denotes the image of this map, that this map is by definition the inverse c-exponential map  $(c\text{-Exp}_{\bar{y}_0})^{-1}$ , and the c-exponential map is a diffeomorphism up to the boundary of  $\bar{M}^*(\bar{y}_0)$  (see Assumption 2.2). Denote

$$\tilde{c}(q, \bar{x}) := c(x(q), \bar{x}) - c(x(q), \bar{y}_0).$$

Then the c-convex function  $\phi$  is transformed to a  $\tilde{c}$ -convex function  $\varphi$  defined as

$$\varphi(q) := \phi(x(q)) + c(x(q), \bar{y}_0).$$

If Loeper's maximum principle (**DASM**) holds, then Lemma 2.9 shows that  $\tilde{c}$ -sections of  $\varphi$  are convex. This property was observed independently by Liu [Li], who used it to derive an optimal Hölder exponent for optimal maps under the strict condition (**A3**) on the cost, sharpening the Hölder continuity result of Loeper [L1]. Furthermore, if (**convex DASM**) holds then  $-\tilde{c}(q,\bar{x})$  is convex in q for any  $\bar{x} \in \bar{M}$ , which then implies convexity of  $\varphi$  in q (see [FKM1, Theorem 4.3] for more details). One can easily check that  $\bar{c}$ -segments with respect to  $\bar{x}$  are transformed via this coordinate change to  $\tilde{c}$ -segments with respect to  $\bar{x}$ , and c-segments with respect to x(q) are transformed to  $\tilde{c}$ -segments with respect to q. Therefore, Loeper's maximum principle (**DASM**) or (**convex DASM**) for c implies the same for  $\tilde{c}$ .

#### 3.2.1 Relation between cotangent vectors in two different coordinates

Here we give an explicit relation between covectors in the new coordinate variable q (as introduced above) and the original coordinate variable x. Fix arbitrary  $\bar{y}_0 \in M$ ,  $x_0 \in M(\bar{y}_0)$ , and let  $q_0 = -D_{\bar{x}}c(x_0, \bar{y}_0) \in T^*_{\bar{y}_0}\bar{M}$ . For each  $\bar{z} \in \bar{M}(x_0)$ , consider the maps

$$\bar{z} \mapsto \eta(\bar{z}) := -D_x c(x_0, \bar{z}) \in T_{x_0}^* M 
\bar{z} \mapsto p(\bar{z}) := -D_q \tilde{c}(q_0, \bar{z}) \in T_{q_0}^* (T_{\bar{q}_0}^* \bar{M}).$$
(3.1)

where  $\tilde{c}(q,\bar{x}) := c(x(q),\bar{x}) - c(x(q),\bar{y}_0)$  and the variables x and q are related as  $q(x) = -D_{\bar{x}}c(x,\bar{y}_0)$ . Denote by  $M^*(x_0)$ ,  $\tilde{M}^*(q_0)$  the embedding of  $\bar{M}(x_0)$  under the mappings  $\bar{z} \mapsto \eta(\bar{z})$ ,  $\bar{z} \mapsto p(\bar{z})$ , respectively. These sets are related by an affine map as we see in the following lemma. In particular, from Assumption 2.3 both sets are convex in  $T^*_{x_0}M$ ,  $T^*_{q_0}(T^*_{\bar{y}_0}M)$ , respectively.

**Lemma 3.4.** Let Assumptions 2.1 and 2.2 hold. Let  $\eta(p)$  denote the map from  $\tilde{M}^*(q_0)$  to  $M^*(x_0)$  that associates  $p(\bar{z})$  to  $\eta(\bar{z})$  as in the relation (3.1), and let  $\eta_0 = -D_x c(x_0, \bar{y}_0) \in M^*(x_0) \subset T^*_{x_0}M$ . Fix local coordinates. Then for all  $p \in \tilde{M}^*(q_0)$ ,  $\eta(p) = (\eta(p)^1, \dots, \eta(p)^n)$  is given as

$$\eta(p)^{i} = p^{j} \left( -D_{x^{i}} D_{\bar{x}^{j}} c(x_{0}, \bar{y}_{0}) \right) + \eta_{0}^{i}.$$

This formula allows the affine function  $p \mapsto \eta(p)$  to be extended to a global map  $\eta: T_{q_0}^*(T_{\bar{y}_0}^*\bar{M}) \to T_{x_0}^*M$ .

Proof. Observe that

$$\begin{split} \eta^i &= -D_{x^i} c(x_0, \bar{z}) \\ &= D_{x^i} \big|_{x=x_0} [-c(x, \bar{z}) + c(x, \bar{y}_0) - c(x, \bar{y}_0)] \\ &= -D_{q^j} \big|_{q=q_0} [c(x(q), \bar{z}) - c(x(q), \bar{y}_0)] (D_{x^i} \big|_{x=x_0} q^j) + \eta_0^i \\ &= p^j \left( D_{x^i} \big|_{x=x_0} q^j \right) + \eta_0^i. \end{split}$$

From the relation

$$q^j = -D_{\bar{x}^j}c(x(q), \bar{y}_0)$$

we see that

$$D_{x^i}\big|_{x=x_0} q = -D_{x^i} D_{\bar{x}^j} c(x_0, \bar{y}_0),$$

and the assertion follows.

#### **3.2.2** An estimate on the first derivatives of c

In Section 6.5 we will use the following simple estimate.

**Lemma 3.5.** Given convex sets  $\Omega, \Lambda \subset \mathbb{R}^n$ , assume that the function  $(q, y) \in \Omega \times \Lambda \mapsto c(q, y) \in \mathbb{R}$  is smooth. Then for all  $q, \tilde{q} \in \Omega$  and  $y \in \Lambda$  we have

$$|-D_q c(q, y) + D_q c(\tilde{q}, y)| \le C|q - \tilde{q}| |D_q c(\tilde{q}, y)|,$$
 (3.2)

where the constant C depends only on  $\|c\|_{C^3(\Omega \times \Lambda)}$  and  $\|(D^2_{gy}c)^{-1}\|_{L^{\infty}(\Omega \times \Lambda)}$ .

#### 4 An Alexandrov estimate: lower bound

In this section we show a key Alexandrov type estimate (4.1) which bounds from below the "oscillation" of  $\phi$  inside a c-section by the measure of the section. (An estimate that compare the oscillation of the function with the measure of the section is called Alexandrov type.) This result is of its own interest, especially because it is proven under rather general assumptions, and does not rely on the special structure of products of spheres. In later sections, a companion inequality showing the upper bound will be obtained for a special choice of a c-section in the particular case of products of spheres, see Theorem 6.4.

**Lemma 4.1** (Alexandrov lower bound). Let M,  $\bar{M}$  be complete n-dimensional Riemannian manifolds. Suppose the cost  $c: M \times \bar{M} \to \mathbb{R}$  satisfies Assumptions 2.1, 2.2, 2.3 and 2.4 (convex **DASM**). Let  $\phi$  be a c-convex function on M and assume  $0 < \lambda \le |\partial^c \phi|$  for a fixed  $\lambda \in \mathbb{R}$ . Fix  $(x_0, \bar{x}_0) \in M \times \bar{M}$  such that  $\bar{x}_0 \in \partial^c \phi(x_0)$ , and for h > 0 consider the c-section  $Z_h$  defined as

$$Z_h := \{ x \in M \mid \phi(x) - \phi(x_0) \le -c(x, \bar{x}_0) + c(x_0, \bar{x}_0) + h \}.$$

Assume that  $-c(\cdot, \bar{x}_0)$  is smooth on  $Z_h$ , so that the function  $\bar{c}$ - $\operatorname{Exp}_{\bar{x}_0}^{-1}$  is defined and smooth on  $Z_h$ , or equivalently  $Z_h \subset M(\bar{x}_0)$ . Then the following inequality holds:

$$\lambda |Z_h|^2 \le C(n) \left[ \frac{\max_{x \in Z_h} |\det(-D_x D_{\bar{x}} c(x, \bar{x}_0))|}{\min_{x \in Z_h} |\det(-D_x D_{\bar{x}} c(x, \bar{x}_0))|} \right]^2 \left[ \sup_{x \in Z_h} \sup_{p' \in M^*(x)} |dc - \operatorname{Exp}_x|_{p=p'}| \right] h^n$$
(4.1)

with the constant  $C(n) = (4n)^n |B_1|^2$ , where  $|B_1|$  denotes the measure of the unit ball in  $\mathbb{R}^n$ .

**Remark 4.2.** In the statement of Lemma 4.1 and its proof, it is important to notice that by the assumption  $-c(\cdot, \bar{x}_0)$  is smooth on  $clZ_h$  and Assumptions 2.1 and 2.2, the derivatives of  $\bar{c}$ -Exp $_{\bar{x}_0}$  and its inverse (on  $Z_h$ ), i.e.,  $-D_x D_{\bar{x}} c(x, \bar{x}_0)$ ,  $x \in Z_h$ , are all nonsingular.

**Remark 4.3.** For  $c = \text{dist}^2/2$ , Loeper's maximum principle (**DASM**) (and so also (**convex DASM**)) implies that  $M = \overline{M}$  has nonnegative sectional curvature (see [L1]). Therefore in this case  $c\text{-Exp}_y$  is a contraction, that is

$$\sup_{p' \in M^*(x)} |dc - \operatorname{Exp}_x|_{p=p'}| \le 1.$$

We do not know if this contraction property holds for general non-negatively cross-curved cost functions.

Remark 4.4. As in [FKM1], for our main results we will later follow the strategy developed in [Ca1] by using renormalization techniques, but only after a suitable change of coordinates. The main feature of our Alexandrov estimate with respect to the ones in [Ca1, FKM1] is in the fact that the only "possibly bad" dependence on the cost function comes from the term  $\frac{\max_{x \in Z_h} |\det(-D_x D_{\bar{x}}c(x,\bar{x}_0))|}{\min_{x \in Z_h} |\det(-D_x D_{\bar{x}}c(x,\bar{x}_0))|}$ , which can be made as close to 1 as desired, provided one can ensure that the section  $Z_h$  converges to a point as  $h \to 0$ . This will play a crucial role in the proof of Theorem 5.1, as it will allow us to apply this estimate near points which are arbitrarily close to the cut-locus.

*Proof.* For globally smooth cost functions (on the products of two bounded domains) a similar result was proved in [FKM1, Theorem 6.4]. In the present case where the cost function has singularities, the previous proof does not work any more and we require the following subtle argument.

Consider the coordinate change  $x \in Z_h \mapsto q = -D_{\bar{x}}c(x(q), \bar{x}_0) \in \bar{W}_h \subset \bar{M}^*(\bar{x}_0) \subset T^*_{\bar{x}_0}\bar{M}$ , i.e.,  $x = c\text{-Exp}_{\bar{x}_0}q$  and  $Z_h = c\text{-Exp}_{\bar{x}_0}(\bar{W}_h)$ , and let

$$m_{\bar{x}}(\cdot) := -c(\cdot, \bar{x}) + c(\cdot, \bar{x}_0).$$

As explained in Section 3.2, in these new coordinates the functions

$$q \mapsto m_{\bar{x}}(x(q))$$
 and  $q \mapsto \varphi(q) = \phi(x(q)) + c(x(q), \bar{x}_0)$ 

are convex. Moreover the set  $\bar{W}_h$  is convex, as

$$\bar{W}_h = \{ q \in T_{\bar{x}_0}^* \bar{M} \mid \varphi(q) - \varphi(q_0) \le h \},$$

where  $q_0$  is the point corresponding to  $x_0$  in the new coordinates, i.e.,  $c\text{-Exp}_{\bar{x}_0}q_0=x_0$ . It is also important to notice that  $\bar{x}_0 \in \partial^c \phi(x_0)$  implies  $\varphi(q) - \varphi(q_0) \geq 0$ . We now use Lemma 3.1 to find an affine map  $A: T^*_{\bar{x}_0}\bar{M} \simeq \mathbb{R}^n \mapsto T^*_{\bar{x}_0}\bar{M} \simeq \mathbb{R}^n$  such that  $A(\hat{W}_h) = \bar{W}_h$ , with  $B_1 \subset \hat{W}_h \subset B_n$ . Denote  $q_b = A(0)$  and  $x_b = c\text{-Exp}_{\bar{x}_0}q_b$ . Define the renormalized function  $\hat{\varphi}(\hat{q}) := \varphi(A\hat{q})$  for each  $\hat{q} \in \hat{W}_h$ , and denote  $\frac{1}{2}\bar{W}_h := A(\frac{1}{2}\hat{W}_h)$  and  $\frac{1}{2}Z_h := \bar{c}\text{-Exp}_{\bar{x}_0}(\frac{1}{2}\bar{W}_h)$ , where  $\frac{1}{2}\hat{W}_h$  denotes the dilation of  $\hat{W}_h$  by a factor 1/2 with respect to the origin. This 1/2-dilation (or any factor in (0,1) works) will be important in this proof.

Consider the reciprocal expression

$$\partial^c \phi \left(\frac{1}{2} Z_h\right) = c - \operatorname{Exp}_{x_b} (-D_x c(x_b, \bar{x}_0) + \mathcal{V})$$

where

$$\mathcal{V} := \left\{ D_x m_{\bar{x}}(x_b) \mid \bar{x} \in \partial^c \phi\left(\frac{1}{2}Z_h\right) \right\} \subset T_{x_b}^* M.$$

Here  $D_x m_{\bar{x}}$  denotes the differential when  $m_{\bar{x}}$  is differentiable, otherwise it means an arbitrary covector in the subdifferential  $\partial m_{\bar{x}}(x)$ . Notice that  $-D_x c(x_b, \bar{x}_0) + \mathcal{V} \subset \text{cl}(M^*(x_b))$ , and thus

$$\left| \partial^c \phi \left( \frac{1}{2} Z_h \right) \right| \le \left( \sup_{p' \in M^*(x_b)} |dc \operatorname{Exp}_{x_b}|_{p=p'} | \right) |\mathcal{V}|. \tag{4.2}$$

Now, the left-hand side is bounded from below as

$$\left| \partial^{c} \phi \left( \frac{1}{2} Z_{h} \right) \right| \geq \lambda \left| \frac{1}{2} Z_{h} \right| \qquad \text{(by the assumption } |\partial^{c} \phi| \geq \lambda)$$

$$\geq \lambda \left[ \min_{w \in W_{h}} |\det(d\bar{c} \operatorname{Exp}_{\bar{x}_{0}}|_{q=w})| \right] \left( \frac{1}{2} \right)^{n} |W_{h}| \qquad \text{(by } \frac{1}{2} Z_{h} = \bar{c} \operatorname{Exp}_{\bar{x}_{0}} \left( \frac{1}{2} W_{h} \right))$$

$$\geq \lambda \frac{\min_{w \in W_{h}} |\det(d\bar{c} \operatorname{Exp}_{\bar{x}_{0}}|_{q=w})|}{\max_{w \in W_{h}} |\det(d\bar{c} \operatorname{Exp}_{\bar{x}_{0}}|_{q=w})|} \left( \frac{1}{2} \right)^{n} |Z_{h}|$$

$$\geq \lambda \frac{\min_{x \in Z_{h}} |\det(-D_{x}D_{\bar{x}}c(x,\bar{x}_{0}))|}{\max_{x \in Z_{h}} |\det(-D_{x}D_{\bar{x}}c(x,\bar{x}_{0}))|} \left( \frac{1}{2} \right)^{n} |Z_{h}| \qquad \text{(by } D_{\bar{x}}c(\cdot,\bar{x}_{0}) = \bar{c} \operatorname{Exp}_{\bar{x}_{0}}^{-1}).$$

$$(4.3)$$

In the following we will bound  $|\mathcal{V}|$  from above by

$$\frac{\max_{x \in Z_h} |\det(-D_x D_{\bar{x}} c(x, \bar{x}_0))|}{\min_{x \in Z_h} |\det(-D_x D_{\bar{x}} c(x, \bar{x}_0))|} \frac{h^n}{|Z_h|},$$

which will finish the proof; here the dilation  $\frac{1}{2}Z_h$  plays a crucial role (see (4.5)). Fix  $\bar{x} \in \partial^c \phi(\frac{1}{2}Z_h)$ , and let  $\hat{q}_{\bar{x}} \in \frac{1}{2}\hat{W}_h$  such that  $\bar{x} \in \partial^{\hat{c}}\hat{\varphi}(\hat{q}_{\bar{x}})$ . Here, the cost function  $\hat{c}$  is the modified cost function accordingly with the coordinate changes:

$$\hat{c}(\hat{q}, \bar{y}) := c(\bar{c} \operatorname{-Exp}_{\bar{x}_0}(A\hat{q}), \bar{y}) - c(\bar{c} \operatorname{-Exp}_{\bar{x}_0}(A\hat{q}), \bar{x}_0).$$

Consider the function

$$\hat{m}_{\bar{x}}(\hat{q}) := m_{\bar{x}}(\bar{c} - \operatorname{Exp}_{\bar{x}_0}(A\hat{q})) = -\hat{c}(\hat{q}, \bar{x}).$$
 (4.4)

Then

$$\hat{m}_{\bar{x}}(\hat{q}) - \hat{m}_{\bar{x}}(\hat{q}_{\bar{x}}) + \hat{\varphi}(\hat{q}_{\bar{x}}) \le \hat{\varphi}(\hat{q}) \quad \text{for } \hat{q} \in \hat{W}_h.$$

We observe that  $\hat{m}_{\bar{x}}(\cdot) - \hat{m}_{\bar{x}}(\hat{q}_{\bar{x}})$  is a convex function on  $\hat{W}_h$  which vanishes at  $\hat{q}_{\bar{x}} \in \frac{1}{2}\hat{W}_h$ , and  $\hat{m}_{\bar{x}}(\cdot) - \hat{m}_{\bar{x}}(\hat{q}_{\bar{x}}) \leq h$  on  $\partial \hat{W}_h$ . Since  $B_1 \subset \hat{W}_h \subset B_n$  this easily gives  $\hat{m}_{\bar{x}}(0) - \hat{m}_{\bar{x}}(\hat{q}_{\bar{x}}) \geq -h$ , which by convexity implies

$$|D_{\hat{g}}\hat{m}_{\bar{x}}(0)| \le 2h. \tag{4.5}$$

To get information on  $D_x m_{\bar{x}}$ , observe that from (4.4)

$$(d\bar{c}-\text{Exp}_{\bar{x}_0}|_{a=a_b}A)^*D_x m_{\bar{x}}(x_b) = D_{\hat{q}}\hat{m}_{\bar{x}}(0), \tag{4.6}$$

where  $(d\bar{c}\text{-}\mathrm{Exp}_{\bar{x}_0}\big|_{q=q_b}A)^*: T^*_{x_b}M \mapsto T^*_0(T^*_{\bar{x}_0}\bar{M})$  is the dual map of the derivative map  $d\bar{c}\text{-}\mathrm{Exp}_{\bar{x}_0}A: T_0(T^*_{\bar{x}_0}\bar{M}) \mapsto T_{x_b}M$ . Here we abuse the notation and A denotes both the affine map and its derivative. Moreover we use the canonical identification  $T^*_0(T^*_{\bar{x}_0}\bar{M}) \approx T_0(T^*_{\bar{x}_0}\bar{M}) \approx T^*_{\bar{x}_0}\bar{M}$ . Hence (4.5) and (4.6) imply the key inclusion

$$\mathcal{V} \subset \left( dc \text{-} \operatorname{Exp}_{\bar{x}_0} \Big|_{q=q_b}^* \right)^{-1} (A^*)^{-1} B_{2h},$$

so that

$$\begin{split} |\mathcal{V}| &\leq \left| \det(d\bar{c} - \operatorname{Exp}_{\bar{x}_0} \big|_{q=q_b}^*)^{-1} \right| \left| \det(A^*)^{-1} \big| |B_1| 2^n h^n \\ &= \left| \det(d\bar{c} - \operatorname{Exp}_{\bar{x}_0} \big|_{q=q_0}) \right|^{-1} \left| \det A \right|^{-1} |B_1| 2^n h^n \\ & \text{(by the identification between vectors and covectors)} \\ &\leq \left| \det(d\bar{c} - \operatorname{Exp}_{\bar{x}_0} \big|_{q=q_0}) \right|^{-1} |B_1|^2 (2n)^n \frac{h^n}{|W_h|} \quad \text{(by } |W_h| = |\det A| |\hat{W}_h| \leq |\det A| |B_1| n^n) \\ &\leq \frac{\max_{w \in W_h} \left| \det(d\bar{c} - \operatorname{Exp}_{\bar{x}_0} \big|_{q=w}) \right|}{\left| \det(d\bar{c} - \operatorname{Exp}_{\bar{x}_0} \big|_{q=w}) \right|} |B_1|^2 (2n)^n \frac{h^n}{|Z_h|} \\ & \text{(by } |Z_h| \leq \max_{w \in W_h} \left| \det(d\bar{c} - \operatorname{Exp}_{\bar{x}_0} \big|_{q=w}) ||W_h| \right.) \\ &\leq \frac{\max_{x \in Z_h} \left| \det(-D_x D_{\bar{x}} c(x, \bar{x}_0)|) \right|}{\min_{x \in Z_h} \left| \det(-D_x D_{\bar{x}} c(x, \bar{x}_0)) \right|} |B_1|^2 (2n)^n \frac{h^n}{|Z_h|} \quad \text{(by } D_{\bar{x}} c(\cdot, \bar{x}_0) = \bar{c} - \operatorname{Exp}_{\bar{x}_0}^{-1}). \end{split}$$

Together with (4.2) and (4.3), this concludes the proof.

# 5 Main result: Stay-away property on multiple products of spheres

From now on we restrict our attention to the case  $M = \bar{M} = M^1 \times \ldots \times M^k$ , where for each  $i = 1, \ldots, k$ ,  $M^i = \mathbb{S}_{r_i}^{n_i}$  is a round sphere of constant sectional curvature  $r_i^{-2}$ . Though  $M = \bar{M}$ , we sometimes keep the bar notation to emphasize the distinction between the source and the target domain of the transportation. Let  $x = (x^1, \ldots, x^k)$  and  $\bar{x} = (\bar{x}^1, \ldots, \bar{x}^k)$  denote points in the product  $M^1 \times \ldots \times M^k$ , with  $x^i, \bar{x}^i \in M^i$ ,  $i = 1, \ldots, k$ . Assume that the transportation cost c on M is the tensor product of the costs  $c^i$  on each  $M^i$ , defined as

$$c(x,\bar{x}) := \sum_{i=1}^{k} c^{i}(x^{i},\bar{x}^{i}). \tag{5.1}$$

Assume moreover that each  $c^i$  is of the form  $f^i(\operatorname{dist}_i)$  ( $\operatorname{dist}_i$  being the distance on  $M^i$ ) for some smooth strongly convex even function  $f^i:\mathbb{R}\to\mathbb{R}$ , normalized so that  $f^i(0)=0$ . (This normalization assumption can be done with no loss of generality, as one can always add an arbitrary constant to the cost function.) Moreover we suppose that each  $c^i$  satisfies Assumptions 2.1, 2.2, 2.3, 2.4 and 2.5 in Section 2. As shown in [KM2], under these assumptions the tensor product cost c also satisfies Assumptions 2.1, 2.2, 2.3 and 2.4 (but not necessarily 2.5). The reader should have in mind that our model example is  $c = \operatorname{dist}^2/2$ , which as shown in [KM2] satisfies all the assumptions above. However we prefer to give a proof of the result with general  $f^i$  since this will not cost further effort in the proof, and we believe it may be of interest for future applications.

Let us observe that for any point  $\bar{x}$  we have  $M(\bar{x}) = M^1(\bar{x}^1) \times \ldots \times M^k(\bar{x}^k)$  and  $\bar{M}^*(\bar{x}) = \bar{M}^*(\bar{x}^1) \times \ldots \times \bar{M}^*(\bar{x}^k)$ . Moreover, since the distance squared function on a round sphere is smooth except for antipodal pairs, for each  $x^i \in M^i$  we have  $\mathrm{Cut}(x^i) = \{-x^i\}$ , where  $-x^i$  denotes the antipodal point of  $x^i$ . (We also write  $-x = (-x^1, \cdots, -x^k)$ .) This implies easily that  $c\text{-Cut}(x) = \mathrm{Cut}(x)$ , so that  $M^i(x^i) = M^i \setminus \{-x^i\}$  and c-Cut(x) is a union of (totally geodesic) submanifolds, each of which is an embedding of a product  $M^{i_1} \times \ldots \times M^{i_l}$ , l < k.

The goal of the rest of the paper is to show a stay-away property of optimal transport maps on products of spheres:

Theorem 5.1 (Stay-away from cut-locus). Let  $M = \overline{M} = M^1 \times ... \times M^k$ , where for each i = 1, ..., k,  $M^i = \mathbb{S}_{r_i}^{n_i}$  is a round sphere of constant sectional curvature  $r_i^{-2}$ . Let c be the cost given in (5.1) with  $c^i$  is of the form  $f^i(\operatorname{dist}_i)$ , where  $f^i : \mathbb{R} \to \mathbb{R}$  are smooth strongly convex even functions such that  $f^i(0) = 0$ . Assume further that each cost  $c^i$  satisfies Assumptions 2.1, 2.2, 2.3, 2.4 and 2.5, and let  $\phi$  be a c-convex function satisfying Assumption 2.10. Then

$$\partial^c \phi(x) \cap c\text{-Cut}(x) = \emptyset \qquad \forall x \in M.$$

Equivalently, for every  $\bar{x} \in \bar{M}$  the contact set  $S(\bar{x}) = \partial^{\bar{c}} \bar{\phi}(\bar{x})$  satisfies

$$S(\bar{x}) \cap \bar{c}\text{-Cut}(\bar{x}) = \emptyset.$$

Before sketching the proof of this result, let us first see its consequences:

Corollary 5.2 (Uniformly stay-away from cut-locus). Use the notation and assumptions as in Theorem 5.1. There exists a positive constant C depending only on  $\lambda$  (see Assumption 2.10) and  $n_i$ ,  $r_i$ ,  $f^i$ , for  $i = 1, \dots, k$ , such that

$$\operatorname{dist}\left(\partial^{c}\phi(x), c\text{-}\operatorname{Cut}(x)\right) \geq C \qquad \forall x \in M.$$

where dist denotes the Riemannian distance of M.

*Proof.* The result follows by compactness. Indeed, suppose by contradiction there exists a sequence of c-convex functions  $\phi_l$  satisfying Assumption 2.10, and  $x_l \in M$  such that

$$\operatorname{dist}\left(\partial^{c}\phi_{l}(x_{l}), c\text{-}\operatorname{Cut}(x_{l})\right) \to 0$$
 as  $l \to \infty$ .

Up to adding a constant, we can also assume that  $\phi_l(x_l) = 0$ . Then, since M is compact and the functions  $\phi_l$  are uniformly semiconvex (and so uniformly Lipschitz), applying Arzelà-Ascoli's Theorem, up to a subsequence there exists a c-convex function  $\phi_{\infty}$  and  $x_{\infty} \in M$  such that  $\phi_l \to \phi_{\infty}$  uniformly and  $x_l \to x_{\infty}$ . We now observe that also  $\phi_{\infty}$  satisfies Assumption 2.10 (see for instance [FKM1, Lemma 3.1]). Moreover, by the definition of c-subdifferential we easily obtain

$$y_l \in \partial^c \phi_l(x_l), \quad y_l \to y_\infty \quad \Rightarrow \quad y_\infty \in \partial^c \phi_\infty(x_\infty).$$

This implies

$$\operatorname{dist}\left(\partial^c \phi_{\infty}(x_{\infty}), c\text{-}\operatorname{Cut}(x_{\infty})\right) = 0,$$

which contradicts Theorem 5.1, and completes the proof.

Corollary 5.3 (Regularity of optimal maps). Let  $M, \overline{M}, c$  be as in Theorem 5.1. Assume that  $\mu$  and  $\nu$  are two probability measures absolutely continuous with respect to the volume measure, and whose densities are bounded away from zero and infinity. Then the unique optimal map T from  $\mu$  to  $\nu$  is injective and continuous. Furthermore, if both densities are  $C^{\alpha}/C^{\infty}$ , then T is  $C^{1,\alpha}/C^{\infty}$ .

**Remark 5.4.** The  $C^{1,\alpha}$ -regularity result ( $C^{2,\alpha}$  for the potential  $\phi$ ) in this corollary is a direct consequence of the injectivity and continuity of T applied to the theory of Liu, Trudinger and Wang [LTW]. The higher regularity  $C^{\infty}$  follows from Schauder estimates.

Proof. We recall that, under the assumption that  $\mu$  and  $\nu$  have densities bounded away from zero and infinity, there exists a c-convex function  $\phi$  such that  $T(x) = c \cdot \operatorname{Exp}_x(\nabla \phi(x))$  a.e., and  $\phi$  satisfies Assumption 2.10 (see for instance [MTW] or [FKM1, Lemma 3.1]). Hence it suffices to prove that  $\phi$  is  $C^1$  and strictly c-convex, in the sense that  $S(\bar{x}) = \partial^{\bar{c}} \bar{\phi}(\bar{x})$  is a singleton for every  $\bar{x} \in \partial^c \phi(M) = M$ .

To this aim, we observe that once we know that  $\phi$  is strictly c-convex, then we can localize the proof of the  $C^1$  regularity in [FKM1] to obtain the desired result. Thus we only need to show the strict c-convexity of  $\phi$ .

Fix  $\bar{x} \in M$ . By Theorem 5.1 we know that  $S(\bar{x}) \subset M(\bar{x})$ , so that in a neighborhood of  $S(\bar{x})$  we can consider the change of coordinates  $x \mapsto q = -\bar{D}c(x,\bar{x}) \in T^*_{\bar{x}}\bar{M}$ . As shown in [FKM1, Theorem 4.3], thanks to Loeper's maximum principle (**DASM**) the set  $S(\bar{x})$  is convex in these coordinates. Moreover, since now the cost is smooth in a neighborhood of  $S(\bar{x})$ , by [FKM1, Theorem 7.1 and Remark 7.2] the compact convex set  $S(\bar{x})$  in the new coordinates has no exposed points on the support of  $|\partial^c \phi|$ . Since in our case the support of  $|\partial^c \phi|$  is the whole M, the only possibility left is that  $S(\bar{x})$  is a singleton, as desired.

Sketch of the proof of Theorem 5.1. We prove this theorem by contradiction. Assume there exists a point  $\bar{x}_0$  such that the contact set  $S(\bar{x}_0)$  intersects  $Cut(\bar{x}_0)$ . First, we find a *cut-exposed* point  $x_0$  in  $S(\bar{x}_0) \cap \text{Cut}(\bar{x}_0)$ . More precisely we split M as  $M' \times M''$  so that  $\bar{x}_0 = (\bar{x}_0, \bar{x}_0)$ ,  $x_0 = (x_0, x_0)$ , where  $x_0 = -\bar{x}_0 \in \text{Cut}(\bar{x}_0)$ ,  $x_0$  stays away from the cut-locus of  $\bar{x}_0$ , and  $x_0$  is an exposed point in the set  $S^{\cdot \cdot} = \{y^{\cdot \cdot} \in M^{\cdot \cdot} \mid (-\bar{x}_0, y^{\cdot \cdot}) \in S(\bar{x}_0)\}$  (see Section 6.1). Near  $\bar{x}_0$ , for  $\varepsilon \in (0,1)$  and  $\delta \in [0,1]$  we construct a family of points  $\bar{x}_{\varepsilon,\delta} = (\bar{x}_{\varepsilon}, \bar{x}_{\delta})$  such that  $d(\bar{x}_0, \bar{x}_{\varepsilon,\delta}) \approx \varepsilon + \delta$ , so that for  $\delta$  small we have  $\bar{x}_{\varepsilon,\delta} \in \bar{M}^*(x_0)$ , or equivalently  $x_0 \in M^*(\bar{x}_{\varepsilon,\delta})$ . By suitably choosing the point  $\bar{x}_{\delta}$  in order to exploit the fact that  $x_0$  is an exposed point for S, we can ensure that, if  $Z_{\varepsilon,\delta,h}$  denotes a section obtained by cutting the graph  $\phi$  with  $-c(\cdot,\bar{x}_{\varepsilon,\delta})$  at height h above  $x_0$ , then for any fixed  $\varepsilon \in (0,1)$  we have  $Z_{\varepsilon,\delta,h} \to \{x_0\}$  as  $\delta, \frac{h}{\delta} \to 0$  (see Section 6.2). In particular, for  $\varepsilon > 0$  fixed we have  $Z_{\varepsilon,\delta,h} \subset M^*(\bar{x}_{\varepsilon,\delta})$  for  $\delta, \frac{h}{\delta}$  small (equivalently, the function  $c(\cdot, \bar{x}_{\varepsilon,\delta})$  is smooth inside  $Z_{\varepsilon,\delta,h}$ ). Now we take advantage of the choice of  $\bar{x}_{\varepsilon}$ : on the sphere  $\mathbb{S}^n$  the function  $-\operatorname{dist}^2(\cdot,\bar{x})$  looks like a cone near the antipodal point  $-\bar{x}$ , and if  $\operatorname{dist}(\bar{x},\bar{x}_{\varepsilon})\approx\varepsilon$  then the measure of a section obtained by cutting the graph of  $-\operatorname{dist}^2(\cdot,\bar{x})$  with  $-\operatorname{dist}^2(\cdot,\bar{x}_{\varepsilon})$  at height h above  $-\bar{x}$  has measure  $\approx h^n/\varepsilon$  (see Proposition 6.7). In our case, since  $x_0 = -\bar{x}_0$ , the function  $\phi$  behaves as  $-c(\cdot,\bar{x}_0) \approx -\operatorname{dist}(\cdot,\bar{x}_0)$  along M (see Lemma 6.6). Hence by the argument above we have an improvement of a factor  $1/\varepsilon$  in the measure of  $Z_{\varepsilon,\delta,h}$  (see Proposition 6.7), which allows to show the following Alexandrov type inequality:

$$h^{\dim M} \lesssim \varepsilon |Z_{\varepsilon,\delta,h}| |\partial^c \phi(Z_{\varepsilon,\delta,h})| \qquad \text{for $\delta$ and $\frac{h}{\delta}$ sufficiently small,}$$

where  $\lesssim$  is independent of  $\varepsilon$ ,  $\delta$  and h (see Theorem 6.4)<sup>3</sup>. Thanks to Assumption 2.10, the above

<sup>&</sup>lt;sup>3</sup>Although this is the informal idea, the actual proof is much more involved. In particular, for technical reasons, we will also need to split M as  $M' \times M''$  so that  $\partial^c \phi(x_0) \cap \left( \{ -x_0' \} \times M'' \right) \neq \emptyset$  (M' corresponds to the "cut-locus components") and  $\partial^c \phi(x_0) \cap \left( M' \times \{ -x_0'' \} \right) = \emptyset$  (M'' corresponds to the "regular components"), see Section 6.1. Observe that  $M' \subset M'$ . Then, to prove Theorem 6.4, a different argument has to be used depending on the kind of components, see Sections 6.4 and 6.5 respectively.




Figure 1: On the sphere, the squared distance function from a point  $\bar{x}$  looks like a cone near  $-\bar{x}$ . So, if  $\operatorname{dist}(\bar{x}, \bar{x}_{\varepsilon}) = \operatorname{dist}(-\bar{x}, -\bar{x}_{\varepsilon}) \approx \varepsilon$ , the section obtained by cutting its graph with  $-\operatorname{dist}^2(\cdot, \bar{x}_{\varepsilon})$  at height h has measure  $\approx h^n/\varepsilon$ .

inequality implies

$$h^{\dim M} \lesssim \frac{\varepsilon}{\lambda} |Z_{\varepsilon,\delta,h}|^2$$
 for  $\delta$  and  $\frac{h}{\delta}$  sufficiently small. (5.2)

On the other hand, since  $Z_{\varepsilon,\delta,h} \subset M^*(\bar{x}_{\varepsilon,\delta})$  for  $\delta$  and  $\frac{h}{\delta}$  small enough, we can apply Lemma 4.1 to  $Z_{\varepsilon,\delta,h}$  and have

$$\lambda |Z_{\varepsilon,\delta,h}|^2 \leq C(n) \left[ \frac{\max_{x \in Z_{\varepsilon,\delta,h}} |\det(-D_x D_{\bar{x}} c(x,\bar{x}_{\varepsilon,\delta})|}{\min_{x \in Z_{\varepsilon,\delta,h}} |\det(-D_x D_{\bar{x}} c(x,\bar{x}_{\varepsilon,\delta}))|} \right]^2 \left[ \sup_{x \in Z_{\varepsilon,\delta,h}} \sup_{p' \in M^*(x)} |dc \cdot \operatorname{Exp}_x|_{p=p'}| \right] h^{\dim M}.$$

The convergence  $Z_{\varepsilon,\delta,h} \to \{x_0\}$  as  $\delta, \frac{h}{\delta} \to 0$  further reduces this inequality to

$$\lambda |Z_{\varepsilon,\delta,h}|^2 \lesssim h^{\dim M}$$
 for  $\delta$  and  $\frac{h}{\delta}$  sufficiently small,

which contradicts (5.2) as  $\varepsilon \to 0$  and completes the proof.

The rest of the paper is devoted to fleshing out the details of the above proof.

### 6 Proof of Theorem 5.1 (Stay-away from cut-locus)

#### 6.1 Cut-exposed points of contact sets

Assume by contradiction that there exists  $\bar{x}_0 = (\bar{x}_0^1, \dots, \bar{x}_0^k) \in \bar{M} = M = M^1 \times \dots \times M^k$  such that  $S(\bar{x}_0) \cap c\text{-Cut}(\bar{x}_0) \neq \emptyset$ . To prove Theorem 5.1 a first step is to find a *cut-exposed point* of the contact set in the intersection with the cut-locus, which we define throughout the present section.

Let  $y \in S(\bar{x}_0) \cap c\text{-Cut}(\bar{x}_0)$ , and note that one of the components of  $y = (y^1, \dots, y^k)$ , say  $y^j$ , satisfies  $y^j = -\bar{x}_0^j$ . Moreover we cannot have  $y = -\bar{x}_0$ . Indeed it is not difficult to see that, if  $\bar{x}_0 \in \partial^c \phi(-\bar{x}_0)$ , then  $\partial^c \phi(-\bar{x}_0) = M$  (see for instance Lemma 6.6(1) below), which contradicts Assumption 2.10.

Among all points  $y \in S(\bar{x}_0) \cap c\text{-Cut}(\bar{x}_0)$ , choose one such that the number  $a_0$  of its antipodal (or *cut-locus*) components is maximal, and denote the point by  $y_0$ . By rearranging the product  $M^1 \times \ldots \times M^k$ , we may write without loss of generality that

$$y_0 = (-\bar{x}_0^1, \dots, -\bar{x}_0^{a_0}, y_0^{a_0+1}, \dots, y_0^k), \qquad y_0^j \notin c\text{-Cut}(\bar{x}_0^j) \quad \forall j = a_0 + 1, \dots, k.$$
 (6.1)

For convenience, use the expression

$$M^{\cdot} = \bar{M}^{\cdot} = M^1 \times \ldots \times M^{a_0}, \qquad M^{\cdot \cdot} = \bar{M}^{\cdot \cdot} = M^{a_0+1} \times \ldots \times M^k.$$

The expressions  $A^{\cdot}$ ,  $A^{\cdot \cdot}$  will be used to denote things defined for elements in  $M^{\cdot}$ ,  $M^{\cdot \cdot}$ , respectively. For example,

$$y' = (y^{1}, \dots, y^{a_{0}}), \qquad y'' = (y^{a_{0}+1}, \dots, y^{k}),$$

$$c'(y', \bar{y}') = \sum_{i=1}^{a_{0}} c^{i}(y^{i}, \bar{y}^{i}), \qquad c''(y'', \bar{y}'') = \sum_{i=a_{0}+1}^{k} c^{i}(y^{i}, \bar{y}^{i}).$$

Consider the set

$$S^{\cdot \cdot} = \{ y^{\cdot \cdot} \in M^{\cdot \cdot} \mid (-\bar{x}_0, y^{\cdot \cdot}) \in S(\bar{x}_0) \}.$$

Notice that due to maximality of  $a_0, S^{\cdot \cdot} \subset M^{\cdot \cdot}(\bar{x}_0^{\cdot \cdot})$  and it is embedded to  $\bar{M}^{\cdot \cdot *}(\bar{x}_0^{\cdot \cdot})$  through the map  $y^{\cdot \cdot} \mapsto q^{\cdot \cdot}(y^{\cdot \cdot}) = -D_{\bar{x}^{\cdot \cdot}}c^{\cdot \cdot}(y^{\cdot \cdot}, \bar{x}_0^{\cdot})$ . Observe that since  $S^{\cdot \cdot}$  is compact, the resulting set, say  $\tilde{S}^{\cdot \cdot}$ , is compact too. Moreover  $\tilde{S}^{\cdot \cdot}$  is convex since it is the restriction of the convex set  $\tilde{S}(\bar{x}_0)$  to  $M^{\cdot \cdot *}(\bar{x}_0^{\cdot \cdot})$ , where  $\tilde{S}(\bar{x}_0)$  is the image of  $S(\bar{x}_0)$  under the map  $x \mapsto -D_{\bar{x}}c(x,\bar{x}_0)$ . (More precisely, this set  $\tilde{S}(\bar{x}_0)$  is defined as the closure of the image of  $S(\bar{x}_0) \setminus c$ -Cut $(\bar{x}_0)$ .) This compact convexity ensures the existence of an exposed point  $q_0^{\cdot \cdot}$  for  $\tilde{S}^{\cdot \cdot}$ , that is, there exists an affine function L on  $T_{\bar{x}_0^{\cdot \cdot}}\bar{M}^{\cdot \cdot}$  such that

$$L(q_0^{\cdot \cdot}) = 0$$
, and  $L(q^{\cdot \cdot}) < 0 \quad \forall q^{\cdot \cdot} \in \tilde{S}^{\cdot \cdot} \setminus \{q_0^{\cdot \cdot}\}.$  (6.2)

(In case  $\tilde{S}^{\cdots} = \{q_0^{\cdots}\}\$  let  $L \equiv 0$ .) One should note that if L is such an affine function, then tL is also such an affine function for any t > 0. Let  $x_0 \in S(\bar{x}_0)$  be the corresponding point of  $q_0^{\cdots}$  in M, that is,

$$x_0 = (-\bar{x}_0, x_0), \tag{6.3}$$

where

$$q_0^{\cdot \cdot} = -D_{\bar{x}^{\cdot \cdot}}c^{\cdot \cdot}(x_0^{\cdot \cdot}, \bar{x}_0^{\cdot \cdot}).$$

We call this point  $x_0$  a *cut-exposed* point of  $S(\bar{x}_0)$ , since its components are either cut-locus type or exposed.

One can assume with a further rearrangement of the product  $M^{\cdot \cdot} = M^{a_0+1} \times \ldots \times M^k$  that there exists  $b_0 \in \{a_0, \ldots, k\}$  with the following two properties:

1. For each  $i_1 \in \{a_0 + 1, \dots, b_0\}$ , there exists  $\bar{y}_{i_1} \in \partial^c \phi(x_0)$  with

$$\bar{y}_{i_1}^{i_1} = -x_0^{i_1}. (6.4)$$

2. For every  $\bar{y} \in \partial^c \phi(x_0)$ ,

$$\bar{y}^j \neq -x_0^j$$
 (or equivalently  $\bar{y}^j \notin \bar{c}\text{-Cut}(x_0^j) = \text{Cut}(x_0^j)$ ) for  $j = b_0 + 1, \dots, k$ . (6.5)

(If 
$$b_0 = a_0$$
,  $\{a_0 + 1, \dots, b_0\} = \emptyset$ .)




Figure 2: Starting from a point  $y_0 \in S(\bar{x}_0)$  such that the number of its antipodal (or *cut-locus*) components is maximal, we choose  $x_0 = (y_0^{\cdot}, x_0^{\cdot \cdot}) = (-\bar{x}_0^{\cdot}, x_0^{\cdot \cdot}) \in M^{\cdot} \times M^{\cdot \cdot} = M$  so that  $x_0^{\cdot \cdot}$  is an exposed point for  $S^{\cdot \cdot \cdot}$  (in some suitable system of coordinates).

After this rearrangement, define

$$M' = \bar{M}' = M^1 \times ... \times M^{b_0}$$
  $M'' = \bar{M}'' = M^{b_0 + 1} \times ... \times M^k$ 

The expressions A', A'' will be used to denote things defined for elements in M', M'', respectively. For example,

$$y = (y', y''), \quad \bar{y} = (\bar{y}', \bar{y}'') \in M = M' \times M'' = \bar{M}' \times \bar{M}'',$$
  
 $c(y, \bar{y}) = c'(y', \bar{y}') + c''(y'', \bar{y}''),$ 

and we have the identification

$$T_{\bar{x}_0}^* \bar{M} = T_{\bar{x}_0'}^* \bar{M}' \times T_{\bar{x}_0''}^{**} \bar{M}'', \qquad \bar{M}^*(\bar{x}_0) = \bar{M}'^*(\bar{x}_0') \times \bar{M}''^*(\bar{x}_0'').$$

In the following  $n' = \dim M'$ ,  $n'' = \dim M''$  and  $\pi'$ ,  $\pi''$  denote the canonical projections from M to M', M'', respectively. This splitting of M as  $M' \times M''$  will be important later, as in the proof of Theorem 6.4 we will need different arguments on M' and M'' respectively, see Sections 6.4 and 6.5.

#### 6.2 Analysis near the cut-exposed point

In this subsection we construct a family of c-sections  $Z_{\varepsilon,\delta,h}$  of  $\phi$  near the cut-exposed point  $x_0$  defined in (6.3). Regarding these c-sections, two important results (Proposition 6.2 and 6.3) are obtained. In later subsections we will show an Alexandrov type inequality for  $Z_{\varepsilon,\delta,h}$  which will be paired with the other Alexandrov type inequality (4.1) to lead a contradiction to the existence of such  $x_0$ , thus finishing the proof of Theorem 5.1.

Recall the affine function L on  $T^*_{\bar{x}_0^{\cdots}}\bar{M}^{\cdots}$  given in (6.2). After modifying L by multiplying it by an appropriate positive constant, there exists a geodesic curve  $[0,1]\ni \delta\mapsto \bar{x}_\delta^{\cdots}\in \bar{M}^{\cdots}(x_0^{\cdots})$  starting from  $\bar{x}_0^{\cdots}$  such that for the linear map  $\nabla L$  on  $T^*_{\bar{x}^{\cdots}}\bar{M}^{\cdots}$ ,

$$\nabla L(q^{\cdot \cdot} - q_0^{\cdot \cdot}) = \langle \frac{\partial}{\partial t} \Big|_{t=0} \bar{x}_t^{\cdot \cdot}, q^{\cdot \cdot} - q_0^{\cdot \cdot} \rangle. \tag{6.6}$$

Consider a c-segment  $[0,1] \ni \varepsilon \to \bar{x}_{\varepsilon} \in \bar{M}$  with respect to  $x_0$  connecting the point  $\bar{x}_0$  to its antipodal point  $\bar{x}_{1/2} = x_0$  then to  $\bar{x}_1 = \bar{x}_0$ .  $(\bar{x}_{\varepsilon} \text{ is nothing else than a closed geodesic starting from } \bar{x}_0$  and passing through  $x_0 = -\bar{x}_0$  at  $\varepsilon = 1/2$ .) Define

$$\bar{x}_{\varepsilon,\delta} := (\bar{x}_{\varepsilon}, \bar{x}_{\delta}) \in M = M \times M. \tag{6.7}$$

Obviously  $\bar{x}_{0,0} = \bar{x}_0$ . Two important properties follow:

(a) Since  $\bar{x}_{\varepsilon} \in \bar{M}^{\cdot}(x_{0})$  for  $\varepsilon \in (0,1)$  and  $\bar{x}_{0} \in \bar{M}^{\cdot}(x_{0})$  we have

$$x_0 \in M(\bar{x}_{\varepsilon,\delta}) = M^{\cdot}(\bar{x}_{\varepsilon}) \times M^{\cdot\cdot}(\bar{x}_{\delta}) \qquad \forall \, 0 < \varepsilon < 1, \, \delta \geq 0 \text{ small.}$$

(b) Since  $\bar{x}_{\varepsilon,\delta} = \bar{x}_{\varepsilon} \neq \bar{x}_{0}$  for  $\varepsilon \in (0,1)$ ,  $\bar{x}_{1} = \bar{x}_{0}$ , and  $\bar{x}_{0} = -x_{0}$ , for every  $\varepsilon \in (0,1)$  and  $\delta \in [0,1]$  we have from Assumption 2.5 for each  $c^{i}$ ,

$$-c^{\cdot}(x^{\cdot}, \bar{x}_{\varepsilon, \delta}^{\cdot}) + c^{\cdot}(x_{0}^{\cdot}, \bar{x}_{\varepsilon, \delta}^{\cdot}) \leq -c^{\cdot}(x^{\cdot}, \bar{x}_{0}^{\cdot}) + c^{\cdot}(x_{0}^{\cdot}, \bar{x}_{0}^{\cdot}) \qquad \forall x^{\cdot} \in M^{\cdot}, \tag{6.8}$$

with equality only when  $x = x_0$ . (See for instance Lemma 6.5 below.)

Consider now the c-section  $Z_{\varepsilon,\delta,h}$  obtained by cutting the graph of  $\phi$  by the graph of  $-c(\cdot, \bar{x}_{\varepsilon,\delta}) + c(x_0, \bar{x}_{\varepsilon,\delta}) + h$ , that is

$$Z_{\varepsilon,\delta,h} := \{ x \in M \mid \phi(x) - \phi(x_0) + c(x, \bar{x}_{\varepsilon,\delta}) - c(x_0, \bar{x}_{\varepsilon,\delta}) \le h \}.$$

$$(6.9)$$

As it can be easily seen by moving down the graph of  $-c(\cdot, \bar{x}_{\varepsilon,\delta})$  and lift it up until it touches the graph of  $\phi$ ,  $\bar{x}_{\varepsilon,\delta} \in \partial \phi(Z_{\varepsilon,\delta,h})$ . Hence, thanks to Loeper's maximum principle (**DASM**) we have

$$\bar{x}_{\varepsilon,\delta} \in \partial^c \phi(Z_{\varepsilon,\delta,h}).$$
 (6.10)

**Proposition 6.1.** The following equality holds.

$$Z_{\varepsilon,0,0} = S(\bar{x}_{\varepsilon,0}) = S(\bar{x}_0) \cap (\{x_0\} \times M^{\cdot \cdot}). \tag{6.11}$$

Proof. From (6.8),

$$\begin{aligned} \phi(x) - \phi(x_0) + c(x, \bar{x}_{\varepsilon,0}) - c(x_0, \bar{x}_{\varepsilon,0}) \\ &= \phi(x) - \phi(x_0) + c'(x', \bar{x}_{\varepsilon,0}') - c'(x_0', \bar{x}_{\varepsilon,0}') + c''(x'', \bar{x}_0'') - c''(x_0'', \bar{x}_0'') \\ &\geq \phi(x) - \phi(x_0) + c'(x', \bar{x}_0') - c'(x_0', \bar{x}_0') + c''(x'', \bar{x}_0'') - c''(x_0'', \bar{x}_0'') \\ &= \phi(x) - \phi(x_0) + c(x, \bar{x}_0) - c(x_0, \bar{x}_0) \geq 0. \end{aligned}$$

This, together with the equality case for (6.8), yields (6.11).

The following two propositions are essential in our proof of Theorem 5.1.

Our first result shows that, for fixed  $\varepsilon$ , the sections  $Z_{\varepsilon,\delta,h}$  converge to the point  $x_0$  (in the sense of Kuratowski) as  $\delta, \frac{h}{\delta} \to 0$ .

**Proposition 6.2.** Fix  $0 < \varepsilon < 1$ . Then, for any sequences  $\delta_i, h_i \to 0$  with  $\frac{h_i}{\delta_i} \to 0$ , we have

$$Z_{\varepsilon,\delta_i,h_i} \to \{x_0\} \text{ as } i \to \infty.$$

*Proof.* Fix arbitrary sequences  $\delta_i, \frac{h_i}{\delta_i} \to 0$ , and denote

$$Z_{\infty} = \lim_{i \to \infty} Z_{\varepsilon, \delta_i, h_i} = \{ z_{\infty} \in M \mid \text{there exists a sequence } z_i \in Z_{\varepsilon, \delta_i, h_i} \text{ with } z_i \to z_{\infty} \in M \}.$$

By continuity,  $z_{\infty} \in Z_{\varepsilon,0,0}$  for each  $z_{\infty} \in Z_{\infty}$ , and thus by (6.11)  $z_{\infty} = x_0$ .

To show  $z_{\infty}^{\cdot \cdot} = x_0^{\cdot \cdot}$ , we first let  $\delta > 0$  be sufficiently small and fix a small (closed) neighborhood, say U, of  $x_0$  so that all the derivatives (up to the second order) of the function  $U \times [0,1] \ni (x,t) \to c(x, \bar{x}_{\varepsilon,t\delta})$  are uniformly bounded. Then, for  $x \in Z_{\varepsilon,\delta,h} \cap U$  the following inequalities hold:

$$h \geq \phi(x) - \phi(x_{0}) + c'(x', \bar{x}_{\varepsilon}) - c'(x_{0}', \bar{x}_{\varepsilon}) + c''(x'', \bar{x}_{\delta}) - c''(x_{0}', \bar{x}_{\delta}')$$

$$\geq -c'(x', \bar{x}_{0}') + c'(x_{0}', \bar{x}_{0}') - c''(x'', \bar{x}_{0}') + c''(x_{0}', \bar{x}_{0}')$$

$$+ c'(x', \bar{x}_{\varepsilon}) - c'(x_{0}', \bar{x}_{\varepsilon}) + c''(x'', \bar{x}_{\delta}') - c''(x_{0}', \bar{x}_{\delta}') \qquad \text{(since } \bar{x}_{0} \in \partial^{c}\phi(x_{0}))$$

$$\geq -c''(x'', \bar{x}_{0}'') + c''(x_{0}', \bar{x}_{0}'') + c''(x'', \bar{x}_{\delta}'') - c''(x_{0}', \bar{x}_{\delta}'') \qquad \text{(by (6.8))}$$

$$\geq \langle D_{\bar{x}}c''(x'', \bar{x}_{0}'') - D_{\bar{x}}c''(x_{0}'', \bar{x}_{0}''), \frac{\partial}{\partial t} \Big|_{t=0} \bar{x}_{t\delta} \rangle + O(\delta^{2})$$

$$= \delta \nabla L(D_{\bar{x}}c''(x'', \bar{x}_{0}'') - D_{\bar{x}}c''(x_{0}'', \bar{x}_{0}'')) + O(\delta^{2}) \qquad \text{(by (6.6))}$$

Use the coordinate  $q''(x'') = -D_{\bar{x}''}c''(x'',\bar{x}_0'')$  to rewrite this as

$$\nabla L(q^{\cdot \cdot} - q_0^{\cdot \cdot}) \ge -\frac{h}{\delta} - O(\delta).$$

Since  $L(q_0^{\cdot \cdot}) = 0$  this gives

$$L(q^{\cdot \cdot} - q_0^{\cdot \cdot}) \ge -\frac{h}{\delta} - O(\delta).$$

Consider now the sequences  $\delta_i$ ,  $\frac{h_i}{\delta_i} \to 0$ , and any convergent subsequence of  $z_i \in Z_{\varepsilon,\delta_i,h_i} \cap U$ . For the limit  $z_{\infty}$ , let  $q^{\cdot \cdot} = -D_{\bar{x}^{\cdot \cdot}}c(z_{\infty}^{\cdot \cdot}, \bar{x}_0^{\cdot})$ . Then  $q_{\infty}^{\cdot \cdot} \in \tilde{S}^{\cdot \cdot}$  (since  $z_{\infty} \in Z_{\varepsilon,0,0} \subset S(\bar{x}_0)$  by (6.11)), and from the above inequality we get

$$L(q_{\infty}^{"} - q_{0}^{"}) \ge 0$$

which forces  $q_{\infty}^{\cdot \cdot} = q_0^{\cdot \cdot}$  by (6.2). This shows  $z_{\infty}^{\cdot \cdot} = x_0^{\cdot \cdot}$ , and thus  $Z_{\infty} \cap U = \{x_0\}$ . To finish the proof notice that each  $Z_{\varepsilon,\delta,h}$  is connected, and so is the limit  $Z_{\infty}$ . (This connectivity can be seen by noticing that the set  $Z_{\varepsilon,\delta,h}$  is convex in the coordinates  $q(x) = -D_{\bar{x}}c(x,\bar{x}_{\varepsilon,\delta}) \in T_{\bar{x}_{\varepsilon,\delta}}^*\bar{M}$ .) Therefore  $Z_{\infty} = \{x_0\}$ , as desired.

**Proposition 6.3.** There exists  $\delta_0 = \delta_0(\varepsilon) > 0$  such that, if  $0 \le \delta \le \delta_0$ ,  $0 \le h \le \delta^2$ , then for each  $\bar{y} = (\bar{y}', \bar{y}'') \in \partial^c \phi(Z_{\varepsilon,\delta,h})$  the component  $\bar{y}''$  stays away from the cut-locus of the component z'' of z (i.e.,  $\bar{y}'' \in \bar{M}''(z'')$ ) for every  $z \in Z_{\varepsilon,\delta,h}$ . Equivalently  $\bar{\pi}''(\partial^c \phi(Z_{\varepsilon,\delta,h})) \subset \bigcap_{z \in Z_{\varepsilon,\delta,h}} \bar{M}''(z'')$ .

Proof. Suppose the statement is false along some sequence  $\delta_i, h_i \to 0$  with  $h_i \leq \delta_i^2$ , and let  $x_i, z_i \in Z_{\varepsilon,\delta,h}, \ \bar{y}_i \in \partial^c \phi(x_i)$  be such that  $\bar{y}_i'' \in \operatorname{Cut}(z_i'')$ . Since  $Z_{\varepsilon,\delta_i,h_i} \to \{x_0\}$ , both  $x_i, z_i \to x_0$ . Moreover if  $\bar{y}_{\infty}$  is a cluster point for  $\{\bar{y}_i\}_{i\in\mathbb{N}}$ , then  $\bar{y}_{\infty} \in \partial^c \phi(x_0)$  and  $\bar{y}_{\infty}'' \in \operatorname{Cut}(x_0'')$ . This contradicts the choice of M'' (see (6.5)) and concludes the proof.

#### 6.3 An Alexandrov type estimate near the cut-exposed point

We state the main theorem to be proved in the rest of the paper.

Theorem 6.4 (Alexandrov upper bound near cut-exposed point). Fix  $0 < \varepsilon < 1$ , and let  $Z_{\varepsilon,\delta,h}$  be as in (6.9). There exists  $\delta_1 = \delta_1(\varepsilon) > 0$  so that, if  $0 < \delta \leq \delta_1$ , then there exists  $h_1 = h_1(\varepsilon,\delta)$  such that

$$h^{\dim M} \lesssim \varepsilon^{a_0} |Z_{\varepsilon,\delta,h}| |\partial^c \phi(Z_{\varepsilon,\delta,h})| \qquad \forall \, 0 < h \le h_1(\varepsilon,\delta), \tag{6.12}$$

where  $\lesssim$  is independent of  $\varepsilon$ ,  $\delta$  and h.

This result concludes the proof of Theorem 5.1, since for  $\varepsilon > 0$  small enough and  $\delta, \frac{h}{\delta} \to 0$  we have  $Z_{\varepsilon,\delta,h} \to \{x_0\}$  (by Proposition 6.2), and (6.12) is in contradiction with (4.1).

The following subsections are devoted to the proof of Theorem 6.4, that we divide into three parts. First, in Section 6.4 we get Alexandrov type estimates for the sets obtained by the intersection of  $Z_{\varepsilon,\delta,h}$  with the cut-locus components of  $x_0$ . In Section 6.5, we analyze the projection  $\pi''(Z_{\varepsilon,\delta,h})$  of  $Z_{\varepsilon,\delta,h}$  onto the regular component M'' of  $x_0$ . We construct a suitable convex set, say  $\tilde{C}$ , which has size comparable to the image  $\partial^c \phi(Z_{\varepsilon,\delta,h})$ , and we get a version of the estimate (6.12) involving  $\tilde{C}$  and  $\pi''(Z_{\varepsilon,\delta,h})$  (see Proposition 6.8(3)). Finally in Section 6.6 we combine these results and conclude the proof.

# 6.4 Proof of Theorem 6.4 (Alexandrov upper bound near cut-exposed point): analysis in the cut-locus component M'

The main result of this section is Proposition 6.7 that gives an Alexandrov type estimate for the intersection of  $Z_{\varepsilon,\delta,h}$  with the cut-locus components of  $x_0$ .

We start with a few elementary results.

**Lemma 6.5.** Let  $\mathbb{S}^n$  be the standard round sphere, and  $c(x, \bar{x}) = f(\operatorname{dist}(x, \bar{x}))$  for  $(x, \bar{x}) \in \mathbb{S}^n \times \mathbb{S}^n$ , where f is a smooth strictly increasing function  $f : \mathbb{R}_+ \to \mathbb{R}_+$ . Assume that c satisfies Assumption 2.5 (**DASM**<sup>+</sup>). Then, for every  $x, \bar{x} \in \mathbb{S}^n$ ,

$$-c(-\bar{x},\bar{y}) + c(-\bar{x},\bar{x}) \ge -c(x,\bar{y}) + c(x,\bar{x}) \qquad \forall \, \bar{y} \in \mathbb{S}^n,$$

where  $-\bar{x}$  denotes the antipodal point of  $\bar{x}$ . Moreover equality holds if and only if  $\bar{y} = \bar{x}$ .

Proof. For any  $x, \bar{x} \in \mathbb{S}^n$ , one can find a c-segment x(s) with respect to  $\bar{x}$  such that  $x(0) = x(1) = -\bar{x}$  and  $x(s_0) = x$  for some  $s_0 \in [0, 1]$ . The inequality (together with the characterization of the equality case) then follows from  $(\mathbf{DASM}^+)$  for the function  $\bar{m}_s(\cdot) = -c(x(s), \cdot) + c(x(s), \bar{x})$ .  $\square$ 

For each  $1 \leq i \leq k$  and  $z \in M$ , let  $M_z^i$  denote the *i*-th slice of M through z, that is

$$M_z^i := \{x \in M \mid x^j = z^j \text{ for } j \neq i\}.$$

The following lemma generalizes the fact that on  $M = \overline{M} = \mathbb{S}^n$  with  $c = \operatorname{dist}^2/2$ , if  $x \in \mathbb{S}^n$  and  $-x \in \partial^c \phi(x)$ , then  $\partial^c \phi(x) = \mathbb{S}^n$ .

**Lemma 6.6.** Let  $M, \bar{M}, c$  be as in Theorem 5.1. Let  $\phi$  be a c-convex function on M. Fix  $z = (z^1, \ldots, z^k) \in M = M^1 \times \ldots \times M^k$  and an open set U with  $z \in U$ . Fix  $i \in \{1, \ldots, k\}$ , and let  $\bar{z} \in M$  with  $\bar{z}^i = -z^i$ . The following holds:

- (1) If  $\bar{z} \in [\partial^c \phi(U)]_z$  (resp.  $\bar{z} \in \partial^c \phi(z)$ ), then  $M_{\bar{z}}^i \subset [\partial^c \phi(U)]_z$  (resp.  $M_{\bar{z}}^i \subset \partial^c \phi(z)$ ).
- (2) Suppose  $\bar{z} \in \partial^c \phi(z)$ . Then, for each  $x \in M_z^i$ ,  $\phi(x) \phi(z) = -c^i(x^i, -z^i) + c^i(z^i, -z^i)$ .

*Proof.* To prove (1) it is enough to observe that for  $\bar{x} \in M_{\bar{z}}^i$  and  $x \in M$ ,

$$-c(x,\bar{x}) + c(z,\bar{x})$$

$$= -c^{i}(x^{i},\bar{x}^{i}) + c(z^{i},\bar{x}^{i}) + \sum_{j\neq i} \left[ -c^{j}(x^{j},\bar{z}^{j}) + c^{j}(x^{j},\bar{z}^{j}) \right]$$

$$\leq -c^{i}(x^{i},-z^{i}) + c(z^{i},-z^{i}) + \sum_{j\neq i} \left[ -c^{j}(x^{j},\bar{z}^{j}) + c^{j}(z^{j},\bar{z}^{j}) \right] \qquad \text{(by Lemma 6.5)}$$

$$= -c(x,\bar{z}) + c(z,\bar{z}) \qquad \text{(since } \bar{z}^{i} = -z^{i}\text{)}.$$

The last line is bounded from above by  $\phi(x) - \phi(z)$  either if  $x \in \partial U$  or  $\bar{z} \in \partial^c \phi(z)$ .

Let us prove the (2). Suppose  $\bar{z} \in \partial^c \phi(z)$ . By duality (Lemma 2.6),  $z \in \partial^{\bar{c}} \bar{\phi}(\bar{z})$  for the dual  $\bar{c}$ -convex function  $\bar{\phi}$ . Applying (1) to  $\bar{\phi}$  we get  $M_z^i \in \partial^{\bar{c}} \bar{\phi}(\bar{z})$ , or equivalently  $M_z^i \subset S(\bar{z})$ . Therefore for all  $x \in M_z^i$  we have

$$\phi(x) - \phi(z) = -c(x, \bar{z}) + c(z, \bar{z})$$
  
=  $-c^{i}(x^{i}, -z^{i}) + c^{i}(z^{i}, -z^{i})$  (since  $x^{j} = z^{j}$  for  $j \neq i$ )

which concludes the proof.

Let  $i \in \{1, ..., b_0\}$ , i.e.,  $M^i$  is a component of M'. Recall that  $x_0$  is the cut-exposed point defined in (6.3). By definition of  $b_0$  in (6.4) and (6.5), there exists  $\bar{y}_i \in \partial^c \phi(x_0)$  such that  $\bar{y}_i^i = -x_0^i$ . (If  $i \leq a_0$  then one can choose  $\bar{y}_i = \bar{x}_0$ .) Let  $Z_{\varepsilon,\delta,h}^i := \pi^i(Z_{\varepsilon,\delta,h} \cap M_{x_0}^i)$  for the canonical projection  $\pi^i: M \to M^i$ . Then Lemma 6.6(2) implies

$$Z_{\varepsilon,\delta,h}^{i} = \{ x^{i} \in M^{i} \mid -c^{i}(x^{i}, -x_{0}^{i}) + c^{i}(x_{0}^{i}, -x_{0}^{i}) + c^{i}(x^{i}, \bar{x}_{\varepsilon,\delta}^{i}) - c^{i}(x_{0}^{i}, \bar{x}_{\varepsilon,\delta}^{i}) \le h \}.$$
 (6.13)

Here comes the main result of this section.

**Proposition 6.7.** There exist  $\delta_2 = \delta_2(\varepsilon) > 0$  such that, if  $0 < \delta \le \delta_2$ , then there exists  $h_2 = h_2(\varepsilon, \delta)$  such that the set  $Z^i_{\varepsilon, \delta, h}$  satisfies the following estimates for  $0 < h \le h_2$ :

$$\begin{split} h^{\dim M^i} &\lesssim \varepsilon |Z^i_{\varepsilon,\delta,h}| \qquad \text{if } 1 \leq i \leq a_0, \\ h^{\dim M^i} &\lesssim |Z^i_{\varepsilon,\delta,h}| \qquad \text{if } a_0 + 1 \leq i \leq b_0, \end{split}$$

where  $\lesssim$  is independent of  $\varepsilon$ ,  $\delta$  and h and  $|Z_{\varepsilon,\delta,h}^i|$  denotes the Riemannian volume in the submanifold  $M^i$ .

*Proof.* From (6.13) and Lemma 6.5 we have  $Z^i_{\varepsilon,\delta,h} \to \{x^i_0\}$  as  $h \to 0$ . Thus for sufficiently small h we can embed  $Z^i_{\varepsilon,\delta,h}$  into  $\in T^*_{x^i_0}M^i$  by  $x^i \mapsto q^i(x^i) = -D_{\bar{x}^i}c^i(x^i,x^i_0)$ . Let  $W^i_h$  be its image. Then

$$|W_h^i| \leq \left(\max_{x^i \in Z_{\varepsilon,\delta,h}^i} \left| -D_{x^i} D_{\bar{x}^i} c^i(x^i, x_0^i) \right| \right) |Z_{\varepsilon,\delta,h}^i| \lesssim |Z_{\varepsilon,\delta,h}^i|$$

for h sufficiently small. In the following we bound  $|W_h^i|$  from below.

Without loss of generality, assume  $M^i$  is the unit sphere. Let  $q_0^i = q^i(x_0^i)$ . By abuse of notation use  $c^i(q^i, \bar{x}^i)$  to denote  $c^i(x^i(q^i), \bar{x}^i)$ , and renormalize this cost function as

$$c_h^i(q^i, \bar{x}^i) = \frac{1}{h} \left[ c^i(hq^i + q_0^i, \bar{x}^i) - c^i(q_0^i, \bar{x}^i) \right]$$

Then (6.13) implies  $W_h^i = h\hat{W}_h^i + q_0^i$ , where

$$\hat{W}_h^i := \{q^i \in T_{x_0^i}^*M^i \mid \ -c_h^i(q^i, -x_0^i) + c_h^i(q^i, \bar{x}_{\varepsilon, \delta}^i) \leq 1\}$$

Recall  $c^i = f^i(\text{dist}_i)$  for some smooth nonnegative uniformly convex function  $f^i : \mathbb{R}_+ \to \mathbb{R}_+$  such that  $f^i(0) = 0$ ,  $\frac{df^i}{dt}(0) = 0$ . Thus, as  $h \to 0$  the renormalized cost  $-c_h^i(q^i, -x_0^i)$  converges to the conical function

$$q^i \mapsto \frac{df^i}{dt}(\pi)|q^i|, \text{ for } q^i \in T^*_{x_0^i}M^i.$$

(Here, we used  $\operatorname{dist}_i(x_0^i, -x_0^i) = \pi$ .)

Case I: If  $1 \le i \le a_0$ , then  $\bar{x}_{\varepsilon,\delta}^i = \bar{x}_{\varepsilon}^{i}$ , and so  $c_h^i(q,\bar{x}_{\varepsilon,\delta}^i)$  converges to the linear function

$$q^i \mapsto D_q c^i(q_0^i, \bar{x}_{\varepsilon}^{i}) \cdot q^i$$

where

$$|D_q c^i(q_0^i, \bar{x}_{\varepsilon}^{\cdot i})| = \frac{df^i}{dt} (\pi - 2\pi\varepsilon) \ge \frac{df^i}{dt} (\pi) - C\varepsilon$$

for some constant C > 0. (Here, we used  $\operatorname{dist}(x_0^i, \bar{x}_{\varepsilon}^{i}) = \pi - 2\pi\varepsilon$ .) Therefore in the limit  $h \to 0$  one can easily check that




Figure 3: If  $1 \le i \le a_0$  then  $-x_0^i = \bar{x}_0^i$  and  $\mathrm{dist}_i(-x_0^i, \bar{x}_{\varepsilon,\delta}^i) \approx \varepsilon$ , so the size of the section is of order  $1/\varepsilon$  (see also Figure 1). On the other hand, if  $a_0 < i \le b_0$  then  $-x_0^i \ne \bar{x}_0^i$ , which implies that  $\mathrm{dist}_i(-x_0^i, \bar{x}_{\varepsilon,\delta}^i)$  is uniformly bounded away from 0, and the size of the section is of order 1.

$$\lim_{h \to 0} |\hat{W}_h^i| \gtrsim \frac{1}{\varepsilon},$$

and thus for h > 0 sufficiently small

$$|W_h^i| = h^{\dim M^i} |\hat{W}_h^i| \gtrsim \frac{h^{\dim M^i}}{\varepsilon}.$$

Case II: If  $a_0 < i \le b_0$ , then  $\bar{x}^i_{\varepsilon,\delta} = \bar{x}^{\cdot \cdot i}_{\delta}$ . Similarly as for the above case,  $c^i_h(q,\bar{x}^i_{\varepsilon,\delta})$  converges to the linear function

$$q^i \mapsto D_q c^i(q_0^i, \bar{x}_\delta^{\cdot \cdot i}) \cdot q^i.$$

Since  $\bar{x}_{\delta}^{\cdot \cdot} \in \bar{M}^{\cdot \cdot}(x_0^{\cdot \cdot})$  for  $\delta > 0$  small enough, there exist positive constants  $C, C_0$  such that

$$|D_q c^i(q_0^i, \bar{x}_\delta^{i})| \le \frac{df^i}{dt} (\pi - C) \le \frac{df^i}{dt} (\pi) - C_0,$$

where for the last inequality we used the uniform convexity of f. From this one can check that  $\lim_{h\to 0} |\hat{W}_h^i| \gtrsim 1$ , and thus for sufficiently small h>0

$$|W_h^i| \gtrsim h^{\dim M^i}$$
.

This concludes the proof.

# 6.5 Proof of Theorem 6.4 (Alexandrov upper bound near cut-exposed point): analysis in the regular component M''

The main result of this subsection is Proposition 6.8. Fix  $0 < \varepsilon < 1$ , and assume that  $\delta$  and  $\frac{h}{\delta}$  are sufficiently small so that, as in Proposition 6.3, the set  $Z_{\varepsilon,\delta,h}$  is close to the cut-exposed point  $x_0$ , and so in particular  $Z_{\varepsilon,\delta,h} \subset M(\bar{x}_{\varepsilon,\delta})$ . Consider the change of coordinates  $q \in T^*_{\bar{x}_{\varepsilon,\delta}} \bar{M} \mapsto x(q) \in M(\bar{x}_{\varepsilon,\delta})$  induced by the relation

$$q = -D_{\bar{x}}c(x(q), \bar{x}_{\varepsilon,\delta}), \tag{6.14}$$

and let  $\tilde{Z}_{\varepsilon,\delta,h} \in T^*_{\bar{x}_{\varepsilon,\delta}}\bar{M}$  be the set  $Z_{\varepsilon,\delta,h}$  in this chart. The function  $\phi$  and the cost c are transformed to

$$\varphi(q) = \phi(x(q)) + c(x(q), \bar{x}_{\varepsilon,\delta}),$$

and

$$\tilde{c}(q,\bar{y}) = c(x(q),\bar{y}) - c(x(q),\bar{x}_{\varepsilon,\delta}) \quad \text{for } (q,\bar{y}) \in T^*_{\bar{x}_{\varepsilon,\delta}} \bar{M} \times \bar{M}.$$

Notice that

$$\tilde{c}(q, \bar{x}_{\varepsilon,\delta}) \equiv 0,$$

and  $\varphi$  is a  $\tilde{c}$ -convex function on  $T^*_{\bar{x}_{\varepsilon,\delta}}\bar{M}$ . Moreover

$$\tilde{Z}_{\varepsilon,\delta,h} = \{ q \in T^*_{\bar{x}_{\varepsilon,\delta}} \bar{M} \mid \varphi(q) - \varphi(q_0) \le h \}$$

where  $q_0$  is the point corresponding to  $x_0$  in this new chart. It is important to recall that, thanks to Assumption 2.4 (**convex DASM**),  $\tilde{c}$  and  $\varphi$  are convex. (See Section 3.2)

We have the natural decomposition (with obvious notation)

$$q = (q', q'') = (-D_{\bar{x}'}c'(x'(q'), \bar{x}'_{\varepsilon,\delta}), -D_{\bar{x}''}c''(x''(q''), \bar{x}''_{\varepsilon,\delta}))$$

$$\in T^*_{\bar{x}_{\varepsilon,\delta}}\bar{M} = T^*_{\bar{x}'_{\varepsilon,\delta}}\bar{M}' \times T^*_{\bar{x}''_{\varepsilon,\delta}}\bar{M}''.$$
(6.15)

(Here, one should keep in mind that, by the definition of  $\bar{x}_{\varepsilon,\delta}$ , the component  $\bar{x}''_{\varepsilon,\delta}$  in M'' does not depend on  $\varepsilon$ .) The modified cost  $\tilde{c}(q,\bar{y})$  has the decomposition

$$\tilde{c}(q,\bar{y}) = \tilde{c}'(q',\bar{y}') + \tilde{c}''(q'',\bar{y}'')$$

where

$$\tilde{c}'(q',\bar{y}') = c'(x'(q'),\bar{y}') - c'(x'(q'),\bar{x}'_{\varepsilon,\delta}) \qquad \text{for } q' \in T^*_{\bar{x}',\varepsilon}\bar{M}',$$

and

$$\tilde{c}''(q'', \bar{y}'') = c'(x''(q''), \bar{y}'') - c''(x''(q''), \bar{x}_{\varepsilon,\delta}'')$$
 for  $q'' \in T_{\bar{x}_{\varepsilon,\delta}'}^* \bar{M}''$ .

Let  $\tilde{\pi}', \tilde{\pi}''$  denote the canonical projection from  $T^*_{\bar{x}_{\varepsilon,\delta}}\bar{M}$  onto  $T^*_{\bar{x}'_{\varepsilon,\delta}}\bar{M}'$  and  $T^*_{\bar{x}''_{\varepsilon,\delta}}\bar{M}''$ , respectively.

Now, let us construct a convex set  $\tilde{C} \subset T_{q_0}^*(T_{\bar{x}_{\varepsilon,\delta}}^*\bar{M})$  that we will use later to estimate  $|\partial^c \phi(Z_{\varepsilon,\delta,h})|$  from below (see Proposition 6.9). The strategy of the proof follows the lines of the one of [FKM1, Proposition 6.10].

**Proposition 6.8.** Fix  $0 < \varepsilon < 1$ , and assume that  $0 < \delta \le \delta_0$  and  $0 < h \le \delta^2$ , with  $\delta_0$  as in Proposition 6.3. Then there exists a convex set  $\tilde{C} \in T_{q_0}^*(T_{\bar{x}_{\varepsilon,\delta}}^*\bar{M})$  satisfying the following properties:

- $(1) \ \ \tilde{C} \subset \{0\} \times T^*_{q''_0}(T^*_{\bar{x}''_{\varepsilon,\delta}}\bar{M}'') \subset T^*_{q'_0}(T^*_{\bar{x}'_{\varepsilon,\delta}}\bar{M}') \times T^*_{q''_0}(T^*_{\bar{x}''_{\varepsilon,\delta}}\bar{M}'');$
- (2)  $\tilde{c}$ -Exp<sub>q0</sub> $\tilde{C} = \{\bar{z} \in M | -\partial_q \tilde{c}(q_0, \bar{z}) \cap \tilde{C} \neq \emptyset\} \subset [\partial^c \phi(Z_{\varepsilon, \delta, h})]_{x_0} \subset \partial^c \phi(Z_{\varepsilon, \delta, h}), \text{ where } \partial_q \text{ denotes the subdifferential with respect to } q \text{ variable;}$
- (3)  $\mathcal{H}^{n''}(\tilde{C})\mathcal{H}^{n''}(\tilde{\pi}''(\tilde{Z}_{\varepsilon,\delta,h})) \gtrsim h^{n''}$ , where  $\gtrsim$  is independent of  $h, \delta, \varepsilon$ .

*Proof.* In the following, we first construct such a set  $\tilde{C}$  and then we show the desired properties. The set  $\tilde{C}$  will be given as a convex hull of certain covectors  $\hat{p}_1, \ldots, \hat{p}_{n''}$ , see (6.22). We go through several steps.

First we find some auxiliary covectors  $p_1, \ldots, p_{n''}$ . From Lemma 3.1 applied to the convex set  $\tilde{\pi}''(\tilde{Z}_{\varepsilon,\delta,h})$ , there is an ellipsoid  $\tilde{E}$  such that

$$\tilde{E} \subset \tilde{\pi}''(\tilde{Z}_{\varepsilon,\delta,h}) \subset n''\tilde{E}$$
 (6.16)

where the scaling  $n''\tilde{E}$  is with respect to the barycenter of the ellipsoid. Let  $p_i''$ ,  $1 \leq i \leq n''$ , denote the unit orthogonal covectors parallel to the axes of the ellipsoid  $\tilde{E}$ , and denote by  $a_i$  the length of the *i*-th principal axis of  $\tilde{E}$ . Find hyperplanes  $\Pi_i'' \subset T_{\bar{x}_i'',\delta}^* \bar{M}''$  that are orthogonal to  $p_i''$  and touch tangentially the boundary of  $\tilde{\pi}''(\tilde{Z}_{\varepsilon,\delta,h})$  at points  $q_i''$ ,  $1 \leq i \leq n''$ . Let  $q_0''$  be the point in  $T_{\bar{x}_{\varepsilon,\delta}''}^* \bar{M}''$  corresponding to  $x_0$ , and denote by  $\ell_i$  the distance from  $q_0''$  to  $\Pi_i''$ . Then, thanks to (6.16) we have

$$\prod_{i}^{n''} \ell_{i} \leq \prod_{i}^{n''} (2n''a_{i}) \lesssim \mathscr{H}^{n''}(\tilde{\pi}''(\tilde{Z}_{\varepsilon,\delta,h})). \tag{6.17}$$

For each  $q_i''$ , there exists  $q_i' \in T_{\bar{x}_{\varepsilon,\delta}}^* \bar{M}'$  such that the hyperplane  $\Pi_i := T_{\bar{x}_{\varepsilon,\delta}}^* \bar{M}' \times \Pi_i'' \subset T_{\bar{x}_{\varepsilon,\delta}}^* \bar{M}$  tangentially touches the boundary  $\partial \tilde{Z}_{\varepsilon,\delta,h}$  at the point  $q_i = (q_i', q_i'')$ . Let  $x_i = \bar{c}\text{-Exp}_{\bar{x}_{\varepsilon,\delta}}q_i$ . Since  $p_i = (0, p_i'')$  is orthogonal to  $\Pi_i$  and  $\tilde{Z}_{\varepsilon,\delta,h}$  is a sublevel set of the convex function  $\varphi$ , there exists a scalar multiple  $t_i \in \mathbb{R}_+$  such that  $t_i p_i \in \partial \varphi(q_i)$ . By Assumption 2.2 and Loeper's maximum principle (**DASM**) (Lemma 2.7), the point  $\bar{z}_i = \tilde{c}\text{-Exp}_{q_i}t_ip_i$  satisfies  $\bar{z}_i \in \partial^{\bar{c}}\varphi(q_i) = \partial^c\varphi(x_i)$ . Note that in fact,

$$\bar{z}_i = \tilde{c}\text{-}\mathrm{Exp}_{q_i} t_i p_i = c\text{-}\mathrm{Exp}_{x_i} \eta(t_i p_i)$$

where  $\eta$  is the affine map given by Lemma 3.4 (in whose statement we replace  $x_0$ ,  $q_0$  and  $\bar{y}_0$  with  $x_i$ ,  $q_i$  and  $\bar{x}_{\varepsilon,\delta}$ , respectively). Moreover, using the decomposition

$$p_i = (0, p_i'') \in T_{q_i'}^*(T_{\bar{x}_{\varepsilon,\delta}'}^* \bar{M}') \times T_{q_i''}^*(T_{\bar{x}_{\varepsilon,\delta}''}^* \bar{M}''),$$

we see that the  $\tilde{c}$ -segment (with respect to  $q_i$ )

$$[0,1] \ni t \mapsto \bar{z}_i(t) = \tilde{c}\text{-Exp}_{q_i}(1-t)t_ip_i = c\text{-Exp}_{x_i}((1-t)\eta(t_ip_i))$$

from  $\bar{z}_i(0) = \bar{z}_i$  to  $\bar{z}_i(1) = \bar{x}_{\varepsilon,\delta}$ , is of the form

$$\bar{z}_i(t) = (\bar{x}'_{\varepsilon,\delta}, \bar{z}''_i(t)) \in \bar{M}' \times \bar{M}''.$$

Observe that by Proposition 6.3 and Assumption 2.3, we have

$$\bar{z}_i''(t) \in \bar{M}''(x''), \quad \forall t \in [0, 1], \forall x \in Z_{\varepsilon, \delta, h}.$$
 (6.18)

We use these  $\tilde{c}$ -segments  $\bar{z}_i(t)$  to define the points  $\hat{p}_i$ ,  $i=1,\cdots,n''$ . Define the function

$$m_{\bar{z}_i(t)}(q) := -\tilde{c}(q, \bar{z}_i(t)) + \tilde{c}(q_i, \bar{z}_i(t)) + \varphi(q_i).$$

Clearly,  $m_{\bar{z}_i(0)} \leq \varphi$  and  $m_{\bar{z}_i(1)} \equiv \varphi(q_i) = h + \varphi(q_0)$ . By continuity there exists  $\tau_i \in [0,1)$  such that

$$m_{\bar{z}_i(\tau_i)}(q_0) = \varphi(q_0).$$

Also, Loeper's maximum principle (DASM) implies




Figure 4: The supporting function  $m_{\bar{z}_i(0)} = m_{\bar{z}_i}$  touches  $\varphi$  at  $q_i$  from below. By interpolating between  $m_{\bar{z}_i} = m_{\bar{z}_i(0)}$  and  $m_{\bar{x}_{\bar{\epsilon},\delta}} = m_{\bar{z}_i(1)}$  along the  $\tilde{c}$ -segment with respect to  $q_i$ , we can find  $\tau_i \in [0,1)$  such that  $m_{\bar{z}_i(\tau_i)}(q_0) = \varphi(q_0)$ . Then the covector  $\hat{p}_i$  used to construct  $\tilde{C}$  is defined as  $\hat{p}_i := (0, -D_{q''}\tilde{c}''(q''_0, \bar{z}''_i(\tau_i)) \in \partial m_{\bar{z}_i(\tau_i)}(q_0)$ .

$$m_{\bar{z}_i(\tau_i)} \leq \max[h + \varphi(q_0), \varphi],$$

so that in particular

$$m_{\bar{z}_i(\tau_i)} \leq \varphi \text{ on } \partial \tilde{Z}_{\varepsilon,\delta,h},$$

hence, by the definition of  $[\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0}$ ,

$$\bar{z}_i(\tau_i) \in [\partial^{\tilde{c}} \varphi(\tilde{Z}_{\varepsilon,\delta,h})]_{q_0} = [\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0} \quad \text{for every } i = 1, \dots, n''.$$
 (6.19)

For later use, consider the nonzero vectors

$$p_{i}(\tau_{i}) = (1 - \tau_{i})t_{i}p_{i}$$

$$= (0, (1 - \tau_{i})t_{i}p_{i}'')$$

$$= (0, -D_{q''}\tilde{c}''(q_{i}'', \bar{z}_{i}''(\tau_{i}))) \in T_{q_{i}'}^{*}(T_{\bar{x}_{c,\delta}'}^{*}\bar{M}') \times T_{q_{i}''}^{*}(T_{\bar{x}_{c,\delta}''}^{*}\bar{M}''), \qquad i = 1, \dots, n''.$$
(6.20)

Clearly these vectors are all mutually orthogonal. Moreover, because

$$p_i(\tau_i) \in \partial m_{\bar{z}_i(\tau_i)}(q_i), \qquad i = 1, \dots, n'',$$

we have by the convexity of  $m_{\bar{z}_i(\tau_i)}$ ,

$$|p_i(\tau_i)| \ge \frac{\varphi(q_i) - \varphi(q_0)}{\operatorname{dist}(q_0, \Pi_i)} = \frac{h}{\ell_i}.$$
(6.21)

To finish the construction of  $\tilde{C}$ , let

$$\hat{p}_{i} := (0, -D_{q''}\tilde{c}''(q_{0}'', \bar{z}_{i}''(\tau_{i}))$$

$$\in T_{q_{0}'}^{*}(T_{\bar{x}_{\varepsilon,\delta}'}^{*}\bar{M}') \times T_{q_{0}''}^{*}(T_{\bar{x}_{\varepsilon,\delta}''}^{*}\bar{M}''), \qquad i = 1, \dots, n''.$$

$$(6.22)$$

Notice that  $\bar{z}_i(\tau_i) = (x'_{\varepsilon,\delta}, \bar{z}_i(\tau_i)'') = \tilde{c}\text{-Exp}_{q_0}\hat{p}_i$ . Let  $\tilde{C} = \text{co}(\hat{p}_1, \dots, \hat{p}_{n''})$  be the convex hull of  $\hat{p}_1, \dots, \hat{p}_{n''}$ . In the following, we will see that  $\tilde{C}$  satisfies the desired properties (1), (2) and (3). First, (1) follows immediately from (6.22), while (2) is a direct consequence of (6.19) and Lemma 2.8.

Now, let us show (3). By (6.18) each  $\bar{z}_i(\tau_i)''$  stays uniformly away (for small  $\delta, h$ ) from the cut-locus of  $\pi''(Z_{\varepsilon,\delta,h})$ . Hence we can apply Lemma 3.5 to (6.20) and (6.22) to see that  $\hat{p}_i$  is close to  $p_i(\tau_i)$  when we use the canonical identification  $T_{q_i}^*(T_{x_{\varepsilon,\delta}}^*\bar{M}) \approx T_{q_0}^*(T_{x_{\varepsilon,\delta}}^*\bar{M})$ ; more precisely,

$$\left|\hat{p}_i - p_i(\tau_i)\right| \le o_h(1)|\hat{p}_i|,$$

where  $o_h(1)$  is a quantity which goes to 0 as  $h \to 0$ . Since the vectors  $\{p_i(\tau_i)\}_{i=1,\dots,n''}$  are all mutually orthogonal,  $\hat{p}_i$  are almost mutually orthogonal covectors, which by (6.21) satisfy

$$|\hat{p}_i| = |\hat{p}_i''| \gtrsim |p_i(\tau_i)| \ge \frac{h}{\ell_i}.$$

(Here, for sufficiently small  $\delta$  and  $\frac{h}{\delta}$ , the inequality  $\gtrsim$  and the almost orthogonality are independent of  $\delta$ , h and  $\varepsilon$ .) This gives

$$\mathscr{H}^{n''}(\tilde{C}) \gtrsim \prod_{i=1}^{n''} \frac{h}{\ell_i}.$$

This estimate combined with (6.17) shows (3). This completes the proof.

# 6.6 Proof of Theorem 6.4 (Alexandrov upper bound near cut-exposed point): final argument

In this section we finish the proof of Theorem 6.4. Let  $0 < \varepsilon < 1$ , and fix  $0 < \delta \le \delta_1(\varepsilon) := \min\{\delta_0(\varepsilon), \delta_2(\varepsilon)\}$  and  $0 < h \le h_1(\varepsilon, \delta) := \min\{\delta^2, h_2(\varepsilon, \delta)\}$ , with  $\delta_0(\varepsilon)$  and  $\delta_2(\varepsilon), h_2(\varepsilon, \delta)$  as in Proposition 6.3 and 6.7 respectively. The estimates  $\lesssim$ ,  $\gtrsim$ ,  $\approx$  in this section are all independent of  $\varepsilon$ ,  $\delta$  and  $\delta$ .

To make use of the results of previous sections, we need the following comparison result:

**Proposition 6.9.** The set  $\tilde{C}$  constructed in Proposition 6.8 satisfies

$$\mathscr{H}^{n''}(\tilde{C}) \lesssim |\partial^c \phi(Z_{\varepsilon,\delta,h})|.$$

Note that even with Proposition 6.8 (2), this estimate is not obvious because  $n'' < \dim M$ .

*Proof.* For each  $\varepsilon, \delta, h$  as in Proposition 6.8, we will find an auxiliary set  $\mathcal{A} = \mathcal{A}_{\varepsilon,\delta,h} \subset \mathcal{D}$  in a fixed (thus independent of  $\varepsilon, \delta, h$ ) compact set  $\mathcal{D} \subset M^*(x_0) \subset T^*_{x_0}M$  such that

$$c\text{-}\mathrm{Exp}_{x_0}(\mathcal{A}) \subset [\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0} \subset \partial^c \phi(Z_{\varepsilon,\delta,h}); \tag{6.23}$$

$$|\mathcal{A}| \gtrsim \mathcal{H}^{n''}(\tilde{C}). \tag{6.24}$$

Once such a set is constructed, the desired estimate follows from

$$|\partial^c \phi(Z_{\varepsilon,\delta,h})| \ge |c\text{-Exp}_{x_0}(\mathcal{A})| \gtrsim |\mathcal{A}|$$
 (since  $\mathcal{A} \subset \mathcal{D}$ ).

The construction of  $\mathcal{A}$  goes through several steps. First, apply to the set  $\tilde{C}$  the (extended) map  $p \in T_{q_0}^*(T_{\bar{x}_{\varepsilon,\delta}}^*\bar{M}) \mapsto \eta(p) \in T_{x_0}^*M$  as in Lemma 3.4 (with  $\bar{y}_0 = \bar{x}_{\varepsilon,\delta}$ ), and let  $\eta(\tilde{C}) \subset T_{x_0}^*M$  denote its image. Notice that by Proposition 6.8(2)

$$c\text{-}\mathrm{Exp}_{x_0}(\eta(\tilde{C})) = \tilde{c}\text{-}\mathrm{Exp}_{q_0}\tilde{C} \subset [\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0}.$$

Let us compare  $\mathcal{H}^{n''}(\eta(\tilde{C}))$  with  $\mathcal{H}^{n''}(\tilde{C})$ . For each  $p=(0,p'')\in \tilde{C}$ , Lemma 3.4 applies as

$$\eta(p) = \left(\eta'_{\varepsilon,\delta}, p''\left(-D_{x''}D_{\bar{x}''}c''(x''_0, \bar{x}''_{\varepsilon,\delta})\right) + \eta''_{\varepsilon,\delta}\right),\,$$

where  $\eta_{\varepsilon,\delta} = -D_x c(x_0, \bar{x}_{\varepsilon,\delta})$  (thus, c-Exp<sub>x0</sub> $(\eta_{\varepsilon,\delta}) = \bar{x}_{\varepsilon,\delta}$ ). Therefore

$$\eta(\tilde{C}) \subset \{\eta'_{\varepsilon,\delta}\} \times T^*_{x''_0}M$$

and

$$\mathscr{H}^{n''}(\eta(\tilde{C})) = |\det D_{x''} D_{\bar{x}''} c''(x_0'', \bar{x}_{\varepsilon,\delta}'')| \mathscr{H}^{n''}(\tilde{C}) \approx \mathscr{H}^{n''}(\tilde{C}).$$

Notice that  $\bar{x}''_{\varepsilon,\delta}$  is independent of  $\varepsilon$  (see (6.7)) and stays uniformly away from  $\operatorname{Cut}(x''_0)$ , so that the above estimate is independent of  $\varepsilon$ ,  $\delta$  and h.

We now use a convexity argument to construct  $\mathcal{A}$ . We will first construct some suitable sets  $C^1, \ldots, C^{b_0}$ , and  $\tilde{C}_0$ , inside a fixed compact set (independent of  $\varepsilon, \delta, h$ ) in  $M^*(x_0)$ , which satisfy the properties of the sets  $S_i$  in Lemma 3.3. These sets will also satisfy:

$$c\text{-}\mathrm{Exp}_{x_0}(C^1) \cup \ldots \cup c\text{-}\mathrm{Exp}_{x_0}(C^{b_0}) \cup c\text{-}\mathrm{Exp}_{x_0}(\tilde{C}_0) \subset [\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0};$$

$$\mathscr{H}^{n_i}(C^i) \gtrsim 1, \qquad i = 1, \ldots b_0;$$

$$\mathscr{H}^{n''}(\tilde{C}_0) \gtrsim \mathscr{H}^{n''}(\eta(\tilde{C})).$$

Then  $\mathcal{A}$  will be given as the convex hull of these sets, that is  $\mathcal{A} = \operatorname{co}(C^1, \dots, C^{b_0}, \tilde{C}_0)$ . By convexity of  $M^*(x_0)$ ,  $\mathcal{A}$  will be in a fixed compact set, say  $\mathcal{D}$ , independent of  $\varepsilon, \delta, h$ , and the c-convexity of  $[\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0}$  (see Lemma 2.8) will imply c-Exp $_{x_0}(\mathcal{A}) \subset [\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0}$ , showing (6.23). We will then apply Lemma 3.3 to get

$$|\mathcal{A}| \gtrsim \mathcal{H}^{n''}(\eta(\tilde{C})) \approx \mathcal{H}^{n''}(\tilde{C}),$$

which gives (6.24). Hence we are let to construct  $C^1, \ldots, C^{b_0}, \tilde{C}_0$ .

To construct  $C^1, \ldots, C^{b_0}$ , recall that  $M' = M^1 \times \ldots \times M^{b_0}$ , and for every  $i \in \{1, \ldots, b_0\}$  there exists  $\bar{y}_i \in \partial^c \phi(x_0)$  with  $\bar{y}_i^i = -x_0^i$ . Moreover  $M_{\bar{y}_i}^i \subset \partial^c \phi(x_0)$  by Lemma 6.6. We further observe

that the same inclusion holds for all the components  $y_i^l$  of  $y_i$  that satisfy  $y_i^l = -x_0^l$ . Hence, once  $\bar{y}_i$  has a cut-locus component with  $x_0$ , then one can change such component arbitrarily, and the resulting point still remains inside  $\partial^c \phi(x_0)$ . Combining this fact with Loeper's maximum principle (**DASM**) we can find a covector  $v_i$  and a set  $C^i \subset \partial \phi(x_0) \subset T_{x_0}^* M$ , with  $v_i \in C^i$  whose components are either  $v_i^l = 0$  or  $v_i^l \in M^{l*}(x_0^l)$ , and

$$C^i = \{ q \in T_{x_0}^* M \mid 2q^i \in M^{i*}(x_0^i), \text{ and } q^l = v_i^l \text{ for } l \neq i \}.$$

Clearly,  $C^i$  is compact and  $C^i \subset M^*(x_0)$ . Moreover  $c\text{-Exp}_{x_0}C^i \subset \partial^c\phi(x_0) \subset [\partial^c\phi(x_0)]_{x_0}$  and  $\mathscr{H}^{n_i}(C^i) \gtrsim 1$ . Also, observe that the construction of  $C^1, \ldots, C^{b_0}$  is independent of  $\varepsilon, \delta, h$ .

Let us now construct the set  $\tilde{C}_0$ . From Propositions 6.2 and 6.3 we see that for  $\delta$  and  $\frac{h}{\delta}$  sufficiently small there exists a compact set  $C'' \subset \bar{M}''(x_0'')$  (independent of  $\varepsilon, \delta, h$ ) with  $\pi''(\partial^c \phi(Z_{\varepsilon,\delta,h})) \subset C''$ . Recall the definition of  $a_0, b_0, \bar{x}_{\varepsilon,\delta} = (\bar{x}_{\varepsilon}, \bar{x}_{\delta})$ , and that  $\bar{x}_{\delta} \in \bar{M}''(x_0'')$ . Then we write  $\eta_{\varepsilon,\delta} = (\eta_{\varepsilon}, \eta_{\delta}) \in T_{x_0}^* M \times T_{x_0}^* M''$  and we observe that  $\eta_{\delta}$  is uniformly away from the boundary of  $M'''(x_0'')$ . These facts imply that there exists a compact set  $C_2 \subset M''''(x_0'')$  (independent of  $\varepsilon, \delta, h$ ) such that

$$\eta(\tilde{C}) \subset \{\eta_{\varepsilon}^{\cdot}\} \times C_2^{\cdot\cdot}.$$

However,  $\eta_{\varepsilon}^{\cdot} \to \partial M^{\cdot *}(x_{0}^{\cdot})$  as  $\varepsilon \to 0$ , thus  $\eta(\tilde{C})$  is not kept in a fixed compact set in  $M^{*}(x_{0})$ . In particular, we cannot take  $\eta(\tilde{C})$  for  $\tilde{C}_{0}$ , and this motivates the following: Since  $\bar{x}_{\varepsilon}^{\cdot} = -x_{0}^{\cdot}$  and  $\bar{x}_{\varepsilon,\delta} \in [\partial^{c}\phi(Z_{\varepsilon,\delta,h})]_{x_{0}}$ , applying Lemma 6.6 as in the previous paragraph we see that the set  $M^{\cdot} \times \{\bar{x}_{\delta}^{\cdot}\}$ , in particular,  $(x_{0}^{\cdot}, \bar{x}_{\delta}^{\cdot})$  belongs to  $[\partial^{c}\phi(Z_{\varepsilon,\delta,h})]_{x_{0}}$ . This point  $(x_{0}^{\cdot}, \bar{x}_{\delta}^{\cdot})$  corresponds to the covector  $(0, \eta_{\delta}^{\cdot})$ . Consider the cone co  $((0, \eta_{\delta}^{\cdot}), \eta(\tilde{C}))$ , and define  $\tilde{C}_{0}$  as

$$\tilde{C}_0 := \operatorname{co}\left(\left(0, \eta_{\delta}^{\cdot\cdot}\right), \, \eta(\tilde{C})\right) \cap \left\{ \left(\frac{\eta_{\varepsilon}^{\cdot}}{2}, q^{\cdot\cdot}\right) \in T_{x_0}^*M \mid q^{\cdot\cdot} \in T_{x_0^{\cdot\cdot}}^*M^{\cdot\cdot} \right\}.$$

By a simple geometric argument

$$\mathscr{H}^{n''}(\tilde{C}_0) \gtrsim \mathscr{H}^{n''}(\eta(\tilde{C})),$$

and moreover, since  $\frac{\eta_{\varepsilon}}{2} \in \frac{1}{2}M^{**}(x_{0})$ , the set  $\tilde{C}_{0}$  is contained in a fixed compact set in  $M^{*}(x_{0})$  independently of  $\varepsilon, \delta, h$ . By c-convexity of  $[\partial^{c}\phi(Z_{\varepsilon,\delta,h})]_{x_{0}}$ ,

$$c\text{-Exp}_{x_0}(\tilde{C}_0) \subset [\partial^c \phi(Z_{\varepsilon,\delta,h})]_{x_0}.$$

Note that by construction this set  $\tilde{C}_0$ , together with  $C^1, \ldots, C^{b_0}$ , satisfy the property of the sets  $S_i$  in Lemma 3.3. Furthermore they are in a fixed compact set in  $M^*(x_0)$  independent of  $\varepsilon, \delta, h$ . This completes the proof.

Combining Propositions 6.9 and 6.8(3) we obtain

$$h^{n''} \lesssim \mathcal{H}^{n''}(\pi''(\tilde{Z}_{\varepsilon,\delta,h}))|\partial^c \phi(Z_{\varepsilon,\delta,h})|. \tag{6.25}$$

We will finish the proof by applying Proposition 6.7. First, we need some preliminary steps. Use the notation given in Section 6.5. Let  $Z'_{\varepsilon,\delta,h}$  be the slice of  $Z_{\varepsilon,\delta,h}$  in  $M' \times \{x''_0\}$ , that is

$$Z'_{\varepsilon,\delta,h} := \{ x' \in M' \mid (x', x''_0) \in Z_{\varepsilon,\delta,h} \}.$$

Then  $Z'_{\varepsilon,\delta,h}$  is embedded via  $x' \mapsto -D_{\bar{x}'}c'(x',\bar{x}'_{\varepsilon,\delta})$  into  $\tilde{Z}'_{\varepsilon,\delta,h} \subset \bar{M}'^*(\bar{x}'_{\varepsilon,\delta})$ , where

$$\tilde{Z}'_{\varepsilon,\delta,h} := \{q' \in \bar{M}'^*(\bar{x}'_{\varepsilon,\delta}) \mid (q',q''_0) \in \tilde{Z}_{\varepsilon,\delta,h}\}.$$

Embed in the same way each  $Z^i_{\varepsilon,\delta,h}$  (see (6.13)),  $i=1,\ldots b_0$ , into  $\tilde{Z}^i_{\varepsilon,\delta,h}\subset \bar{M}^{i*}(\bar{x}^i_{\varepsilon,\delta})$ .

**Proposition 6.10.** Assume that  $0 < \delta \le \delta_0$  and  $0 < h \le \delta^2$ , with  $\delta_0$  as in Proposition 6.3. Then the following inequalities hold:

$$\Big(\min_{x'\in Z'_{\varepsilon,\delta,h}}|\det(D_{x'}D_{\bar{x}'}c'(x',\bar{x}'_{\varepsilon,\delta}))|\Big)|Z'_{\varepsilon,\delta,h}|\leq |\tilde{Z}'_{\varepsilon,\delta,h}|\leq \Big(\max_{x'\in Z'_{\varepsilon,\delta,h}}|\det(D_{x'}D_{\bar{x}'}c'(x',\bar{x}'_{\varepsilon,\delta}))|\Big)|Z'_{\varepsilon,\delta,h}|,$$

$$\Big(\min_{x^i \in Z^i_{\varepsilon,\delta,h}} |\det(D_{x^i}D_{\bar{x}^i}c^i(x^i,\bar{x}^i_{\varepsilon,\delta}))|\Big) |Z^i_{\varepsilon,\delta,h}| \leq |\tilde{Z}^i_{\varepsilon,\delta,h}| \leq \Big(\max_{x^i \in Z^i_{\varepsilon,\delta,h}} |\det(D_{x^i}D_{\bar{x}^i}c^i(x^i,\bar{x}^i_{\varepsilon,\delta}))|\Big) |Z^i_{\varepsilon,\delta,h}|,$$

where  $|\cdot|$  denotes the Riemannian volume (in the appropriate submanifold).

Proof. From (6.14)

$$D_{x'}q' = -D_{x'}D_{\bar{x}'}c'(x'(q'), \bar{x}'_{\epsilon,\delta}),$$

and so the first inequality follows from

$$|\tilde{Z}'_{arepsilon,\delta,h}| = \int_{Z'_{arepsilon,\delta,h}} |\det D_{x'}q'| \, dx'.$$

The proof of the second inequality is analogous.

By convexity and Lemma 3.3 one has

$$\mathscr{H}^{n'}(\tilde{Z}'_{\varepsilon,\delta,h})\gtrsim \prod_{i=1}^{b_0}\mathscr{H}^{n_i}(\tilde{Z}^i_{\varepsilon,\delta,h}),$$

while Propositions 6.10 and 6.7 imply

Combining these estimates with (6.25) we get

$$h^{n'+n''} \lesssim \varepsilon^{a_0} \left[ \prod_{i=1}^{b_0} \left( \min_{x^i \in Z^i_{\varepsilon,\delta,h}} |\det(D_{x^i} D_{\bar{x}^i} c^i(x^i, \bar{x}^i_{\varepsilon,\delta}))| \right) \right]^{-1} \mathcal{H}^{n'}(\tilde{Z}'_{\varepsilon,\delta,h}) \mathcal{H}^{n''}(\pi''(\tilde{Z}_{\varepsilon,\delta,h})) |\partial^c \phi(Z_{\varepsilon,\delta,h})|$$

$$\lesssim \varepsilon^{a_0} \left[ \prod_{i=1}^{b_0} \left( \min_{x^i \in Z^i_{\varepsilon,\delta,h}} |\det(D_{x^i} D_{\bar{x}^i} c^i(x^i, \bar{x}^i_{\varepsilon,\delta}))| \right) \right]^{-1} |\tilde{Z}_{\varepsilon,\delta,h}| |\partial^c \phi(Z_{\varepsilon,\delta,h})| \qquad \text{(by Lemma 3.2)}$$

$$\lesssim \varepsilon^{a_0} |Z_{\varepsilon,\delta,h}| |\partial^c \phi(Z_{\varepsilon,\delta,h})|,$$

where the last inequality follows from

$$|\tilde{Z}_{\varepsilon,\delta,h}| \lesssim \Big(\max_{x \in Z_{\varepsilon,\delta,h}} \det(D_x D_{\bar{x}} c(x, \bar{x}_{\varepsilon,\delta}))\Big) |Z_{\varepsilon,\delta,h}|$$

(see Proposition 6.10) and

$$\frac{\max_{x' \in Z'_{\varepsilon,\delta,h}} \det(D_{x'} D_{\bar{x}'} c'(x', \bar{x}'_{\varepsilon,\delta}))}{\left[ \prod_{i=1}^{b_0} \left( \min_{x^i \in Z^i_{\varepsilon,\delta,h}} | \det(D_{x^i} D_{\bar{x}^i} c^i(x^i, \bar{x}^i_{\varepsilon,\delta})| \right) \right]} \lesssim 1 \quad \text{as } \delta, \frac{h}{\delta} \to 0$$

(see Propositions 6.2 and 6.3). This concludes the proof of Theorem 6.4, and Theorem 5.1 is proved.
