## ANNEX

Art. 4 - (Incompatibility, expectations, prohibitions combined) of the Regulations for the provision of grants for collaborative research activities.

1. This position is not open to employees (both with a fixed -term and an open-ended/permanent contract) of Universities, of Public research Institutions, of the National Agency for New Technologies, Energy and Sustainable Economic Development (ENEA) and of the Italian Space Agency (ASI) as well as of institutions issuing a degree of scientific specialization recognized as equivalent to the title of Doctor of Philosophy (in accordance with Article 74, paragraph 4 of Presidential Decree of 11 July 1980 No. 382).
2. Employees of other Public Administrations than those referred to in the previous paragraph, as well as of institutions / private entities, may hold the research grant provided only if placed on unpaid leave for the corresponding period.
3. In accordance with Article 18, paragraph 1 of Law No. 240/2010, this position is not open to who have a degree of consanguinity or affinity up to the fourth degree included, with:
  - the person that decided on the position opening;
  - components of the body that decides on the resources financing the position;
  - the Administrative Director;
  - a member of the Board of Directors of the School.
4. The ownership of the grant is also incompatible:
  - with participation in the undergraduate or master degree, PhD (with scholarship) or medical specialty courses, in Italy or abroad; *and with the ordinary course participation and completion of the school and the corresponding courses, with scholarship, other than colleges special ordinance*
  - with the ownership of other research grants;
  - with the exercise of free and professional activities and / or management;
  - with other contracts concluded with the School;
5. The Research Grant can not be combined with scholarships awarded for any purpose, except those awarded by national or foreign institutions to integrate with trips abroad, the research activities.
6. The absence of the situations of incompatibility expressed in the previous paragraphs, except paragraph 3, must exist at the beginning of the contract and for its whole duration. To this end, the winner makes a special declaration and commits himself to communicate promptly to the Administration any variation from what stated.
7. The grant holder can engage in external activities (other than those mentioned in paragraph 4), after a written notification and authorization of the Head of the research program, provided that they:
  - do not affect the full accomplishment of the research;
  - do not involve conflict of interest with the research carried out;
  - in relation to activities, do not harm, in any way, to the School.
8. The Grant Holder can always engage in the external activities such as speaking at seminars, conventions and conferences, provided they are not official teaching activities.
